PUBLIC UTILITIES REGULATORY COMMISSION (PURC) PUBLICATION OF ELECTRICITY TARIFFS

- In accordance with the statutory duty to publish rates approved by the Public Utilities Regulatory Commission under Section 19 of the Public Utilities Regulatory Commission Act 1997 (Act 538) ("the Act"), this publication is made this 31st day of March 2014.
- 2. The Volta River Authority (VRA) shall charge the rates provided in the First Schedule hereto referred to as "BGC VRA" as the Bulk Generation Charge to take effect as per Paragraph 7 below.
- 3. The Ghana Grid Company Limited (GRIDCo) shall charge the rates provided in the Second Schedule hereto referred to as the Transmission Service Charge to take effect as per Paragraph 7 below.
- 4. The Electricity Company of Ghana Limited (ECG) and Northern Electricity Distribution Company Limited (NEDCo) shall charge the rates provided in the Third and Fourth Schedules hereto referred to as the Distribution Service Charge and End-User Tariffs to take effect as per Paragraph 7 below.
- 5. The rates are denominated in Ghana Pesewas.
- 6. Until the next major tariff review, electricity tariffs shall be adjusted as per the Automatic Adjustment Formula (AAF) published in Gazette No. 15 of 25th February 2011.
- 7. Due to current instability in electricity supply, the appropriate date for implementation of the electricity tariffs contained in First, Second, Third and Fourth Schedules below using the Automatic Adjustment Formula (AAF) would be determined by the Commission at a later date.
- 8. The rates approved by the Public Utilities Regulatory Commission which took effect from 1st January 2014 as published in Gazette No 14 of Wednesday 12th February 2014 shall remain in force until revoked by the Commission in accordance with Paragraph 7 above.


