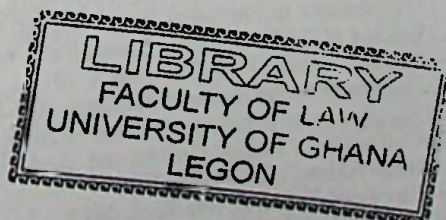

### **INFORMATION CIRCULAR (AIR NAVIGATION SERVICES)**

#### **SUBJECT: PROFICIENCY IN APPROVED RADIOTELEPHONY PROCEDURES FOR OPERATORS OF COMPANY RADIO FREQUENCIES**

Operators of company radio frequencies shall not operate such radios to aircraft operating in Ghana unless such Radio Operators demonstrate to the Authority, proficiency in approved radiotelephony procedures.

A Certificate of Competence shall be issued by the Authority following successful completion of an approved radiotelephony course provided at an Approved Training Organisation (ATO).

The Radiotelephony Certificate of Competence shall be renewed annually by the Authority following an approved recurrent training at an Approved Training Organisation (ATO).

Holders of Certificates of Competence before the effective date of this circular shall demonstrate such proficiency in approved radiotelephony procedures before the next renewal of their certificates.

Licensed pilots, licensed Air Traffic Controllers, licensed Air Navigators and licensed Radio Station Operators are exempted from this requirement.

**GHANA CIVIL AVIATION AUTHORITY****INFORMATION CIRCULAR (AIR NAVIGATION SERVICES)****SUBJECT: NOTICE TO PROVIDERS OF AIRPORT VEHICLE/EQUIPMENT OPERATIONS TRAINING COURSE**

Airport vehicle/equipment operations training courses leading to the issuance of Airside Drivers Permits in all civil airports in Ghana shall be subjected to approval by the Authority.

Such approved courses shall be conducted at Training Institutions approved by the Authority.

Instructors involved in airport vehicle/equipment operations training shall provide evidence of appropriate instructor training before authorisation by the Authority to conduct such training.

Holders of Airside Drivers Permits before the effective date of this circular shall undergo such approved training before the next renewal of their permits preceding the effective date of this circular.

Holders of Airside Drivers Permits shall not operate any vehicle or equipment on the Manoeuvring and Movement Areas of all civil airports in Ghana unless such drivers demonstrate to the Authority, proficiency in approved radiotelephony procedures.

A Certificate of Competence shall be issued by the Authority following successful completion of an approved radiotelephony course provided at an Approved Training Organization (ATO).

The Radiotelephony Certificate of Competence shall be renewed annually by the Authority following an approved recurrent training at an Approved Training Organization (ATO).

Current holders of Airside Drivers Permits shall demonstrate such proficiency in approved radiotelephony procedures before the next renewal preceding the effective date of this circular.

Licensed pilots, licensed Air Traffic Controllers, licensed air navigators and licensed radio station operators are exempted from this requirement.
