We refer to the facility agreement dated 29 September 2014 made between Surfline Communications Limited (the "Borrower"), John Taylor (the "Guarantor") and Vantage Mezzanine Fund II Partnership acting through Vantage Mezzanine Fund II (Pty) Limited (the "Lender") as amended and restated by an amendment and restatement loan agreement dated 2 April 2015 made between the Borrower, the Guarantor, the Lender and DEG-Deutsche Investititions-Und Entwicklungsgesellschaft MBH (the "Facility Agreement").

     the Company did not achieve revenue for the year ended 31 December 2016 of \$50
    million as required by the financial covenant.
- 4. Due to the occurrence of these events, you are in breach of clauses 17.1, 17.6 and 17.13 of the Facility Agreement. Pursuant to clause 17 of the Facility Agreement, these breaches constitute Events of Default and these Events of Default are continuing.
- 5. As these Events of Default are continuing, we are entitled (in addition to any other right or remedy we may have against you) to take action in accordance with the provisions of clause 17.15 (Acceleration) of the Facility Agreement.
- 6. By this letter, we give you notice in accordance with the Borrowers and Lenders Act, 2008 (Act 773) and request that you remedy the Event of Default mentioned in paragraph 5 of this letter within 30 days of this letter.
- 7. Pursuant to clause 17.15 (Acceleration) of the Facility Agreement, we hereby give you notice that all the outstanding Loan, accrued interest, the Special Dividend Floor Value as defined in the Preference Share Subscription Agreement and all other amounts accrued or outstanding under the Finance Documents will become immediately due and payable within 31 days of this

letter, unless you remedy the Events of Default pursuant to paragraph 8 of this letter.

- 8. Further, we understand that an unsecured creditor of the Borrower (Tech Mahindra) has instituted court proceedings against the company and obtained a court order in the High Court of Ghana which may be enforceable against the assets of the Borrower. In terms of clause 9 of the Security Agreement, we give you notice that our floating charge has automatically converted to a fixed charge from the time Tech Mahindra instituted court proceedings against the Borrower.
