MARITIME CIRCULAR

SHIPPING NOTICE NO.011

ISSUANCE OF CERTIFICATE OF ENDORSEMENT (COE) TO HOLDERS OF FOREIGN CERTIFICATE OF COMPETENCY

The Ghana Maritime Authority (GMA) wishes to inform ship owners and ship managers that they are to arrange for all their deck officers, marine engineer officers, and radio officers/operators holding foreign certificate of competency to apply for Certificate of Endorsement (COE) from the Authority before signing on a Ghana registered vessel or any vessel operating in Ghana's waters.

The ship owners and ship managers may apply for the Certificate of Endorsement on behalf of those officers by completing a prescribed form and payment of a prescribed fee.

The ship owners and ship managers are required to comply with this directive effective from **1st April, 2019.**

This circular is in accordance with section 479A of the Ghana Shipping (Amendment) Act, 2011(Act 826), which mandates the Authority to issue maritime circulars for the purpose of disseminating relevant information on maritime issues.

The details of this circular are as follows;

INTRODUCTION

1. Under Regulation I/10 of the International Convention on Standards of Training, Certification and Watch keeping for Seafarers (STCW), 1978, as amended, GMA is obliged to confirm, through all necessary measures, that the provisions of this regulation are complied with, in order to recognise a certificate issued by a foreign maritime administration to a deck officer (including master), marine engineer officer or radio officer/operator.
2. These measures include the need for the issuing authority to comply with the requirements of Regulation I/7 of the STCW and Section A-I/7 of the STCW Code. In addition, an Undertaking must be agreed between the foreign maritime administration and GMA, in compliance with STCW before a Certificate of Endorsement (COE) could be issued.

APPLICATION

3. Ship owners and ship managers must arrange for all their deck and marine engineer officers, radio officers/operators holding foreign certificate of competency to apply for a COE before signing on a Ghana registered vessel or any vessel operating in Ghana's waters. They may apply for the COE on behalf of their officers by completing the prescribed form and paying the prescribed fee.
4. A COE will be granted to a person provided he possesses the following:
 - a. a valid certificate of competency issued or revalidated under STCW;
 - b. a document issued by an appropriate Authority, directly to GMA, attesting to the authenticity of the certificate of competency;
 - c. the issuing Authority is listed as being recognised by GMA; and
 - d. a valid medical fitness certificate issued not more than 6 months before the date of application.
5. In addition, officers seeking employment or employed on board Ghana registered vessels as masters, chief mates, chief engineer officers or second engineer officers (management-level) must have an appropriate knowledge of Ghana maritime legislation relevant to the functions they are permitted to perform on board.
6. The COE will specify the capacity in which the holder is authorised to serve and will be valid for a period not exceeding five years from the date of issue or the expiry date of the applicant's certificate of competency, whichever is earlier. A fresh application should be made to revalidate a COE.

VALID CERTIFICATE OF COMPETENCY AND MEDICAL FITNESS

7. If the holder of a COE ceases for any reason(s), to have a valid certificate of competency or a valid certificate of medical fitness, that COE is deemed to be invalid until a valid certificate of competency or a valid certificate of medical fitness is obtained.
8. Ship owners and ship managers are advised to ensure that their officers hold valid certificates of competency and medical fitness certificates when serving on board Ghana ships or vessels operating within Ghana's maritime jurisdiction.
