**WHEREAS** under subregulation (1) of regulation 14 of the Ghana International Trade Commission (Anti-Dumping) Regulations, 2019 (L.I. 2380), the Ghana International Trade Commission is required to issue a public notice of the decision to initiate an investigation to determine the existence, degree and effect of any alleged dumping of an imported product;

**WHEREAS** under subregulation (5) of regulation 14 of the Ghana International Trade Commission (Anti-Dumping) Regulations, 2019 (L.I. 2380), the Commission may give notice of an anti-dumping investigation to the exporter, foreign producer, importer, domestic producer and any other interested party of the product alleged to have been dumped and request for information relevant to the investigation;

**NOW THEREFORE, I, MR. FRANK AGYEKUM**, Executive Secretary to the Commission, do give notice of the initiation of an anti-dumping investigation requested in a complaint filed by Aluworks Limited and request for information relevant to the investigation indicated:

Agency : Ghana International Trade Commission (GITC)

Action : Initiation and scheduling of Anti-Dumping Investigation No. ADR-GITC/001/2019.

Summary : The Commission hereby gives notice of the initiation and scheduling of Anti-Dumping (Investigation) No. ADR-GITC/001/2019 to determine whether there should be anti-dumping duties imposed on imports of aluminium coils and circles from China.

Date of commencement : 13<sup>th</sup> December, 2019.

The investigation is being conducted based on the allegation by Aluworks Limited that aluminium coils and circles

(a) imported into Ghana benefit from impermissible export substitute; and

### SUPPLEMENTARY INFORMATION

**Background :** This Anti-Dumping investigation was requested in a complaint properly filed on 8<sup>th</sup> May, 2019 by Aluworks Limited, Plot #63/1, Heavy Industrial Area, Tema, P.O. Box C/O 914, Tema.

The Complainant requested for this investigation to remedy

- (a) the importation into Ghana of subsidised aluminium coils and circles; and
- (b) the sale in Ghana of aluminium coils and circles at prices that are lower than the prices at which the goods are sold in China and third countries.

The Complainant claims that the result of these practices has led to

- (a) the significant lowering of market share of the Complainant in the aluminium trade;
- (b) unutilised capacity;
- (c) inability to expand production; and
- (d) laying off workers.

**Participation in the Anti-Dumping investigation:** Persons wishing to participate in the hearing as parties must file an entry of appearance with the Commission not later than 6<sup>th</sup> December, 2019. The request to appear must include a statement of the reasons for the request and the data requested in the questionnaire available at the Secretariat of the Commission.

**NB:** The information requested in the questionnaire is in relation to an Anti-Dumping investigation concerning an imported product under the authority of the Ghana International


*Trade Commission Act, 2016 (Act 926). This order is mandatory and failure to provide the information as directed can attract sanctions under section 51 of Act 926.*

**Hearing** : The Commission will hold a hearing in connection with this Anti-Dumping investigation beginning at 10:00am on 13<sup>th</sup> December, 2019 at the Commission's Offices on the Second Floor of the Ghana Free Zones Authority Building, GPS: GL - 040 - 2630, Cantonments. A request to appear at the hearing and make an oral presentation should be filed in writing with the Commission on or before 6<sup>th</sup> December, 2019. A person who is not a party to the investigation but has evidence that may aid the deliberations of the Commission shall request permission in writing to present a short statement at the hearing.

**Written submissions:** Parties to this investigation shall file any written submissions with their entry of appearance.

Parties may also file written evidence in connection with their presentations at the hearing.
