Rules.

Issued by the Acting Commissioner for the East Africa Protectorate under the provisions of the East Africa Outlying Districts Ordinance 1902.

- 1. The rules issued under the Outlying Districts Ordinance 1902 and dated the 30th day of May 1906 shall apply to every closed district or part of a closed district within the meaning of the said Ordinance other than the area defined in the Schedule hereto.
- 2. Rule 2 of the Rules issued under the said Ordinance and dated the 26th day of October 1905 is hereby cancelled.

Schedule.

All the territory to the North of a line drawn from the South-east corner of Lake Rudolf to the Western flanks of Mount Nyiro Southwards along the edge of the Laikipia Escarpment to the caravan track from Mugutan Station to Rumuruti thence along this track to Rumuruti Station thence along the Guaso Narok and Nyiro Rivers to the Lorian Swamp and from the Lorian Swamp in a direct line North-east to Bardera.

Proclamation.

Under the East Africa Mining Regulations 1902.

In pursuance of the powers conferred upon me by the East Africa Mining Regulations 1902 I hereby declare that the land within the area of every Township proclaimed under the East Africa Townships Ordinance 1903 is exempt from the operation of the said Regulations.

Order conferring on certain Sub-Commissioners the power to hold inquests.

In exercise of the powers conferred upon me by the Indian Act V of 1898 (Code of Criminal Procedure) I hereby confer upon all Sub-Commissioners of the Protectorate who have been appointed Magistrates of the First Class under the Code the additional power with which a Magistrate of the First Class may be invested by the Local Government under Schedule IV No. 6 of the said Code, namely power to hold inquests; Section 174.

In exercise of the powers conferred upon me by the East Africa Order-in-Council 1902 I hereby appoint Hugh Owen Dolbey, to be a Magistrate of the first class as defined in the Code of Criminal Procedure 1898 (Act No. V of 1898) and confer upon him all the additional powers with which a Magistrate of the first class may be invested by the Local Government under schedule IV of the aforesaid Act with the exception of No. 12 thereof. And I also appoint the said Hugh Owen Dolbey to be an assistant judge under the Bombay Civil Courts Act 1869 (Act No. IV of 1869). And I also confer upon the said Hugh Owen Dolbey the powers of a District Court over insolvent judgment-debtors under Chapter XX of the Code of Civil procedure (Act No. XIV of 1882). And I also appoint the said Hugh Owen Dolbey to be an Assistant Collector and hereby direct him to hold and preside over additional Special Courts in all districts within the Province of Kisumu.

Judicial powers shall be the Province of Kisumu.

Enacted by His Majesty's Commissioner for the Uganda Protectorate.

Entebbe, 24th January 1907. H. HESKETH BELL His Majesty's Commissioner.

### No. 1 of 1907.

### Civil procedure: Recognised Agents.

IT is hereby enacted as follows:—

1. This Ordinance may be cited as "The Civil Procedure (Recognised Agents) Ordinance, 1907".

2. In addition to the persons declared by the Code of Civil Procedure to be the recognised agents of parties, by whom any appearance, application or act in or to any Court, required or authorized by law to be made or done by a party to a suit or appeal in such Court, may be made or done, the following persons shall be recognised agents for the purposes aforesaid, namely:—

A permanent servant, partner, relation or friend, whom the Court may admit as a fit person to represent a party, and especially persons holding powers-of-attorney from absent parties, parties carrying on business on behalf of bankers and traders, managing agents of landlords, nearest male relations of women, and persons ex-officio authorized to act for the Commissioner or for any Chief.
