A Bill

Intituled

An Ordinance to Amend the Game Ordinance, 1909

1 This Ordinance may be cited as "The Game Amendment Ordinance, Short title 1913," and shall be read as one with the Game Ordinance, 1909, hereinafter referred to as the Principal Ordinance

2 In this Ordinance the term "lion" shall mean a male or female lion Interpretation and shall include the young of lion

3 The Third Schedule to the Principal Ordinance shall be and is hereby Amendment of amended by the addition thereto of the words and figures following — Schedule 3

<i>Kind</i>	<i>Number allowed</i>	No poison trap or set gun to be used for the killing or capturing of lion or cheetah
49 Lion	4	
50 Cheetah ..	2	

4 Save as hereinafter provided, no person shall use any poison, trap or No poison trap set gun for the purpose of killing or capturing lion or cheetah,

5 Nothing in this Ordinance or in the Principal Ordinance contained Saving as to shall be deemed to prohibit the hunting, killing or capturing by any means the killing of whatsoever and without a licence under the Principal Ordinance of lion or lion on private cheetah land

- (a) on private land
- (b) on land, not being land within a Game Reserve, within 20 miles of any private land (other than private land situate within a Native Reserve)
- (c) on land, not being land within a Game Reserve, within 5 miles of any private land situate within a Native Reserve, or within 5 miles of any Railway
