AT THE COURT AT BUCKINGHAM PALACE,

THE 5TH DAY OF NOVEMBER, 1914.

PRESENT,

THE KING'S MOST EXCELLENT MAJESTY IN COUNCIL.

WHEREAS, by virtue of the Convention of Defensive Alliance between Her Majesty Queen Victoria and His Imperial Majesty the Sultan signed on June the 4th, 1878, the Annex to the said Convention signed on July the 1st, 1878, and the Agreement signed on behalf of Her Majesty and His Imperial Majesty the Sultan on August the 14th, 1878, His Imperial Majesty the Sultan assigned the Island of Cyprus to be occupied and administered by England upon the terms and conditions specified in the said Convention, Annex, and

And whereas by reason of the outbreak of war between His Majesty and His Imperial Majesty the Sultan the said Convention, Annex, and Agreement have become annulled and

are no longer of any force or effect:

And whereas it has, for the reasons hereinbefore appearing, seemed expedient to His Majesty that the said Island should be annexed to and should form part of His Majesty's Dominions, in order that proper provision may be made for the Government and protection of the said Island:

NOW, THEREFORE, His Majesty is pleased, by and with the advice of His Privy

Council, to order, and it is hereby ordered, as follows:-

1. From and after the date hereof the said Island shall be annexed to and form part of His Majesty's Dominions and the said Island is annexed accordingly.

2. Nothing in this Order shall affect the validity of any Instructions issued by His Majesty under the Royal Sign Manual and Signet to the High Commissioner and Commander-in-Chief of Cyprus, or of any Order-in-Council affecting Cyprus, or of any Law or Proclamation passed or issued under any such Instructions or Order, or of any act or thing done under any such Instructions, Order, Law or Proclamation, save in so far as any provision of any such Order-in-Council, Law or Proclamation may be repugnant to the provisions of any Act of Parliament which may, by reason of the annexation hereby declared, become extended to Cyprus, or to any Order or Regulation made under the authority of any such Act or having in Cyprus the force and effect of any such Act.

3. His Majesty may from time to time revoke, alter, add to or amend this Order. This Order may be cited as the Cyprus (Annexation) Order-in-Council, 1914.

And the Right Honourable Lewis Harcourt, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

The East Africa Townships Ordinance, 1903.

RULES issued by His Excellency the Governor under the East Africa Townships Ordinance, 1903.

Nairobi,

- 1. These Rules may be cited as "The Nairobi Municipal Committee Rules, 1914."
- 2. The Chief Secretary shall in the month of January in each year nominate a Committee consisting of :-
 - (a) Seven Government servants, of whom one shall be the Assistant to the Provincial Commissioner of the Ukamba Province or the District Commissioner of Nairobi.
 - (b) Four Europeans, not being in the permanent service of the Government, residing or carrying on business within the Township of Nairobi, and
 - (c) Two Non-Europeans, not being in the service of the Government, residing or carrying on business in the Township of Nairobi.

3. The Assistant to the Provincial Commissioner of the Ukamba Province or the District Commissioner of Nairobi, as the case may be, shall be Chairman of the Committee, and seven members of such Committee shall form a quorum.

4. The Chief Secretary may, with the approval of the Governor, at any time remove any member of the Committee, and may at any time nominate a new member in the place of any member who shall have been removed or who shall have resigned or who shall have otherwise vacated his membership of the Committee.

5. (a) The Chairman of the Committee shall in the month of March in each year prepare Estimates of revenue and expenditure for the ensuing financial year commencing on April 1st. Such Estimates shall be submitted to the Governor through the Chief Secretaary.

(b) The Township Estimates when approved by the Governor shall be published in

the Gazette.

6. The Committee shall, from time to time, frame and submit to the Governor, through the Attorney General and Chief Secretary, Rules for the health, order and good government of the Township.

7. The Rules dated the 14th day of January, 1913, and published as Government Notice No. 10 in the Gazette of the 15th January, 1913, are hereby revoked, provided that nothing herein shall be deemed to revive the Rules cancelled by Rule 5 of the aforesaid Rules dated the 14th day of January, 1913, and provided that all powers and duties vested in or imposed upon the Committee nominated under the Rules revoked by these Rules shall be vested in or imposed upon the Committee nominated under these Rules.

8. These Rules shall apply to the Township of Nairobi.

RULES.

The Indian Telegraph Act, 1885.

Rules issued by His Excellency the Governor under Section VII. of the Indian Telegraph Act, 1885, as applied to the East Africa Protectorate.

WHEREAS it is laid down in Rule 2 of the Rules made under Section VII. of the Indian Telegraph Act, 1885, dated the 20th day of June, 1914, that the charges for the transmission of inland telegrams must be prepaid, unless otherwise provided by Rule, and whereas it has become desirable to make provision for the acceptance of certain classes of telegrams without prepayment, Now Therefore the following additional Rules are promulgated:

I. The Postmaster General may arrange, in conjunction with the Military Authorities, for the acceptance, transmission and delivery of inland telegrams for the East Africa Protectorate handed in at Military Telegraph Offices without prepayment, provided that the charges for transmission of such messages, at the rates laid down by Rule, shall be paid by the addressees on delivery.

II. In the event of any abuse arising or difficulty being experienced in collecting charges on delivery the Postmaster-General is empowered to suspend the acceptance and transmission of telegrams without prepayment in connection with any particular Military Telegraph Line, or any particular Military Telegraph Office, or in the case of telegrams addressed to any particular person or persons.

EUROPEAN WAR.

The following telegrams have been received from the Secretary of State during the week:—

December 14th.

Official News:—British submarine B.11 yesterday entered Dardanelles, and despite difficult current dived under five rows of mines, torpedoed Turkish battleship Messudiyeh, and returned safely. Messudiyeh last seen sinking by stern. Enemy has evacuated west bank Yser Canal. Three violent infantry attacks made by enemy south-east of Ypres were repulsed. Russians have captured enemy's position in region Prozamysz Cochanow. Enormous losses inflicted on enemy in region Ilow Lowicz. South of Cracow, 4 guns, 7 machine guns, 4,000 prisoners captured Thursday.

December 15th.

News:—After Official comparative quiet fighting recommenced northern Yesterday Allies made combined France. attack on line Hollebeke Wyteschaete, making substantial progress. Several German trenches, numerous prisoners captured. French Government report some progress Argonne Woevres Alsace. Serbian troops have re-entered Belgrade after desperate fighting.

December 16th.

Official News:-German war vessels engaged West Hartlepool fortress this morning and were driven off. Small German warship also opened fire on Scarborough, Admiralty statement issued Whitby. eleven this morning announces our flotillas have been engaged at various points and situation developing. French Government reports small wood captured by our troops west of Wyteschaete, also some progress south of Ypres and in Argonne. Russians report concentration enemy forces left bank Vistula and fierce fighting since worning 14th between Lowicz, Vistula and left bank Dzura. Enemy reported weakening between Czestochowa-Cracow, and Garmans completing their movements by rather vitowards Carpathian Passes.

December 17th.

Official News:—British Patrolling Squadron endeavoured cut off cruisers which raided Yorkshire Coast yesterday, but Germans on being sighted retired full speed and escaped, favoured by mist. Losses on both sides small. Fifty-five civilians killed West Admiralty point out such Hartlepool. demonstrations against unfortified towns or commercial ports are not difficult if some risk is accepted, but have no military significance. French Government report slight progress several points. Westende bombarded by British squadron.

December 18th.

Official News:—French Government reports progress near Vermelles on road from Ypres to Menin, south and south-east Bixschoot, and in region of Bapaume and Peronne. Russian Government reports successes in direction of Mlawa and sinking of German armoured cruiser Friedric Karl with two-thirds crew. Egypt has been declared British Protectorate; Turkish sovereignty thus terminates.

December 19th.

Official News:—French Government report progress in Belgium, trenches captured by vigorous offensive in Arras district, little ground gained north-east Nieuport, slight advance by British troops Armentieres region, strong counter-attacks on Ypres-Menin road repulsed, two heavy enemy batteries destroyed near Verdun. His Majesty's Government have deposed Khedive of Egypt, who has joined King's enemies. Khediviate offered to and accepted by Prince Hussein Kemel Pasha.

Memorandum us to Temporassion of Money and Letters Abroad.

THE Foreign Office is unable to indertake any responsibility for the forwarding of money, letters, or messages to individual persons abroad.

Payments of money to British who are detained in an enemy country and unable to return to His Majesty's Dominian constitute an infringement of the Trading with the Enemy Proclamation, but it is a large to forward such remittances through a neutral country.

It is suggested that is may be so wible to orward the money through Messrs. Cook and Son or one of the principal section.

Private letters to Germany and Austria-Hungary through neutral countries are now allowed to be forwarded subject to the usual conditions of censorship. Letters cannot, however, be forwarded direct to Germany or Austria-Hungary. British subjects and others wishing to communicate with friends in enemy countries must forward their letters through an agency in a neutral country, and correspondents may select their own private agency. Letters should not, however, be sent through British or Foreign Embassies, Legations, or Consulates in neutral countries. Messrs. Cook and Son have, it is understood, expressed their willingness to arrange for the transmission of such letters, and applications for information as to the necessary stamps, &c., should be made to them.

Letters intended for transmission to enemy countries should be as brief as possible, should contain nothing but personal matter, and should, if possible, be written in the German language.

It should be noted that the Foreign Office, in making the above suggestions, cannot guarantee the safe delivery of either money or letters.
