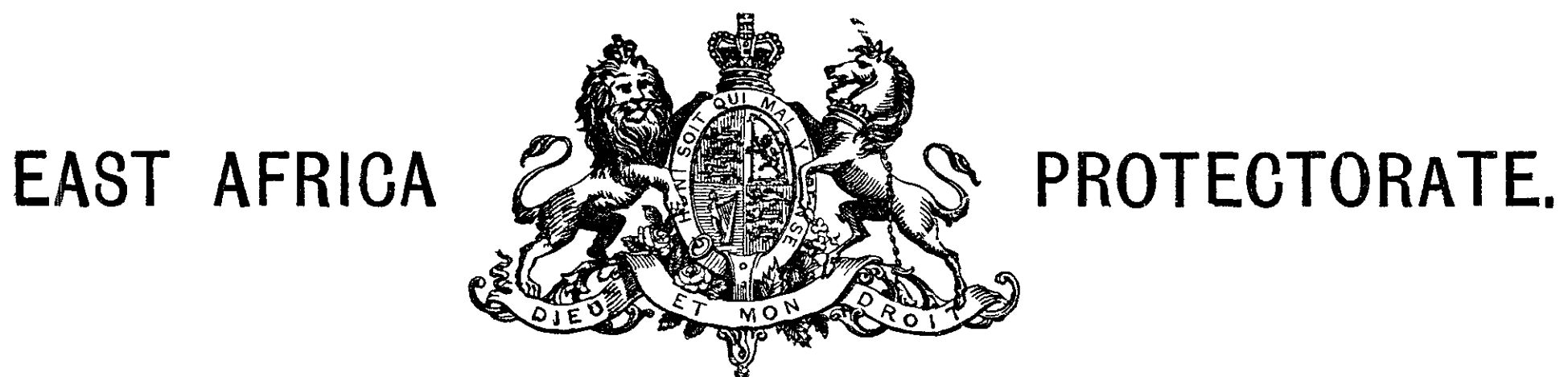

### NOTICE

THE following notices are published for general information —

HIS Britannic Majesty's Principal Secretary of State for Foreign Affairs gives notice that in view of the state of war arising out of the action of Turkey, Egypt is placed under the protection of His Majesty and will henceforth constitute a British Protectorate

The suzerainty of Turkey over Egypt is thus terminated, and His Majesty's Government will adopt all measures necessary for the defence of Egypt and the protection of its inhabitants and interests

December 18th, 1914

The King has been pleased to approve the appointment of Lieutenant-Colonel Sir Arthur Henry McMahon, G C V O , K C I E , C S I , to be His Majesty's High Commissioner for Egypt

December 18th, 1914

HIS Majesty's Government, having been informed that the Government of the French Republic have recognized the British Protectorate over Egypt, His Britannic Majesty's Principal Secretary of State for Foreign Affairs hereby gives notice that His Majesty's Government adhere to the Franco-Moorish Treaty of March 30th 1912

In view of the action of His Highness Abbas Hilmi Pasha, lately Khedive of Egypt, who has adhered to the King's enemies, His Majesty's Government have seen fit to depose him from the Khedivate, and that high dignity has been offered, with the title of Sultan of Egypt, to His Highness Prince Hussein Kamel Pasha, eldest living Prince of the family of Mahomet Ali, and has been accepted by him

WITH reference to General Notice No 32, published on page 35, of the *Official Gazette* of 1915, respecting the Government War Risks Insurance scheme, information has been received that the rates of premium on hulls were reduced on the 17th of December, 1914, from £1 per cent, to 15s per cent, for a voyage, and from £2 per cent to 30s per cent, for a round voyage or for a time policy for three months

The rate of premium for cargo was reduced on the 31st of December, from a guinea and a half to one guinea per cent

**NOTICE****EUROPEAN WAR**

**The following telegrams have been received from the Secretary of State during the week:—**

February 28th

Official news —Four forts Dardanelles entrance namely Cape Helles, Seddul, Mokhanieh, Kao Kalessie, re-attacked Thursday morning by allies' fleet "Queen Elizabeth" "Agammonon" "Irresistible" and "Gaulois" at long range, later "Vengeance" and "Cornwallis" engaged first closely, and "Suffolk" and "Charlemagne" last two, reductions completed of all four at 5-15 after further close attack by "Vengeance" "Triumph" and "Albion" Sweeping operations then begun on Friday, Straits swept for four miles up "Albion" "Majestic" and "Vengeance" at limit of swept area engaged forts Dardanus and enemy left forts entrance Landing parties from "Vengeance" and "Irresistible" demolished first three forts completely and fourth partially and destroyed two new guns and four nordenfeldts On Thursday "Agammonon" hit by shell at 11,000 yards casualties three killed, five wounded, Friday casualties one killed, three wounded Operations proceeding

March 1st

Official news —French Government reports small successes near Dixmude and Lombartzyde, important progress in Champagne, German works carried north of Perthes and Beausejour, two hundred prisoners captured north-east Perthes, over thousand German soldiers surrendered during last ten days, subsequent report confirms progress Champagne, gains representing two thousand metres trenches, in one trench enemy left over two hundred dead, in Aigonne about three hundred yards trenches captured, at another point Germans sprayed advanced French trench with burning liquid Russian Government reports their offensive developing north Eastern Poland, Pryasnysz taken, German retreat extending, about five thousand five hundred taken prisoners, Austrians severely defeated in Eastern Galicia, losing four thousand prisoners nine machine guns

March 2nd

Official news —Sir John French reports enemy activities near Ypres checked, attack yesterday morning on portion off line repulsed, party Princess Patricia's Canadian Light Infantry captured and blew up German trench, killing eleven occupants, driving off remainder, ground gained near La Bassée French Government reports gains in Champagne secured and strong counter attack repulsed north of Mesnil and further progress made, prisoners captured both there and in

Vosges Russian Government reports operations round Pryasnysz concluded by defeat of two German army corps, ten thousand prisoners captured, also rich booty Admiralty reports Dardanelles operations again delayed unfavourable weather

March 3rd

Official news —French Government reports continued progress between Perthes and Beausejour, notably northwest Perthes, slight progress Aigonne (where hundred prisoners taken,) and Vosges, enemy attacks near Rheims repulsed Russian Government reports offensive continued on Niemen front, enemy still bombarding Osowiec, in Pryasnysz district enemy retiring hastily, in Carpathians furious battle South Pizemysl, Austrian losses exceedingly great, Austrians also defeated in region Stropko Dardanelles operations resumed Monday morning "Triumph" "Ocean" and "Albion" entered Straits attacked fort No 8 and white cliff batteries, fire returned by Forts also fieldguns and howitzers, an reconnaissance reported several new gun positions prepared, no guns erected, seaplanes also located surface mines. Monday night mine sweepers swept interior mile and half off Cape Kephey, work under fire excellent, casualties only six wounded, four French battleships operated off Bulan, bombarded batteries and communications, operations at entrance destroyed, nineteen guns from six to eleven inches, eleven below six inches, four nordenfeldts, two searchlights, magazines, Forts 6 and 3 also demolished Tuesday "Canopus," "Swiftsure" and "Cornwallis" engaged Fort No 8 heavy fire opened by Fort No 9 also Field batteries and howitzers Fort No 9 damaged, ceased fire 4 30, battleships withdrew 5 30 all three hit, only casualty one slightly wounded, seaplane reconnaissance impossible through weather, attack progress, Russian cruiser "Askold" joined allied Fleet

March 4th

Official news —French Government reports progress Champagne maintained and extended, French hold German lines six kilometres long one kilometre deep, German guard regiment sustained enormous losses, some further prisoners captured Russian Government reports further progress Northern front enemy's attempts approach Osowiec fortress repulsed, in Carpathians successes obtained against Austrians and Germans, in Eastern Galicia on river Lomiqui, near Stanislaw, Austrians suffered very serious reverse, losing six thousand prisoners, guns, transport

March 5th

Official News —Admualty reports attack Dardanelles resumed Wednesday, results within Straits not yet reported, outside Straits Observation Station demolished Gallipoli Peninsula, Turkish guns and troops bombarded in Adiamyti Gulf, forty Turkish guns already destroyed, French have bombarded Bulan forts wrecking Kavack bridge German submarine U 8 was sunk in English Channel yesterday, crew captured, merchant vessel "Thordis"

rammed and probably sunk Geiman submarine February 28th French Government reports loss advanced trench north of Airas, in Champagne where further progress made two German guards regiments defeated with heavy loss, German æroplane captured near Veidun Russian Government reports some progress Niemen and northern Poland, where fighting specially stubborn, in Carpathians Austrians continued fruitless attacks suffering immense lossess
