GOVERNMENT NOTICE No 179]

UNDER MARTIAL LAW.

REGULATIONS

HIS EXCELLENCY the Acting Governor has been pleased to issue the following Regulations under Martial Law —

- 1 Any person holding or who may hereafter hold for the purpose of sale any of the articles set forth in the first and second schedules hereto shall forthwith make a return to the District Commissioner of the District in which such articles are held specifying the name of each article and the quantity thereof so held
- *2 The sale of any of the articles set forth in the first schedule hereto is hereby prohibited save on the production of a certificate of a duly certified medical practitioner that the article specified in such certificate is necessary for the health of the person named in such certificate. The certificate shall set out the name and amount of the article required
- 3 The person selling any article under the provisions of the preceding Regulation snall keep the certificate and such certificate shall be open to inspection upon demand by any officer of Police not below the rank of an assistant inspector
- 4 No person shall sell maize, maize meal or Machakos ghee at a price above the following maximum price —

(a) Maize, Hickory King	Rs 2-25 per load of 60 lb	S
" Native	Rs 1-75 ,, ,, ,, ,,	
Maize meal, Hickory King	Rs 2-75 ,, ,, ,, ,,	
" Native " "	Rs 2-25 ,, ,, ,, ,, ,,	

Provided that at Mombasa 50 cents per load of 60 lbs may be added to the above prices

(b) Machakos Ghee

70 cents per lb

5 These Regulations shall be read together with the Martial Law Regulations of the 10th December, 1914, and any person committing a breach of these Regulations shall be liable on conviction to a fine not exceeding Rs 5000/- or to imprisonment of either description for a term not exceeding 6 months or to both
