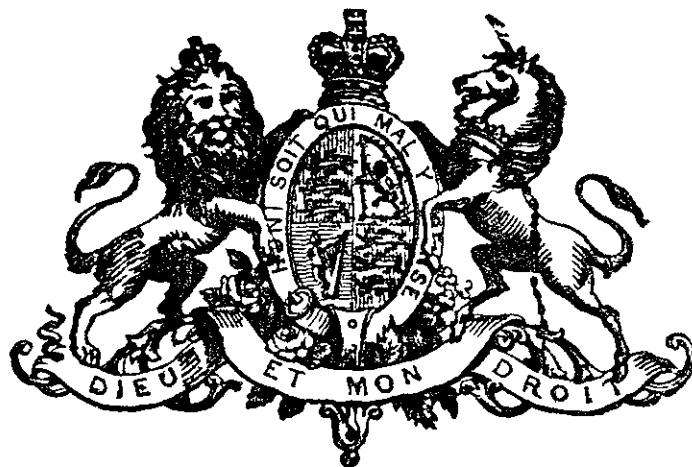

THE TRADING WITH THE ENEMY AMENDMENT ORDINANCE, 1916.

PROCLAMATION

IN EXERCISE of the powers conferred upon the Governor by the Trading with the Enemy Amendment Ordinance, 1916, section 2 (2), I, Charles Calvert Bowring, a Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor of the East Africa Protectorate, hereby declare that the Statutory List contained in the Trading with the Enemy (Statutory List) Proclamation, 1916 (Proclamation No 37), as amended by subsequent Proclamations be further amended by making therein the additions, variations and removals contained in the Schedule to the Order dated the 25th day of May, 1917, made by the Lords of His Majesty's Most Honourable Privy Council and published in the *Official Gazette* (Government Notice No 271 of 1917)

GOVERNMENT NOTICE No 271]

ORDER OF THE LORDS IN COUNCIL

TRADING WITH THE ENEMY (NEUTRAL COUNTRIES) ORDER (No 35), 1916

At the Council Chamber, *Whitehall*, the 25th day of *May*, 1917

By the Lords of His Majesty's Most Honourable Privy Council

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation, such List being therein referred to as "the Statutory List"

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect —

That the "Statutory List" should be further varied and added to as set forth in the Schedule hereto

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the Statutory List be varied and added to as set forth in the Schedule hereto

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly

GOVERNMENT NOTICE No 273]

UNDER MARTIAL LAW.

REGULATIONS

Radiotelegraph on Ships.

HIS EXCELLENCY the Acting Governor has been pleased to issue the following Regulations under Martial Law —

- 1 (1) The radiotelegraph apparatus on board ships other than His Majesty's ships of war shall not be worked whilst such ships are within a harbour of the Protectorate
- (2) Ships of British register in Protectorate harbours must completely disconnect their aerial wires from their radiotelegraph apparatus the ends of such wires being suspended entirely clear of the radiotelegraph cabin, preferably from the main rigging, in such a manner to show they are properly disconnected
- (3) Ships of Foreign register in a Protectorate harbour must, subject to the provisions of the following regulation, take down their aerial wires completely and disconnect the same from their radiotelegraph apparatus
- (4) Ships of Foreign register remaining in a Protectorate harbour for less than 12 hours may, at the discretion of the competent naval authority, be permitted to leave their aeriels up provided the same are disconnected in accordance with the provisions of regulation (2)
- (5) The naval authority at any Protectorate port or in the absence of a naval authority the principal civil authority may in addition to the provisions of the foregoing regulations seal the radiotelegraph operating room on any ship other than on one of His Majesty's ships of war and may in his discretion take such other steps as he may be advised to prevent the use of the radiotelegraph installation on such ships

2 These Regulations shall be read together with the Regulations published under Martial Law of the 10th December, 1914

3 The master of any ship on which a breach of these Regulations has occurred shall on conviction be liable to a fine not exceeding Rs 1,500/- or to a term of imprisonment of either description not exceeding 6 months or to both

GOVERNMENT NOTICE No 274]

UNDER MARTIAL LAW.

REGULATIONS

HIS EXCELLENCY the Acting Governor has been pleased to issue the following Regulations under Martial Law —

1 Notwithstanding anything to the contrary contained in any Regulation under Martial Law any maximum prices fixed by any Regulation made under Martial Law and issued at a date preceding the issue of these regulations shall apply to any sales whether for cash or on credit

2 The Regulations issued under Martial Law of the 16th day of June, 1917 (Government Notice No 215), are hereby revoked

3 The Governor may appoint a Food Controller

4 No sale or delivery of rice, flour or sugar shall be made in Mombasa after the date hereof without the permit in writing of the Food Controller —

(a) by the importer thereof to any person for the purpose of sale by wholesale or retail by such person or

(b) by any such person to any other person for the purpose of sale by retail

Any permit issued under this regulation shall specify whether the sale and delivery are for the purpose of sale by wholesale or sale by retail Any sale or delivery in breach of such a permit shall be punishable under these regulations

5 No rice, flour or sugar imported into the Township of Mombasa shall be conveyed out of such township whether by rail, sea or road without the permit in writing of the Food Controller

6 The Food Controller may in his discretion refuse to issue any permit under these regulations

7 The Food Controller may from time to time fix and publish maximum prices for rice, flour and sugar and for such other articles of food as the Governor may direct

8 The Export of rice, flour and sugar is prohibited to all destinations other than the Uganda Protectorate

9 These Regulations shall be read together with the Martial Law Regulations of the 10th day of December, 1914, and any person committing a breach of these Regulations shall be liable on conviction to a fine of Rs 750/- or to imprisonment of either description for a term not exceeding 6 months or to both

10 These Regulations may be administered by any Magistrate holding a subordinate Court of the first or second class

GOODS EX ENEMY SHIPS IN ITALIAN PORTS

His Majesty's Secretary of State for Foreign Affairs has received from His Majesty's Ambassador at Rome the following translation of a Royal Decree (No 626), dated March 29th last, and published in the Italian Official Gazette of April 27 —

ARTICLE 1

When it is necessary to discharge ships which are to be placed at the disposal of the State Administration the captain of the port will, by registered letter, notify the captain and the owner and his representative that he must make provision therefor within a time-limit to be fixed in each case

On the expiration of this time-limit, or immediately in case of urgency, the captain of the port, in agreement with the Royal Customs Authorities, will take the necessary steps, taking care that the goods are sorted and kept in depôts or warehouses

The portion of the goods which is not requisitioned by the State Administrations must be handed over by the Royal Customs Authorities to those persons who shall prove that they have a right thereto, and that they have paid any charges due on the goods

ARTICLE 2

If persons demanding the consignment of the goods are for special reasons unable to present all the documents required, or if they consider the conditions made for the issue of any of these documents excessive, they may apply for an arbitration commission to be established, when necessary, at the office of the captain of the port by the Minister of Maritime and Railway Transports

The Commission is to consist of a presiding judge, an official from the Port Office, and a representative of the Chamber of Commerce appointed by the Minister of Maritime and Railway Transports at the proposal respectively of the president of the Tribunal, the captain of the port and the president of the Chamber of Commerce

After examining the documents and hearing the views of the Royal Customs Authorities, and where thought fit after a summary interrogation of the interested parties, the Commission may order the goods to be handed over on payment of a fixed sum or production of a suitable guarantee

In such case the Commission will determine the conditions and terms of the deposit or guarantee

The Commission can also order the sale of the goods and deposit of the price

The Royal Customs Authorities, after having verified the execution of the Commission's orders, will give immediate effect to its decision

No appeal or action against the decision of the Commission is admitted
Rights of the respective parties to be made good before the competent authorities are reserved

ARTICLE 3

Goods not withdrawn within 60 days of the announcement in the Official Notices of the Province of the discharge of the ship may be sold by public auction, and if no sale ensues there, privately by the Royal Customs Authorities

Consignments of goods under 2,000 lire in value will always be sold privately

The Royal Customs Authorities will deposit in the Deposits and Loans Caisse for the account of the person to whom it belongs the sum obtained after deduction of freight, expenses and dues owing to the Administration, not including import duty

In cases falling under the second paragraph of Article 2 sale can be effected after the expiration of the time-limit fixed by the Commission

ARTICLE 4

The expenses to be deducted from the price, which are to be paid at the time of handing over the goods on which they are due, are those for discharging, delays on board ship, transport to and arrangement in the depots and warehouses, transport, warehousing, withdrawal and insurance on board ship or in the warehouses and any other expense incurred in conservation, protection and sale of the goods discharged from the ship

ARTICLE 5

Before handing over or selling the goods the captain of the port will inform the Ministry of War in order to enable requisition to be made when desirable on account of that Ministry or for other civil or military administrations

For all the purposes of requisition the captain of the port is considered the de facto possessor of the goods to which Article 1 refers

ARTICLE 6

On completion of the requisition, the captain of the port will compile a list of the goods requisitioned with the necessary indications to distinguish them, and the price fixed and the name of the Administration on whose account they have been requisitioned

The list will be published in the Official Notices of the Province and exhibited at the Office of the port

ARTICLE 7

The indemnity for requisition will be paid, after deduction of the expenses, to the person to whom goods would have been handed over according to paragraph 2 of Article 1

In case of doubt or controversy, or if the indemnity is not accepted, it will be paid, after deduction of the expenses, into the Deposits and Loans Caisse to the account of the person to whom it belongs

Payment in this manner can similarly be made if within the period prescribed under Article 9 no one appears to claim the indemnity

ARTICLE 8

Whoever claims an indemnity for requisition, if the conditions of the first part of Article 2 apply, may apply to the Commission established there, which will arrange for the deposit or payment of the sum fixing the appropriate guarantees according to the conditions and for the effects provided in the same article

ARTICLE 9

The period of 60 days fixed in the first part of the Sole Article of the Decree of August 27, 1916, No 1119, begins, for the purposes of the same Decree, from the time of the publication of the list in the Official Notices of the Province, provided for in Article 6

It lies with the Administration on whose account the requisition is made to apply for the constitution of an arbitration college in the sense of Article 2 of the Decree of October 30, 1915, No 1570

ARTICLE 10

The application of the present Decree does not prejudice regulations in force for the subjects of enemy States or States allied with the enemy, and for the exercise of the right of Prize

ARTICLE 11

The Minister of Maritime and Railway Transports, in concert with the Ministers of Foreign Affairs, Finance and War, will issue regulations for the execution of the present Decree

ARTICLE 12

The regulations referred to in the present Decree are issued by the officials of the Port Office and of the Royal Customs without any responsibility on their part or that of the public Administration, and without prejudice to the reciprocal rights of the parties

ARTICLE 13

The present Decree is also applicable to goods disembarked before this date from ships placed at the disposal of the Administration of the State

In such cases the time limit fixed by Article 3 begins from the date of publication of the Decree

As regards requisitions effected before the enforcement of the present Decree, the arrangements of the Sole Article of the above-mentioned Decree of August 27, 1916, hold good

The present Decree will take effect from the date of its publication in the Official Gazette
