THE REFORMATORY SCHOOLS ORDINANCE, 1910.

RULES.

- 1. These Rules may be cited as "The Reformatory Schools Amendment Rules, 1921," and shall be read as one with the Rules, dated the 30th day of October, 1911, and published on page 555 of the Gazette 1911, hereinafter referred to as "the Principal Rules."
- 2. Rule 10 (a) of the Principal Rules shall be and is hereby amended by the deletion of the figure "5" and the substitution therefor of the figure "10."

THE ENTERTAINMENTS TAX ORDINANCE, 1920.

REGULATIONS.

IN EXERCISE of the powers conferred upon him by the Entertainments Tax Ordinance, 1920, the Governor's Deputy has been pleased to make the following Regulations:—

Interpretation.

1. In these regulations "Treasurer" means and includes officers appointed to act on his behalf for the purpose of collecting Entertainment Tax. The designations or names of officers so appointed shall be published in the Gazette.

Mode of payment.


2. Proprietors wishing to make payment of the Tax otherwise than by means of stamped tickets shall apply to the Treasurer stating the period for which they wish so to make payment and the amount of the Tax they estimate will fall due for payment during that period.

Date of applications.

3. Such applications shall reach the Treasurer not later than fourteen days prior to the commencement of the period except in the case of any period commencing on the 1st day of January, 1921, in which case the application shall reach the Treasurer as early as possible.

Security.

4. The Treasurer having satisfied himself that the system of account employed by the applicant is such as to afford a proper check of the numbers and prices of tickets that will be sold shall stipulate the security which in his opinion is necessary and



upon tender thereof shall agree to payment of the Tax upon production of returns after the expiration of the period agreed upon.

Returns.

5. The returns to be furnished shall set out the numbers and prices of the tickets actually sold and the Tax payable thereon and shall be accompanied by the amount of the Tax.

Date of receiving Returns.

6. The returns shall reach the Treasurer not later than fourteen days after the expiration of the period agreed upon.

Examination of Books.

7. It shall be an understood condition of application to make payment under the arrangement set forth in Regulations No. 2 to 6 that the applicant agrees that his books of account shall be opened to audit by the Treasurer or the Audit Department, in so far as is necessary to check the numbers and prices of the tickets sold, at any reasonable date and time.

Tickets.

8. In all cases, other than those provided for above, tickets for entertainments liable to the Entertainment Tax shall be printed in counterfoil books consecutively numbered having printed on each ticket and counterfoil the date of the entertainment and value of the ticket exclusive of the amount of the tax.

Stamps to be affixed.

9. Proprietors shall affix to each such ticket a postage stamp of the Colony of Kenya to the value of the tax payable and shall forward to the Treasurer not later than seven days prior to the date of the entertainment all such stamped tickets for audit and defacement of the stamps.

Alteration of Ticket.

10. The price of no ticket shall be altered after defacement of the stamp without the consent of the Treasurer. To obtain such consent proprietors must resubmit the tickets to the Treasurer with the prices altered and with additional stamps affixed to cover the increased tax.

Refund on unsold Tickets.

11. After an entertainment in respect of which the tax has been paid by means of stamps affixed to counterfoil tickets a refund of the tax paid on unsold tickets may be claimed from the Treasurer. No refund will be made in respect of tickets detached from their counterfoils unless it can be shown to the satisfaction of the Treasurer that the detached tickets were exchanged for others bearing a diffierent rate of tax upon which tax has in fact been paid. The Treasurer shall destroy all tickets in respect of which a refund is made.

Season tickets.

12. The tax in respect of admission to entertainments for a season, or for a series of entertainments, or to any entertainment during a certain period of time may be dealt with either under Regulations No. 2 to 7 or Regulations 8 to 11.

Clubs and Societies.

13. In all cases in which admission to an entertainment or entertainments is obtained by means of life membership of, or periodical subscription to, a club, association or society the proprietor shall furnish the Treasurer with true periodical returns of life members and subscribers. In the case of life

members the returns shall be furnished not later than the 30th September in each year and in the case of subscribers not later than one month from the date upon which the period covers by the subscription commences.

Date of Returns.

14. Clubs. associations or societies which do not wish to adopt the system of payment set forth in Regulations No. 2 to 7 and which give entertainments subject to tax between the 1st January, 1921, and such date as they may reasonably be expected to have provided themselves with defaced stamped tickets shall before the 28th February, 1921, furnish the Treasurer with a return setting out the number and prices of the unstamped tickets actually sold and the tax payable thereon and shall therewith tender the amount of the tax.

NOTICE.

HANDLING AND DELIVERY OF CARGO AT PORTS
OF KILINDINI AND MOMBASA.

ON and after the 1st January, 1921, all cargo imported at the aforementioned ports will be landed, sorted, stowed and delivered, and all cargo for export will be shipped, by the Steamship Agents.

As the sheds are now empty and to avoid handing over by the Railway to the Agents of a portion of a large cargo expected prior to the 1st January, it has been arranged that the "Nevasa's" and the "Garth Castle's" cargoes expected on the 29th and 30th instant respectively shall be dealt with by the Steamship Agents.

The agreement between the Government and the Steamship Companies, as approved, has already been published.

The following Regulations have been issued by me departmentally but are published for general information.

A charge for handling and shipping goods for export of Fls. 4/50 per Bill of Lading ton inclusive of Fls. 1/20 per Bill of Lading ton cranage but plus 50 cents for towage from Mombasa to Kilindini or vice versa has been submitted for the consideration of the Government:—

CUSTOMS DEPARTMENT REGULATIONS WITH REFERENCE TO THE HANDLING AND DELIVERY OF CARGO AT MOMBASA AND KILINDINI.

1. On and after the 1st January, 1921, all cargo landed or shipped at Mombasa and Kilindini will be handled by the Steamship Agents hereinafter called the Agents of the steamer from which cargo is discharged or to which cargo is shipped.

IMPORTS.

2. Cargo discharged will be lifted by the Customs or Railway cranes as the case may be but all handling, sorting and stowing will be done by the Agents.

- 3. To clear cargo discharged through the Customs, the Importer or his Agent must produce with his Bills of Entry, the Bill of Lading for the goods to be cleared or where no Bill Lading is available an Agents' Delivery Order.
- 4. The Declaration Clerk to whom the Bills of Entry and Bill of Lading or Agents' Delivery Order are presented for examination will, after the usual comparison and check with invoices, compare the Entry or Entries with the Bill of Lading and if the particulars correspond, will stamp the latter "Released" after as at present initialling the Bill or Bills of Entry. The number of the Bill of Entry will be inserted in the Bill of Lading and vice versa.
- 5. Should it be considered necessary to examine any packages or the whole consignment the word "Stop" will be stamped in the Long Room either against the package or against the whole consignment as may be necessary on the Bill of Entry and such goods as are so marked will not be delivered without the authority of the Examining Officer having first been obtained. The Bill of Lading will be similarly stamped as to one or more packages or the whole consignment as the case may be. Such packages as are not stamped "Stopped" being stamped "Released."
- 6. The Bills of Entry will be sent to the Outdoor Branch as at present and the Bill of Lading returned to the Importer or his Agent.
- 7. In the case of dutiable goods Bills of Lading will on no account be stamped until after duty has been paid.
- 8. Customs clerks will be stationed at such exits from the godowns as may be necessary and their duty will be to prevent any packages passing out of the godowns unless there is presented with them an Agents' Gate Pass giving full particulars of the marks and numbers of the goods delivered.
- 9. The Examining clerks referred to in the foregoing paragraph will check each package with the Gate Pass and having ascertained that all is in order will allow delivery retaining one copy of the Gate Pass.
- 10. The Gate Pass will be endorsed by the Agents with the number of the relative Bill of Lading or Agents' Delivery Order as the case may be and the number of the relative Bill of Entry.
- 11. No receipts from consignees will in future be obtained on the back of the Bills of Entry.
- 12. In the case of duty paid in kind the Examining Clerk will retain the number of packages shown as paid in kind and cause them to be forwarded by the consignee to the King's Warehouse in the usual manner, a receipt being given to the Agents by the Warehouse Keeper.
- 13. In such cases the Bill of Lading will be stamped "Released subject to the duty in kind" and endorsed with the particulars of the goods paid in kind, the Agents being responsible for seeing that only those goods duty paid are delivered to the consignee and that the goods paid in kind are delivered to the King's Warehouse by the consignee. Gate Passes will be required as in the case of other goods.
- 14. In the case of goods entered for Warehousing, the Bill of Lading or Agents' Delivery Order will be stamped "Bond" and the Agents will be responsible for seeing that they are not passed out of the sheds except with the special authority of the Examining Clerk who will provide the necessary escort to accompany them to the Bonded Warehouse, a receipt being given to the Agents by the Warehouse Clerk. In the case of goods entered for

warehousing in Nairobi, direct delivery will be granted to the Importer or his Agent on the production of the necessary Gate Pass subject to such Regulations as it may be necessary to bring into force for the sealing of packages or wagons. Gate Passes will be required for the goods referred to in this paragraph as in the case of all other goods.

- 15. All Want of Entry goods will be handed over to the King's Warehouse by the Agents as is at present done by Railway and Customs, the necessary Gate Passes being issued marked "Want of Entry." All lists of Want of Entry cargo so handed over must be made out in triplicate.
- 16. All Bills of Entry and Gate Passes will be sent as soon as possible after being dealt with to the Manifest Branch where they will be carefully examined, checked and compared, any discrepancy being at once brought to the notice of the Collector.
- 17. Packages will no longer be stencilled before delivery.
- 18. In the case of goods loaded direct into trucks for off loading in the Stacking Yard, the numbers, marks and description of contents will be furnished by the Agents to the Customs. In the case of trucks loaded direct for consignment up country, the numbers of the trucks, marks and numbers of the packages and description of contents will be furnished by the Agents to the Customs. No wagons so loaded will be released without authority from the Customs. In neither of the foregoing cases must goods be released until Agents' Gate Passes have been handed to the Customs.
- 19. Such tally at the quay side and such check of the goods referred to in paragraph 18 as may be necessary at the time of landing and before release at the wagon side will be conducted by the Customs under instructions of the proper officer.
- 20. A Truck Register will be kept by the Customs as at present.
- 21. The proper officer will be held responsible for the systematic inspection of the Agents' Books and Records. If Shed Manifests are kept, a copy must be supplied by the Agents to the Customs.

EXPORT.

- 22. No goods must be shipped into lighters until the Agents' Shipping Order giving the number of the relative Customs Export Entry together with that Entry is produced to the Customs clerk at the Quay side. That clerk will carefully compare the Shipping Order with the Export Entry and if the particulars are correct will stamp the Shipping Order with the words "Shipment permitted" and such stamped Shipping Order will be the Agents' authority for shipment into lighters.
- 23. Such tally and examination of goods for shipment as may be necessary will be conducted by the Customs under instructions of the proper officer.
- 24. Goods shipped will no longer be stencilled by the Customs.

CRANAGE.

A further order will be issued with regard to the collection and accounting for of cranage.
