THE PREVENTION OF CRUELTY TO ANIMALS (AMENDMENT) ORDINANCE, 1921.

Rules

- 1. These Rules may be cited as "The Prevention of Cruelty to Animals Rules, 1921."
- 2. The use of nose ropes and nose rings for oxen and the beating of oxen otherwise than with whips or thongs made of leather and not exceeding one inch in width is prohibited in the Provinces of Ukamba, Kenya and Nyanza.

THE BRITISH PROTECTORATES (DEFENCE) ORDER-IN-COUNCIL, 1916.

REGULATIONS.

WHEREAS by a notice published in the "Official Gazette" of 28th December, 1917, an undertaking was given that the importation of wheat and wheat flour should be prohibited except on licence for three years from 1st December, 1918.

And whereas it is now found necessary to carry cut the aforesaid undertaking and to fix maximum prices in accordance with the terms thereof.

Now therefore in exercise of the powers conferred upon him by "The British Protectorates (Defence) Order-in-Council, 1916, Article IV (1) (e), and all other powers him thereunto enabling, His Excellency the Governor has been pleased to make the following Regulations:—

- 1. These Regulations may be cited as "The Defence Regulations, 1921."
- 2. The importation into the Colony and Protectorate of wheat flour of the qualities known as "superfine" and "household" except on licence is prohibited from 1st June, 1921, until further notice.
- 3. The Director of Agriculture shall be the authority for the issue of licences to import wheat flour. Provided that licences for the importation of wheat flour in transit to Uganda shall be issued by the Commissioner of Customs on his being satisfied that such flour is genuinely consigned to Uganda.
- 4. The maximum price which sellers of flour of the qualities mentioned above may charge is Fls. 33 per bag of 200 lbs. net delivered freight paid at any Kenya railway station. This regulation shall apply to sales of lots of 100 bags and over in fulfilment of one order and for one delivery.
- 5. Any person who has any stocks of any article the maximum price for which has been duly fixed by these Regulations or by Proclamation under the British Protectorates (Defence) Order-in-Council, 1916, or otherwise in accordance with law, or which may hereafter be so fixed, and who usually sells any such article in the course of his business shall at all reasonable times sell a reasonable quantity of any such article on demand at a price not exceeding such maximum price as aforesaid to any person offering cash for the same.
 - 6. Any person contravening the provisions of the above Regulations shall be liable on conviction by a Magistrate having power to hold a Subordinate Court of the First or Second Class to be punished in accordance with the provisions of the British Protectorates (Defence) Order-in-Council, 1916, in that behalf made and provided.


