THE EAST AFRICA TOWNSHIP ORDINANCE, 1903.

Rules.

IN PURSUANCE of the powers conferred upon him by the above Ordinance His Excellency the Governor has been pleased to make the following Rules:—

These Rules may be cited as the Mombasa building Amendment Rules, 1921, and shall apply to the Township of Mombasa and shall be read as one with the Township Rules, 1904, and any amendments thereof relative to the Township of Mombasa.

1. Notwithstanding anything contained in any Rules issued under the above-mentioned Ordinance relating to the Township of Mombasa, it shall be lawful for the Resident Commissioner to grant permits for temporary buildings on such obligations

both as to removal thereof and otherwise and generally upon such terms as he, in his free discretion, may prescribe subject to the written concurrence of the Medical Officer of Health, provided that no permit may be granted under this Rule for a building any of the walls of which are to be constructed wholly or partly of stone, bricks or concrete.

II. Every person who shall erect a building or alter or add to any building shall before proceeding to lay or cover up any foundation footings or any damp course of such buildings or commence such other work, deliver or send, or cause to be delivered or sent to the Resident Commissioner notice in writing, in which shall be specified the date on which such person will cover up such foundation footings or damp course or commence such other work as aforesaid.

III. Every person who shall erect a building or alter or add to any building shall before proceeding to cover up any drains, cesspits or other work connected with the sanitation of such building, deliver or send or cause to be delivered or sent to the Medical Officer of Health notice in writing stating that such drains, cesspits or other work as aforesaid is ready for inspection.

If such person neglect or refuse to deliver or send any such notice, or cause to be delivered or sent any such notice and if the Resident Commissioner or any other person duly authorised on inspecting any work in connection with such building or other work, finds that such work is so far advanced that he cannot ascertain whether anything required by any Rule relating to Buildings has been done or omitted to be done, and if within a reasonable time after such survey or inspection such person shall by notice in writing under the hand of the Resident Commissioner or such other authorised person be required within a reasonable time, which shall be specified in such notice to cause so much of such work as prevents the Resident Commissioner or such other authorised person from ascertaining whether anything has been done or omitted to be done as aforesaid to be cut into, laid open, or pulled down to a sufficient extent to enable the Resident Commissioner or other authorised person to ascertain whether anything has been done or omitted to be done as aforesaid, such person shall within the time specified cause such work to be cut into, laid cpen or pulled down.

V. If any person who is entitled to proceed with any building or work fails to complete such building or work within a period of two years from the date when deposited plans for such building or work were approved the person shall in every case submit a fresh application for permission before proceeding further with such building or work.

VI. A person shall not occupy any building, or being the owner thereof, suffer the same to be occupied, until such building shall after examination have been certified by the Resident Commissioner to have been erected in accordance with the approved plans and by the Medical Officer of Health to be in his opinion in every respect fit for human habitation.

ANGLO-GERMAN WAR MEDALS FOR DISCHARGED RANKS OF 4rn KING'S AFRICAN RIFLES.

To ENSURE THAT all discharged soldiers of the 4th King's African Rifles duly obtain the War Medals to which they are entitled, it would be convenient if District Administrative Officers would submit lists for their districts of all ex-soldiers of the 4th K. A. R. who claim War Medals, viz., 1914-15 Star, British War and Victory Medals.

The conditions of the grant of these medals are approximately as follows:—

1914-15 Star (vide A.O. 20/19) will be granted to all those who served in the East African Theatre of War between 5th August, 1914, and the 31st December, 1915.

The War Areas are (vide C.O. Despatch E.A.P. No. 1245 of 19-11-19).

Bounded on the North by the Uganda Railway from the sea to Port Florence and Kisumu (including whole of all towns actually on the Uganda Railway), thence along the North Shore of Lake Victoria to the Mouth of the Katonga River, thence along the line of that river to Lake George.

British War Medal (vide A. O. 266/19) will be granted in Silver to all those who either served in the East African Tneatre of War or who left their places of residence and rendered approved service Overseas between 5th August, 1914, and 11th November, 1918.

VICTORY MEDAL (vide A. O. 301/19) will be granted to all who served in the East African Theatre of War between 19/20th August, 1914, and 25/26th November, 1918.

The War areas are (vide A. O. 301/1919, Appendix A):—

Bounded on the North by the Uganda Railway from the sea to Port Florence (including the whole of all towns actually on the Uganda Railway) thence along the Northern shore of Lake Victoria to the Mouth of the Katonga River, thence in a straight line to Mubendi, from Mubendi along the line of Muzzizi River to Lake Albert and along the Southern shore of that Lake to the Congo-Uganda Boundary.

The 1914-15 Star carries with it the British War and Victory Medals.

The Victory Medal carries with it the British War Medal.

Names (giving Regtl. Number, Rank and Battalion) should be submitted periodically in batches, monthly lists in duplicate would be convenient, to the Officer in charge Records, 4th K. A. R., Bombo, Uganda.

Names of deceased soldiers should not be submitted as it is not intended to issue medals to next of kin.

Applicants should be informed that a period of nine months must lapse before medals will be available.

Brooches and Ribbons will be issued with the Medals.
