At 11 a.m. the two minutes silence will be observed, after which the Hymn "O God Our Help in Ages Part" will be sung, accompanied by the Band. At the conclusion of the hymn the Reveille will be sounded by buglers and the ceremony completed.

TENDERS are invited for the right to cut firewood in a coupe of about 170 acres in the Sogoto Forest, Dagoretti. The trees comprise Msharagi, Mukinduri, Musig, Munderendu and other species.
