# COLONY AND PROTECTORATE OF KENYA.

## AN ORDINANCE.

No. 41 OF 1921.

Assented to in His Majesty's name this 28th day of November, 1921.

### **An Ordinance to impose temporary Restrictions on former Enemy Aliens acquiring Interests in Land.**

Be it enacted by the Governor of the Colony of Kenya with the advice and consent of the Legislative Council thereof:—

1. This Ordinance may be cited as "The Former Enemy Aliens Restriction Ordinance, 1921."

2. In this Ordinance the expression "Former Enemy Alien" Interpretation. means an alien who is a subject or citizen of the German Empire or any component State thereof, or of Austria, Hungary, Bulgaria, or Turkey, or who, having at any time been such subject or citizen, has not changed his allegiance as a result of the recognition of new States or territorial re-arrangements, or been naturalised in any other Foreign State or in any British Possession in accordance with the laws thereof and when actually resident therein, and does not retain according to the law of his state of origin the nationality of that State;

The expression "Colony" means the Colony and Protectorate of Kenya.

3. No person shall without the consent of the Governor-in-Council sell, lease, sublease, assign, mortgage or otherwise by any means whatsoever, whether of a like kind to the foregoing or not, alienate, encumber, charge or part with the possession of any immovable property or of any right, title or interest, whether vested or contingent, to, in or over immovable property to any former enemy alien. Restriction on alienation of immovable property.

4. Any agreement or contract for any of the purposes prohibited by the foregoing Section which is not completed and registered before the enactment of this Ordinance shall be deemed void, unless such agreement or contract has received the consent of the Governor-in-Council. Uncompleted and unregistered contracts.

5. No person shall register or cause to be registered any document relating to any transaction prohibited by Section 3 of this Ordinance or deemed to be void under the preceding Section under any law for the time being in force relating to the registration of documents relating to land. Registration.

6. Any person who contravenes any of the provisions of this Ordinance or attempts or abets the contravention of any of such provisions shall be guilty of an offence and shall on conviction be liable to a fine not exceeding £5,000, or to imprisonment of either kind for a term not exceeding three years or to both. If the offence be committed by a Company then every director, manager, secretary or officer of the Company who is knowingly a party to the offence shall on conviction be liable to the like fine or imprisonment or to both such fine and imprisonment. Penalties.

7. This Ordinance shall remain in operation for one year from the date of commencement thereof. Duration of Ordinance.

WHEREAS by the Regulations intituled "The Defence Regulations, 1921," dated 25th May, 1921, published under Government Notice No. 187 in the "Official Gazette" of 25th May, 1921, His Excellency the Governor was pleased to prohibit the importation into the Colony and Protectorate of wheat flour of the qualities known as "Superfine and Household" except on licence from 1st June, 1921, until further notice.

NOW THEREFORE in exercise of the powers conferred upon him by the British Protectorates Defence Order-in-Council, 1916, His Excellency the Governor has been pleased to make the following Regulations:—

1. These Regulations may be cited as "The Defence Regulations (No. 2), 1921."
2. The Defence Regulations, 1921, dated the 25th day of May, 1921, are hereby cancelled with effect from the 1st day of December, 1921.
