Notice is hereby given in respect of
the lands specified in the schedule hereto
to be sold by auction at the Jubilee Hall at Mombasa
on Thursday (the 25th of February) 1922 commencing at 10 a.m.

Plans of the sites may be seen at the Public Map
Office Land Department Nairobi and at the Land
Office Mombasa.

It is the right to withdraw any plot from the auction
as reserved to the Government.

CONDITIONS

Each plot to be auctioned separately.

1. The highest bidder shall be the purchaser, and
in case of dispute as to any bidding, the plot shall
be put up again at the first and reputed bidding.

2. The amount of the advance of each bidding
shall be regulated by the Auctioneer and no bidding
shall be extracted.

3. Each purchaser shall pay to the auctioneer
immediately on the fall of the hammer a deposit of
20% of the purchase money. In default of such pay-
ment the plot may be immediately re-offered for sale
and any subsequent bid by the person who has made
an offer may be ignored or refused.

4. The balance of the purchase money may
be paid in full on the issue of the lease or may
be paid by four equal annual instalments payable
on the first day of January in each year the first
of such instalments to be paid on the first day
of January, 1923. The purchaser shall also pay
interest at the rate of 8% per annum on the unpaid
portion of the purchase money such interest to be

paid on the 1st day of March 1922, and subsequently
on the first day of January in each year. Unless
each such instalment and the interest on the unpaid
portion of the purchase money is paid on the date on
which it falls due they shall be deemed to be added
to the amount reserved in the lease and shall be
payable and recoverable as such.

5. The lease shall be for 99 years and shall com-
mence on the first day of March 1922 and the
rent shall be payable from that date.

6. The building shall be erected on any plot unless
the drainage elevations and specifications thereof
shall have been previously approved to and approved
by the Land Officer or such other person as he may
appoint.

7. The Lessee shall further submit a block plan
of the plot with the position of the building clearly
indicated showing a system of drainage which
shall satisfy the Medical Officer of Health for pro-
tection of the public water on the plot and
before any building may be erected the Lessee
shall satisfy the Medical Officer of Health that such
a system of drainage has been properly constructed.

8. Each Lessee shall suitably connect his pre-
mises with any town drainage system when in the
opinion of the Medical Officer of Health such drain-
age shall be so far completed as to enable the
Lessee reasonably so to connect.

9. The Government or such person as may be
appointed for the purpose shall have the right to
enter upon any plot and there shall have access to
the same for the service pipes for gas or telephone
and other services of all descriptions whether
concerned with drainage or not. The Lessee shall not
erect any building in such a way as to cover or
interfere with any existing water main or service
pipe or other utility or telephone wires and
electrical wires already erected.

10. The following roads to be constructed as
far as possible in the order to be decided by Govern-
ment:-

(a) The portion of the road (shown on
Attachment as 100 ft wide) which lies between
the South-west corner of Plot No. 91 and the
South-east corner of Plot No. 94 and forms the
Southern boundary of Plots 91, 92 and 94.

(b) The road which runs along the Western
boundary of Plot No. 91 from the South-west
corner thereof to its junction with Kilindini
Road.

In the event of the purchasers of Plots Nos. 91, 92
and 94 electing to pay the balance of the purchase
price over the extended period referred to in condi-
tion No. 4 Government will not be bound to begin
construction of the said roads prior to the 1st
January, 1923 and in the event of only two of the
said plots being sold the sale thereof shall be cancelled
and a refund made of monies deposited, provided,
however that if within one month of the date of the
sale the purchasers shall give a joint undertaking to
pay Shillings 10,000 for road construction, which
sum shall be set off against the purchase price,
Government shall ratify the sale. If only one plot
shall be sold Government will not bind itself to con-
struct the said roads, and the sale may be cancelled.

12 Every purchaser shall bear the cost of deeds, stamp duty, registration and survey fees, and all other expenses if any connected with the purchase of the plot.

13 Each purchaser shall erect on his plot within 3 years of the commencement of his lease a building constructed of stone, brick or concrete.

14 At no time during the term of the lease shall any building erected on the plot be used for the purpose of a private dwelling house.






