THE DISEASES OF ANIMALS ORDINANCE, 1906

RULES

IN EXERCISE of the powers conferred upon the Governor by the Diseases of Animals Ordinance, 1906, His Excellency the Governor, has been pleased to make the following Rules —

1 These Rules may be cited as "The Diseases of Animals (Amendment) Rules (No 1) of 1922," and shall be read as one with the Diseases of Animals Rules, 1918, hereinafter referred to as the Principal Rules and all amendments thereof

2 Rule 26 of the Principal Rules under Government Notice No 253 and dated the 30th July, 1920, is hereby cancelled and the following substituted therefor —

26 (1) Any person bringing cattle, camels, horses, mules, donkeys, sheep or goats from the Northern Frontier District or Jubaland into the Kenya or Narvasha Provinces, Districts of Nyeri, Meru or Lukupa, shall conduct such animals to the Isiolo Quarantine Area by the following route and by no other, following the course of the Uaso Nyiro River to its junction with the Isiolo River, thence along the Western bank of the Isiolo River up stream to the Inoculating Station within the Isiolo Quarantine Area

Before arriving at the Uaso Nyiro River the owner or agent in charge of the animals shall give notice to the Administrative Officer or Clerk in charge at Archer's Post, of his arrival and shall state the probable date of arrival of the animals at the Isiolo Inoculating Station and the number of such animals

The owner or agent in charge of any cattle shall cause the said cattle to be inspected and actively immunised against underpest and otherwise dealt with as may be considered necessary, by the Veterinary Authorities at the Isiolo Quarantine Station. The cost of such active immunisation against underpest shall be Sh 6/- per head, and shall be paid by the owner or agent in charge of the cattle. The cattle shall be dipped as required before leaving the Inoculating Station at a charge of twelve cents per head

(2) No such owner or agent shall move any such animals from the Isiolo Quarantine Area until he shall have obtained a permit to do so from the Stock Inspector in charge of the area. Such permit will only be granted on the following conditions —

(a) That the owner either possesses himself or can produce written evidence that he has hired in a non-native area grazing of sufficient capacity to accommodate his stock, or can produce a permit that he is entitled to graze a specified number of cattle on a commonage or Township grazing area, or

(b) That he has obtained a permit from the Officer-in charge of a Native Reserve to trade his stock in that Reserve, or

(c) That he can show satisfactory evidence that he is a Native of a Native Reserve

(3) Nothing in the preceding section shall prevent an owner from obtaining a permit from the Officer in charge of the Isiolo Quarantine Area to take his cattle to a specified Auction Sale provided that if the cattle are unsold he shall within 48 hours of the termination of such Auction return them to the Isiolo Quarantine Area unless he shall have obtained a permit under (a), (b) or (c) of the previous section

(4) No person shall keep cattle, camels, horses, mules, sheep or goats at any place along the line of movement as specified on his permit for a longer period than 48 hours without the permission in writing from the Magistrate of the district in which he is situated at the moment

(5) For the purpose of these Rules the Isiolo Quarantine Area shall include the area bounded as follows —

On the West by the Uaso Nyiro River on the South by a line drawn Eastwards from the junction of the Uaso Nyiro and Uaso Narok Rivers to the highest point of Olloimade Hill, thence to the highest point of Mukogodo Hill thence South Eastwards in a straight line where the Ngare Ndare River intersects the North Kenya Farms boundary, thence along the foot of the Ol Motonyi Escarpment to the Isiolo River, on the East by the Isiolo River and on the North by the Uaso Nyiro River

THE EAST AFRICA TOWNSHIPS
ORDINANCE, 1903

RULES

IN EXERCISE of the powers conferred upon him by the East African Townships Ordinance, 1903, His Excellency the Governor, has been pleased to make the following Rules —

1 These Rules may be cited as The Baggage Clearing Rules, 1922, and shall apply to the Township of Mombasa

2 No person shall carry on the business of a Baggage Clearing Agent within the Township of Mombasa unless such person has been registered by the Resident Commissioner or by some person authorised by him in that behalf. The fee payable on registration shall be Shs 25/- per annum or part thereof

3 The Resident Commissioner may in his discretion refuse to register any person as a Baggage Clearing Agent

4 Every person registered as a Baggage Clearing Agent shall enter into a bond in the sum of Shs 1,000/- with one or more sureties to be void on the faithful discharge of his duties

5 Any registered agent may be struck off the Register for misconduct in his business

THE PUBLIC TRAVEL AND ACCESS
ROADS ORDINANCE, 1920ESTABLISHMENT AND DEDICATION OF A LINE
OF PUBLIC TRAVEL

WHEREAS it has been made to appear that requirements exist for the establishment of a line of public travel, namely, the portion of a road between Kibos Station and a point near Kibigori through and adjacent to Farms L O Nos 654, 1527, 1596, 1595, 4399 and 1602, His Excellency the Governor, in exercise of the powers conferred upon him by Section 8, Sub section (1) of the Public Travel and Access Roads Ordinance, 1920, hereby establishes a line of public travel through the above-mentioned farms and dedicates it absolutely as a public road

100 feet in width between the Uganda Railway and the Southern boundary of Farm No 654/25 and 654/29 and thence 30 feet in width between the boundaries of Farms Nos 654/39 and 1527/1, 654/40 and 1527, and 654/41 and 1527/1 and thence 30 feet in width between the boundaries of Farms Nos 1527/1 and 1527/6 and 1527/2 and 1527/7, 1527/8 and 1527/8, 1527/4, 5, 12 and 1527/9 1527/12, 13 14 and 1527/10, 1527/14, 15 16 and 1527/11 and thence 100 feet in width through Farms Nos 1596, 1595, 4399 and 1602, as shewn approximately by a red line on the plan marked P W D No 2219 filed at the Head Office of the Public Works Department at Nairobi

BYE LAWS

1 These Bye-laws may be cited as 'Nairobi (Unauthorised Buildings) Bye-laws, 1922,' and shall be read together with Nairobi Township Rules, 1917 (hereinafter called 'the Principal Bye laws')

2 Rule 101 of the Principal Bye-laws is hereby amended by the addition thereto of the following words —

"Or alternatively in any case when in the opinion of the Municipal Council such action is necessary, the Town Clerk, after at least 14 days notice in writing given to the occupiers of such building may enter and execute such alterations or additions or remove or demolish such building himself, without liability for any loss or damage that may be occasioned thereby and recover the cost of such work from the owner as a civil debt"
