THE PUBLIC TRAVEL AND ACCESS ROADS ORDINANCE, 1920.

ESTABLISHMENT AND DEDICATION OF A LINE OF PUBLIC TRAVEL.

WHEREAS it has been made to appear that requirements exist for the establishment of a line of public travel, namely, the portion of the Muhoroni-Songhor road through Farms L.O. Nos. 1577, 1632, 1576, 1575 and 1574, His Excellency the Governor,

in exercise of the powers conferred upon him by Section 8, Sub-section (1) of the Public Travel and Access Roads Ordinance, 1920, hereby establishes a line of public travel through the above-mentioned farms and dedicates it absolutely as a public road 200 feet in width, as shewn approximately by red lines on the plan marked P.W.D. No. 2875, filed at the Head Office of the Public Works Department at Nairobi, and as more precisely demarcated by posts to be placed by the Public Works Department at intervals on one side of the road.
