#### THE FOREST ORDINANCE, 1911.

#### RULES.

IN EXERCISE of the powers conferred upon him by the Forest Ordinance 1911, His Excellency the Governor, has been pleased to make the following Rules:—

- 1. These Rules may be cited as "The Pencil Cedar (Timber Rebate of Royalty) Rules, 1922."
- 2. Any person who, after the date of these Rules, shall pay royalty to the Government in respect of Cedar timber shall be entitled to a rebate of such royalty on all slats and billets exported and sold to Pencil Manufacturers at the rate of twelve and one-half cubic feet for each case containing slats or billets for 4,800 pencils and at the same rate of royalty as shall have been paid at the time of purchasing the timber.
- 3. All applications for rebates under these Rules shall be made to the Conservator of Forests and must be accompanied by the necessary documents in support of the claim.
- 4. These Rules shall remain in force for a period of three years as from the date hereof.

#### EAST AFRICA TOWNSHIPS ORDINANCES, 1903-18.

RULES.

IN EXERCISE of the powers conferred upon him by the East Africa Townships Ordinances, 1903-18, His Excellency the Governor has been pleased to make the following Rules:-

These Rules may be cited as the Kisumu Building (Amendment) Rules, 1922, and shall apply

to the Township of Kisumu.

No person shall erect any building with hollow walls, provided that nothing in this rule shall prevent the erection of hollow walls in brickwork, masonry or concrete where it may be proved to the satisfaction of the Medical Officer of Health that the entrance of rats into or their harbourage within the hollow or enclosed spaces of such walls will be effectually pre-

3. In the case of buildings of more than one storey it shall be unlawful for any person to construct any floor thereof so as to leave a hollow or enclosed space between such floor and the ceiling immediately below it unless it has been proved to the satisfaction of the Medical Officer of Health that the entrance of rats into or their harbourage within such hollow or enclosed space will be effectually prevented.
