An Ordinance to provide for the Administration of Promissory Oaths.

BE it enacted by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof:

- 1. This Ordinance may be cited as "The Promissory Oaths Short title. Ordinance, 1922."
- 2. The several oaths required to be taken under this Forms of oaths. Ordinance shall be in the Forms set forth in the First Schedule to this Ordinance.
- 3. The several oaths set out in the first column of the Persons Second Schedule to this Ordinance shall be taken by the take and tender oaths. respective persons named in the second column of the said Schedule as soon as may be after their appointment to or acceptance of office, and shall be tendered by the respective persons named in the third column of the said Schedule.

If any person mentioned in the second column of the consequence of not tak Second Schedule to this Ordinance refuses or neglects, when any of ot taking required oath. oath required to be taken by him under this Ordinance is duly tendered, to take such oath, he shall, if he has already entered on his office, vacate the same, and if he has not entered on his office, be disqualified from entering on the same; but no person shall be compelled, in respect of the same appointment to the same office, to take such oath more times than one.

5. Where an oath is required to be taken under this cases in which Ordinance, every person for the time being by law permitted to affirmation is make a solemn affirmation or declaration instead of taking an of oath. oath may, instead of taking such oath, make and subscribe a solemn affirmation in the form of the oath hereby appointed, substituting the words "solemnly and sincerely, declare and affirm" for the word "swear" and omitting the words "So help me God.''

- 6. Where in any oath under this Ordinance the name of the name of His present Majesty is expressed, the name of the Sovereign of the Sovereign the United Kingdom for the time being shall be substituted from being to be used in oaths. time to time.
- Nothing in this Ordinance shall affect any other oath Saving. required or authorised by law to be taken or made.

An Ordinance to safeguard Native Food Supplies in time of shortage.

BE it enacted by the Governor of the Colony of Kenya with the advice and consent of the Legislative Council thereof:-

- 1. This Ordinance may be cited as "The Native Foodstuffs short title. Ordinance, 1922."
 - 2. In this Ordinance unless the context otherwise requires Definitions.

"Native" shall mean any native of Africa and shall include Somalis and Swahilis.

"Native Foodstuffs" shall mean only such articles of food or drink used by natives as, in the opinion of the Governor-in-Council, are necessary for the support of life.

3. Where it has been made to appear to the Governor-in- powers of Council that any district or area is suffering from, or threatened council. with a shortage of native foodstuffs he may issue a Proclamation for any of the following purposes:-

(a) Prohibiting the purchase or barter of such foodstuffs prohibiting purchase for generally or of any class or classes of the same, for the purpose purchas resale of resale in or export from the district or area in such Proclamation specified, unless the written permission of the Resident Commissioner or District Commissioner as the case may be, be first obtained.

(b) Prohibiting the export of such foodstuffs generally or Prohibiting of any class or classes of the same from any district or area.

- (c) Prohibiting the use of such foodstuffs or of any class or classes of the same for the manufacture of liquor in any district or area.
- (d) Prohibiting the concealment or destruction of such foodstuffs or any class or classes of the same in any district or area.
- 4. Any person acting in contravention of this Ordinance offences and penalties. or of any Proclamation issued thereunder shall be guilty of an offence and shall upon conviction be liable to a fine not exceeding £50 or to imprisonment of either description for a term not exceeding six months or to both. the contest of the contract of the traction

TOPE AND ART OF A

An Ordinance to Enable the Victoria Nyanza Sugar Company, Limited, to Construct and Maintain a Tramway, to be Worked by Steam or other Power, connecting the Company's Farms with Kibos Railway Station and for other Purposes.

Freamble.

WHEREAS the Victoria Nyanza Sugar Company, Limited, being a Company incorporated in the Commonwealth of Australia under the Companies Act, 1915, is desirous of constructing and maintaining a tramway to be worked by steam or other power connecting the Company's land, Land Office No. 4399 (in this Ordinance referred to as "the Farm") with Kibos Railway Station, and running along a public road. And whereas the Company is also desirous of constructing and maintaining subsidiary trolley lines running through private lands to connect with the tramway for the purpose of transporting sugar cane from neighbouring farms to the Company's factory. And whereas it is expedient that the Company should be authorised to construct and maintain the tramway and subsidiary trolley lines, and should be granted the powers, authorities and concessions by this Ordinance conferred upon the Company. And whereas a plan showing the approximate alignment of the tramway line and subsidiary trolley lines was deposited with the Public Works Department on the 23rd day of October, 1922, and is hereafter referred to as "the deposited plan." And whereas the objects of this Ordinance cannot be attained without legislative enactment. Be it therefore enacted by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof: -

Short title.

1. This Ordinance may be cited as "The Victoria Nyanza Sugar Company's Tramways Ordinance, 1922."

Interpretation.

- 2. In this Ordinance save where there is something in the context inconsistent therewith, the following terms shall have and include the meanings set against them respectively:—
- 'The Company' shall mean the Victoria Nyanza Sugar Company, Limited, its successors and assigns the owner or owners for the time being of the Farm.
- "The Tramway" and "Subsidiary Trolley Lines" shall mean the tramway and the subsidiary trolley lines authorised by this Ordinance to be constructed and maintained.
- "Road Authority" means the Director of Public Works, or other authority for the time being having control of the public roads affected by the exercise of the powers authorised by this Ordinance.
- "Public Road" shall mean a public road as defined in the Public Travel and Access Roads Ordinance, 1920.

Authority to ecustruct tramway and subsidiary trolley lines. 3. (1) It shall be lawful for the Company to make, construct and maintain a tramway commencing on the farm of the Company situate in the Kisumu District of the Nyanza Province, and running thence in a direction along the line of public travel dedicated as such by Order of the Governor, dated the 1st day of August, 1922, and published in the "Official Gazette" of the 2nd day of August, 1922, pursuant to the provisions of Section 8 (1) of the Public Travel and Access Roads Ordinance, 1920, and terminating at Kibop Railway Station, and also from time to time to make, construct, maintain, remove and replace subsidiary trolley lines running through private lands along the approximate alignments

shewn by green lines on the deposited plan to connect with the tramway shewn by a red line on the said plan for the purpose of transporting sugar cane from neighbouring farms to the Company's

Provided that the tramway and the subsidiary trolley lines shall not exceed in any part thereof a greater space in breadth than fifteen feet, including the supports, abutments and foundations of such tramway and subsidiary trolley lines and shall follow such alignments as the Road Authority shall approve.

- (2) It shall be lawful for the Company to work such tramway and subsidiary trolley lines by steam or other power.
- (1) Wherever the tramway or any subsidiary trolley line Rails to be on runs along any public road it shall, unless the Road Authority same level as shall otherwise approve, be so constructed that the surface of the rails thereof shall, as near as possible, be on the same level as the adjacent portion of the road.

- (2) Wherever the tramway or any subsidiary trolley line crosses any public road at present in existence or hereafter to be established, it shall, unless the Road Authority otherwise approve, be provided with guard rails and filling or other approved device, laid and maintained, so as to permit smooth passage of road traffic to the satisfaction of the Road Authority.
- Whenever the Company shall open or break up any public Completion of road or part thereof for the purposes authorised by this Ordinance works and the Company shall, with all convenient speed, and in all cases of road. within four weeks at the most (unless the Road Authority otherwise consents in writing) complete the work on account of which the Company opened or broke up the same, and fill in the ground and make good the surface, and, to the satisfaction of the Road Authority, restore the said road or part thereof to as good condition as that in which it was before it was opened or broken up, and clear all surplus material and rubbish occasioned thereby; and shall in the meantime cause the place where the road is opened or broken up to be watched and properly lighted at night; and shall bear and pay all reasonable expenses of the repair of the road or part thereof for six months after the same is restored, as far as those expenses are increased by the opening and breaking up.

The Company shall at its own expense, and at all times Repair of part maintain and keep in good condition and repair, with such of public road materials and in such manner as the Road Authority shall direct, way and and to the satisfaction of the Road Authority, so much of any public subsidiary road whereon the tramway or any subsidiary trolley line belonging to the Company is laid as lies between the rails of such tramway or subsidiary trolley line, and in every case so much of the road as extends eighteen inches beyond the rails of and on each side of the tramway or any subsidiary trolley line. If at any time the Company abandons its undertaking and takes up the tramway or any subsidiary trolley line, or any part thereof, the Company shall with all convenient speed, and in all cases within six weeks at the most (unless the Road Authority otherwise consent in writing) fill in the ground and make good the surface, and to the satisfaction of the Road Authority, restore that portion of the public road upon which such tramway or any subsidiary trolley line was laid to as good a condition and with the same class of surface and construction as the adjacent portions of the said public road, and clear away all surplus materials or rubbish occasioned by such work, and leave the area in a tidy and serviceable state to the satisfaction of the Road Authority, and the Company shall in the meantime cause the place where the road is opened or broken up to be watched and properly lighted at night.

where tram-

7. If the Company fail to comply with the provisions of the Power of road last two preceding sections, the Road Authority, if they think fit, authority may at any time, after seven days' notice to the Company, open recover and break up the roads affected, and do the works necessary for expenses. the repair and maintenance or restoration of such roads, to the extent in the two preceding sections above-mentioned, and the expenses incurred by the Road Authority in so doing shall be repaid by the Company on demand by the Road Authority or be recoverable summarily as a civil debt.

Compensation for use of land and damage done. 8. All persons whose lands may be used by the Company its officers, agents or workmen under the provisions of this Ordinance and who shall sustain any loss or damage whatever in the execution of this Ordinance shall be entitled to reasonable compensation for the loss or damage sustained by them and such compensation shall be ascertained, assessed or awarded as hereinafter mentioned. Provided that such compensation shall be claimed within the period of six months of the loss or damage complained of.

Mode of affixing compensation.

9. In all cases in which compensation is claimed it shall be competent to the Company to agree with the claimant for the payment of such sum as the Company may think reasonable and proper and upon such agreement being made the sum so agreed upon shall be paid accordingly and in case the Company and claimant shall not agree as aforesaid the amount to be paid shall be determined by arbitration pursuant to the provisions of the Arbitration Ordinance, 1913.

Saving the rights of His Majesty and other persons not mentioned in this Ordinance.

10. Provided always and be it enacted that nothing in this Crdinance contained shall be deemed to affect or apply to any right, title or interest of His Majesty, his heirs or successors or of any body or bodies politic or corporate or of any person or persons except such bodies politic or corporate and other persons as are mentioned in this Ordinance and those claiming by from or under them.

Commencing at Stone Boundary Pillar No. 67 on the Border between the Colony of Kenya and Tanganyika Territory South of Lake Jipe; thence by a straight line North-east to Trigonometrical Point Vuria (2209) in the Bura Hills; thence by a straight line North to Trigonometrical Point 676 approximately 5 miles North of the junction of the Tsavo and Athi Rivers; thence by a straight line North-east to the point of intersection of Latitude 2° South and Longitude 39° East; thence by a straight line due North-east to a point on the Tana River which is intersected by a straight line drawn from the point of intersection of Latitude 2° South and Longitude 39° East to the point of intersection of Latitude 1° South and Longitude 40° East; thence by the West bank of the Tana River down-stream to the Coast. thence by high water mark along the Coast to the boundary between the Colony of Kenya and Tanganyika Territory; thence by that boundary to the point of commencement; excepting and excluding the following areas:—

- (b) Areas over which beneficial mineral rights are held by lease or otherwise, provided that such rights are recognised by the Government.

ARMISTICE DAY, 1922.

NOTICE.

AT the desire of His Majesty the King a Two Minutes' Silence will be observed throughout the British Empire commencing at 11 a.m., on November the 11th, Armistice Day, in reverent remembrance of the glorious dead who fell during the Great War.

- 2. Arrangements will be made locally throughout the Colony for a ceremony as near as possible on the following lines by the Local Authorities.
- 3. In Nairobi an enclosed Flagstaff and platform will be erected at the junction of Sixth Avenue and Government Road. The 3rd Battalion, King's African Rifles, will form part of a hollow square and provide a Guard of Honour. Government Road and Sixth Avenue being closed at 10-30 a.m., by cordons of Police at convenient distances.
- 4. To the area thus enclosed the Chief Justice and Puisne Judges, Members of Executive and Legislative Councils, Robed Clergy and Soldiers and ex-Soldiers in uniform will be admitted on presentation of a ticket. Space for the public will be found in Government Road on each side of the area and in

Sixth Avenue facing the Flagstaff. Tickets will be issued by the Resident Commissioner. All persons wishing to lay wreaths should take their stand behind and as near as possible to the cordon of Police on the Western side of the area enclosed. Wreaths will be laid during the singing of the Hymn—see Programme below.

- 5. In obedience to His Majesty the King's express desire all present whether in uniform or mufti should wear the medals and decorations to which they are entitled.
- 6. After His Excellency's departure the Police cordons will move towards the Flagstaff enabling a queue to be formed of those desirous of viewing the wreaths laid in honour of the dead.
- 7. A guard of K.A.R. will remain on duty at the Flagstaff post throughout the day and until the wreaths are removed.
- 8. At 6 p.m., the wreaths will be escorted by the K.A.R. Band and Police to the old Cemetery where they will be laid at the foot of the Memorial Cross.
