## AN ORDINANCE.

No. 3 of 1923.

Assented to in His Majesty's name this 6th day of February, 1923.

An Ordinance to amend "The Military Labour Corps Distribution of Pay and Personal Property Ordinance, 1918."

BE it enacted by the Governor of the Colony of Kenya with the advice and consent of the Legislative Council thereof:-

This Ordinance may be cited as "The Military Labour Short title Corps Distribution of Pay and Personal Property (Amendment) Ordinance, 1923, and shall be read as one with the Military Labour Corps Distribution of Pay and Personal Property Ordinance, 1918, hereinafter called "the Principal Ordinance."

2. Section 13 of the Principal Ordinance shall be and is hereby repealed.

An Ordinance to extend the existing Legislative Council of the Colony and Protectorate of Kenya to a date not later than the 20th February, 1924.

BE it enacted by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof:-

- This Ordinance may be cited as "The Legislative Council Short title. (Emergency) Ordinance, 1923," and shall be read with the Legislative Council Ordinance, 1919, hereinafter referred to as The Principal Ordinance."
- 2. Notwithstanding anything contained in the Principal Extension of 2. Notwithstanding anything contained in the Principal existing Ordinance the Legislative Council now existing shall be dissolved council. on the 20th day of February, 1924, unless it shall have been previously dissolved by the Governor by Proclamation and the provisions of the Principal Ordinance shall apply as if the 20th day of February, 1924, were the end of a period of three years from the date of the first election.

## AN ORDINANCE.

No. 5 of 1923.

Assented to in His Majesty's name this 27th day of February, 1923.

An Ordinance to provide for the Registration and Licensing of Land Surveyors; to Control the Practice of such Surveyors, and for other purposes incidental thereto.

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof:—

Short title.

1. This Ordinance may be cited as "The Land Surveyors Ordinance, 1923."

Interpretation.

- 2. In this Ordinance unless the context otherwise requires:
  - (a) "Director" means the Director of Land Surveys.
  - (b) "Board" means the Land Surveyors' Board for Kenya.
  - (c) "Land Surveyor" means a surveyor duly registered and licensed to carry out land surveys under the provisions of this Ordinance.

Application of Ordinance.

3. This Ordinance applies to all surveys in the Colony and Protectorate of Kenya, made for the purpose of preparing any plan for attachment to any instrument of conveyance, lease, assignment or transfer, requiring to be registered under any Registration of Land or Titles Ordinance for the time being in force.

Land Surveyors' Board.

- 4. (1) There shall be a Board of Land Surveyors, which shall consist of:-
  - (a) The Director, who shall be ex-officio Chairman of the Board.
  - (b) At least two Land Surveyors, appointed from time to time by the Governor, on the nomination of the Director, for such period as he may direct.
- (2) The Governor may, on the nomination of the Director, appoint one or more Land Surveyors for the purpose of filling the place of any member or members of the Board who may, through illness or other cause, be unable to attend any meeting of the Board.
- (3) The Board shall conduct the examination of candidates for admission as Land Surveyors, and shall meet at such times and places as may be necessary for the purpose of conducting such examinations and for other duties as hereinafter prescribed by this Ordinance.
- (4) Notice of all appointments to the Board and meetings thereof for examination purposes shall be published in the Gazette.

- Every member of the Board shall take an oath of office oath of office. in the form A in the Schedule to this Ordinance, which may be administered by any Judge of the Supreme Court of the Colony and Protectorate of Kenya.
- The Board may from time to time appoint a Secretary Secretary and other officers. and such examiners and other officers as may be necessary for giving effect to this Ordinance and all such persons shall hold office during the pleasure of the Board.

7. The following persons only shall be entitled to be registered. tered as Land Surveyors under this Ordinance:-

- (a) Persons licensed by the Board as hereinafter set forth.
- (b) Persons duly registered to practise as Licensed Survevors before the enactment of this Ordinance.
- (c) Persons holding a licence to practise as Land Surveyors in the Dominions of South Africa, Canada, Australia, New Zealand, and in such other countries as may be notified in the Gazette by the Governor-in-Council provided that such persons shall appear before and satisfy the Board that they are capable of conducting land surveys in accordance with the provisions of this Ordinance.
- 8. No person unless duly registered as a Land Surveyor Unqualified shall survey any land for the purpose of preparing any plan for bidden to attachment to any instrument of conveyance, lease, assignment survey. or transfer, requiring to be registered under any Registration of Land or Titles Ordinance for the time being in force.

Except as hereinafter provided no person shall be resons entitled a examination. entitled to be examined for a licence as a Land Surveyor unless:-

- (a) he has previously served regularly and faithfully, for a period as required by the Board, with a Land Surveyor licensed in this Colony or in one of the countries set forth in Section 7 (c) of this Ordinance;
- (b) produces an affidavit from such Land Surveyor in form B of the Schedule to this Ordinance; or if for some good and valid reason the Surveyor's affidavit cannot be produced unless:-
- (c) he produces such evidence of service as the Board may require.
- 10. Any person who:—

Exemptions.

- (a) has graduated from any University recognised by the Board and shall have taken a degree in Engineering,
- (b) is a Corporate Member of the Institution of Civil Engineers,

shall be entitled to an examination for a licence, and shall be exempt from examination on all subjects which, in the opinion of the Bourd, may be unnecessary, provided that such person produces affidavits in forms B and D of the Schedule to this Ordinance.

11. Each application for examination as prescribed in the Form of application for Ordinance shall be made to the Secretary in writing at least one examination. month previous to the date on which such examination is to take place, and such application shall be accompanied by:-

- (a) " information required by this Ordinance:
- (b) an examination fee of Five Pounds, which fee shall be refunded if the application for examination be disallowed;

fees under this section shall be paid over, by the Secretary, to the Colonial Treasurer.

The Board may require the attendance of any person Examining who applies for examination as prescribed by this Ordinance and candidate on cartin may examine or question such person upon oath, affirmation or otherwise as to his actual practice in the field and other matters relevant thereto. For such purposes any member of the Board may administer an oath or affirmation.

Conditions precedent to iesus of

- 13. Except as otherwise provided in this Ordinance no person shall receive a licence from the Board authorising him to practise as a Land Surveyor until:-
  - (a) he has attained the age of twenty-one years, and,
  - (b) has complied with the general requirements of this Ordinance, and
  - (c) has passed a prescribed examination to the satisfaction of the Board.

Issue of Moence.

Every person who qualifies in the manner prescribed by this Ordinance shall be entitled to receive a licence from the Board in form C in the Schedule to this Ordinance constituting him a Land Surveyor.

Register of Land Surveyors.

15. The Board shall cause a register to be kept which shall contain the names, addresses and qualifications of all Land Surveyors, the respective dates of registration and any other particulars as may be required.

- 16. (1) Upon a charge duly made and after enquiry, if it is shown with respect to any Land Surveyor that:—
  - (a) he has certified to the accuracy of any survey, knowing the same to be inaccurate, or has negligently certified as aforesaid, without having taken reasonable precautions to verify the accuracy thereof; or
  - (b) he wilfully or by culpable negligence has made, or caused to be made under his immediate supervision, any survey which is so inaccurate or defective as to be unreliable; or
  - (c) his licence has been obtained by misrepresentation; or
  - (d) after registration under this Ordinance he has been convicted of any misdemeanour or crime; or
  - (c) he has certified as his own any survey not made by himself or under his personal supervision; or
  - (f) he has been guilty of such improper conduct as in the opinion of the Board renders him unfit to practise as a Land Surveyor; or
  - (g) his licence or registration, in any country as set forth in Section 7 (c) of this Ordinance, has been suspended or cancelled in such country.

The Board may: -

- (i) erase the name of such Land Surveyor from the register; or
- (ii) suspend such Land Surveyor from practice as a surveyor for any period not exceeding three years, and enter the reasons for such suspension in the
- (iii) caution such Land Surveyor, and if the Board thinks fit, order him to pay the cost of any correction of an error, and the whole or any part of the cost of the enquiry.
- (2) The Board may reinstate a Land Surveyor whose name has been erased from the register or who has been suspended from practice.
- (3) The erasure of a Land Surveyor's name from the register, his suspension from practice, or his re-instatement, shall be notified in the Gazette.

- 17. (1) Every charge against a Land Surveyor under the Charge against 17. (1) Every charge against a Land Surveyor under the Land Surveyor; last preceding Section shall be submitted to the Board in writing now dealt with. signed by the person making the charge: and, if it appears to the Board that such charge justifies an enquiry, the Board shall fix a time and place for that purpose.
  - (2) At least thirty days prior to the date fixed for such enquiry, notice in writing by registered post shall be sent by the Secretary to the last known postal address of the Land Surveyor so charged, informing him of the time and place fixed for the enquiry, and supplying him with a copy of all charges made.

- (3) At such enquiry the Land Surveyor charged shall be entitled to be heard in his defence either personally or by an
- (4) The finding and decision of the Board on such enquiry shall be given in writing, and shall be signed by at least two members of the Board, and shall be countersigned by the Secretary, and such writing shall be conclusive evidence of the matters therein contained and of the decision of the Board, which shall be final.
- (1) Any Land Surveyor when engaged in the perform- Surveyor way ance of his duties may, with such other persons as may be lands, authorised by him, enter upon any land and may do all things necessary for the proper performance of such duties.

- (2) This Section, however, shall not exempt any Land Surveyor from liability for any damage he may commit.
- All surveys under this Ordinance shall be carried out, in every particular, in accordance with the Regulations for the time being in force as issued by the Board.

Surveys to be carried out in accordance with regulations for the time being in force.

Jonfirmation of

- (1) The confirmation by the Director of the plan of any surveyed land shall be held to be a confirmation of the survey or re-survey as the case may be, and the confirmed plan shall be the official plan but no land shall be deemed to have been surveyed or re-surveyed until the plan thereof has been confirmed by the
  - (2) No plan shall be confirmed:-
    - (a) until such plan has been compared with the field notes and computations, lodged with the Director by the Land Surveyor making such survey, and found to be correct; and
    - (b) unless such survey shall have been conducted as prescribed in the preceding Section of this Ordinance.
- 21. (1) The Reard, with the approval of the Governor-in-Council, may made appulations for all or any of the following purposes, paraciti-

Coneral cegulations and dusics of the loserd.

- (a) requiring the meetings and procedure of the Board and the conduct of the business thereof: the election of a member to perform the duties of the Chairman and est as Denuty Chairman during the Illness or absence of the Chairman;
- (b) prescribing the duties of the Secretary and other officers as may be appointed under Section 6 of this Ordinanco;
- (c) regulating the manner of keeping the register, and the particulars to be entered therein;
- (d) varying any of the forms in the Schedule to this Ordinance or to any Ordinance amending it;
- (e) determining the evidence to be produced and conditions to be fulfilled by any person applying for a registration as a Land Surveyor under this Ordinance;
- (f) prescribing the syllabus of subjects of examination for persons desirous of qualifying for a licence, and the period of previous service and training required;
- (g) regulating the issue of licences;
- (h) prescribing what certificates of examination will be recognised by the Board as a substitute for the examinations of the Board;
- (i) prescribing what certificates, diplomas, degrees, licenses and other titles will be recognised by the Board for purposes of exemption;
- (i) regulating the conduct of proceedings in connection with charges against Land Surveyors;
- (k) for the direction and guidance of Land Surveyors;
- (1) generally for carrying into effect the objects of this Ordinance.
- (2) A regulation may impose a penalty not exceeding Twenty Pounds for any breach thereof.

22. The enactments mentioned in the Schedule hereto are hereby repealed, but such repeal shall not affect any matters and things lawfully done thereunder.

1. This Ordinance may be cited as "The Mohammedan Marriage, Divorce and Succession (Amendment) Ordinance, 1923, and shall be read as one with the Mohammedan Marriage, Divorce and Succession Ordinance, 1920, hereinafter referred to as the Principal Ordinance.

Amendment of Section 3 Sub-section 2 of the Principal Ordinance.

Section 3 sub-section 2 of the Principal Ordinance is hereby amended by the deletion of the word "domiciled" where it last appears therein and by the substitution therefor of the word resident."

## An Ordinance to amend The Registration of Titles Ordinance, 1919.

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof:

Short title.

1. This Ordinance may be cited as "The Registration of Titles (Amendment) Ordinance, 1923," and shall be read as one with the Registration of Titles Ordinance, 1919, (hereinafter referred to as "The Principles Ordinance,") and the Registration of Titles (Amendment) Ordinance, 1920.

Amendment of Section 1 of the Principal Ordinance.

- Section 1 of the Principal Ordinance is hereby amended by the insertion of the following sub-section after sub-section (2) thereof:
  - "(3) The Governor may by order published in the Gazette apply this Ordinance to any area in the Colony and

3. Part III of the Principal Ordinance shall be deemed to Part III of the have come into operation in the Coast District comprising the Provinces of Seyidie, Tanaland and Jubaland on the 1st day of November, 1920.

Amendment of Section 34 of the Principal Ordinance.

4. Section 34 of the Principal Ordinance is hereby amended by the deletion of the words "may execute" and by the substitution therefor of the words "shall execute, in original only." The words "and such transfer, if it be endorsed on the instrument evidencing the title of any transferor, need not be issued in duplicate" are hereby repealed.

At the end of Section 49 of the Principal Ordinance there shall be added the following provisoes:-

the Principal Ordinance.

Provided that,

- (1) A Power of Attorney executed in due and customary form and giving sufficient powers in the opinion of the Registrar shall, at his discretion, be registerable in like manner as though executed in the said Form M.
- (2) A Power of Attorney registered before the date of this Ordinance in accordance with the provisions of the East Africa Registration Regulations, 1901, or the Crown Lands Ordinance, 1915, shall be deemed to be duly registered for the purposes of this Section provided that it shall have been so registered prior to any act thereunder being effected in respect to land registered under this Ordinance; but nothing in this Section contained shall make valid a power otherwise invalid, or any transaction under it, by reason of such action.
- 6. The words "unless signed under any then outstanding Amendment of registration abstract" in Section 50 of the Principal Ordinance are hereby repealed. At the end of the said Section there shall ordinance. be added the following provisoes:--

Provided that,

- (1) A Revocation executed in due and customary form shall, at the discretion of the Registrar, be registerable in like manner as though executed in Form N.
- A Revocation of any Power of Attorney referred to in Section 49 (2) shall be registered in accordance with the provisions of the Ordinance under which such Power of Attorney is registered.
- At the end of Section 57 of the Principal Ordinance Amendment of there shall be added the following proviso:-

"Provided that the provisions of this Section shall not Ordinance. apply to any instrument executed by the Governor, or any duly registered company by means of its common seal affixed in the presence of the Secretary and two or more directors."

ADDITIONAL INSTRUCTIONS passed under the Royal Sign Manual and Signet to the Governor and Commander-in-Chief of Colony of Kenya in regard to the duration of the Legislative Council thereof.

Dated 5th February 1923.

ADDITIONAL INSTRUCTIONS to Our Governor and Commander-in-Chief in and over Our Colony of Kenya, or other Officer for the time being administering the Government of Our said Colony.

Whereas by Letters Patent under the Great Seal of Our United Kingdom of Great Britain and Ireland bearing date the Eleventh day of September 1920 We did constitute order and declare that there should be a Governor and Commander-in-Chief (therein and hereinafter called the Governor) in and over Our Colony of Kenya (therein and hereinafter called the Colony):

Recites Letters Patent of 11th September

And whereas We did thereby authorise, empower and command the Governor to do and execute all things that belong to his said office, according to the tenour of Our said Letters Patent and of any Orders in Council relating to the territories formerly known as the East Africa Protectorate, save in so far as any provision of any such Order in Council might be repugnant to any of the provisions of Our said Letters Patent, and of such Commission as might be issued to him under the Royal Sign Manual and Signet, and according to such Instructions as might from time to time be given to him under the Royal Sign Manual and Signet, or by Order in Council or by Us through one of Our Principal Secretaries of State, and to such laws as were then or should thereafter be in force in the Colony:

Recites instructions of 11th September 1920 and additional instructions of 11th February 1922. And whereas We did issue to the Governor certain Instructions under Our Sign Manual and Signet bearing date the Eleventh day of September 1920 providing amongst other things for the constitution of the Legislative Council of the Colony and certain Additional Instructions bearing date the Eleventh day of February 1922 making further and other provision in regard to the constitution of the said Legislative Council.

And whereas by the Thirty-first Clause of Our aforesaid Instructions of the Eleventh day of September 1920 We did direct that the Governor should dissolve the Legislative Council at the expiration of three years from the date of the last preceding general election if it should not have been sooner dissolved:

And whereas it is expedient that the duration of the Legislative Council in being at the date of these Our Additional Instructions shall be extended beyond the period of three years from the last preceding general election, held on the Twenty-first day of February 1920:

Now Therefore We do by these Our Additional Instructions under Our Sign Manual and Signet revoke, as from the date hereof, the Thirty-first Clause of Our Instructions of the Eleventh day of September 1920, but without prejudice to anything lawfully done thereunder, and We do hereby declare Our Will and pleasure that the aforesaid Instructions of the Eleventh day of September 1920 shall henceforth be construed and take effect as if the following Clause had been inserted therein in place of the Thirty-first Clause thereof:

Duration of Legislative Council.

"XXXI. The Legislative Council now existing shall be dissolved on the Twentieth day of February 1924 unless it shall have previously been dissolved by the Governor by proclamation, and after such dissolution the Governor shall dissolve the Legislative Council at the expiration of three years from the date of the last preceding general election if it shall not have been sooner dissolved."

## THE PUBLIC HEALTH ORDINANCE, 1921.

#### REGULATIONS.

IN EXERCISE of the powers conferred upon him by the Public Health Ordinance, 1921, His Excellency the Governor has been pleased to make the following Regulations.

These Regulations may be cited as "The Public Health (Port Health) Regulations, 1923."

Duties of Port Health Officer.

2. The Port Health Officer shall be responsible, subject to the instructions of the Principal Medical Officer, for the medical and health inspection of and the granting of pratique to, or the taking of such health measures or precautions as may be necessary in connection with, all vessels arriving at a port; for the sanitary and health supervision of vessels at a port and of a port area and harbour for the proper surying out and enforcement on vessels at a port and throughout a port area and harbour, of measures for the destruction of redents, for preventing the multiplication or migration of rodents, and for ensuring the prompt discovery and investigation of any sickness or mortality among them possibly due to plugue; for the direction and control of the sanitary or other staff employed at the port by the Medical Department; and for the proper carrying out or enforcement of the provisions of the Public Health Orlinance, 1921, hereinafter referred to as "the Orlinance," and the Regulations thereunder in Ordinance," and the Regulations thereunder in espect of vessels, passengers, crows, and cargoes at a port and of a port area and harbour. He shall carry out his duties so as to obviate unnecessary delay or detention of vessels, passengers, or merchandise, and in matters which also affect the Administration of the Railway or a Harbour or any other Government Department, or the Local Authority at or adjoining a port, shall act in consultation and co-operation with the officers concerned.

Duties of Agents.

3. Agents of vessels shall as early as possible give notice in writing to the Port Health Officer of the expected arrival of every vessel. Such notices shall be given in the form shewn in Schedule A appended hereto.

Procedure in granting Pratique.

4. The Master of every vessel anchoring off or arriving at any port or place in the Colony and Protectorate shall, immediately on the arrival of such vessel at the outer anchorage or roadstead thereof, hoist or cause to be hoisted at the foremast head of such vessel when it is possible to do so, otherwise in the most conspicuous position available and clear of any other flags, the flag known as flag Q, being a yellow flag of six breaths of bunting, and shall keep the flag flying there until pratique has been granted as provided under these Regulations. As soon as pratique has been granted the Port Health or other

duly authorised officer so granting it shall order the said flag to be lowered, and for the purpose of these Regulations the granting of pratique shall be signified by the lowering of the said flag.

Restricted Pratique.

5. Where restricted pratique has been granted to any vessel under Section 62 of the Ordinance, the Port Health Officer shall specify, in writing, to the Master thereof the conditions and restrictions imposed and the Master shall cause a copy thereof to be posted up in a conspicuous place on such vessel. Failure or refusal on the part of the Master or any other person to observe or comply with any such condition or restriction shall constitute a contravention of these Regulations, and, in addition, the Port Health Officer, if he deems it necessary for safeguarding the public health, may place such vessel in quarantine.

# Declaration of Health.

6. The Master of every vessel anchoring off or arriving at any port or place in the Colony and Protectorate, upon being furnished by the Port Health or other duly authorised officer, with a declaration of health in the form shown in Schedule B hereto shall properly fill up and sign such declaration, shall obtain the countersignature thereon of the Ship Surgeon, if any, and shall return the declaration, so filled up and signed, to such duly authorised officer. The Port Health Officer may require the Master of any vessel formally to affirm or attest such declaration on oath.

Masters and Officers of vessels to give information and assistance.

7. The Master and every Ship Surgeon, if any, and other officers and persons on any vessel shall give all such assistance and information to the Port Health or other duly authorised officer as may be required by such officer in earrying out any duty under these Regulations. Any such officer may at any time for the purpose of these Regulations board, or enter any part of, or examine any article or thing on board of or landed from any such vessel, and the Port Health Officer may require that such vessel's log-book or any records or papers be submitted to him for inspection.

#### Masters of vessels to furnish list of Passengers.

8. The Port Health Officer may require the Master of any vessel having or suspected of having on board the infection of any infectious disease, or which has recently touched at any port or place which is a proclaimed place or is infected with any formidable epidemic disease or is situated near any place which is so infected, to furnish in respect of such vessel—

(a) A list of all passengers or of passengers of any specified description or class on board, and showing in respect of each passenger the name, sex, race, and age, the port of embarkation, port of disembarkation, destination, and, where possible, address, thereat;

(b) A list of the crew, giving name, race, and rating of each member;

(c) A list of all cargo, or cargo of any specified class or description, showing its nature, port of shipment, destination, and the name and address of the consignee.

## Quarantining of vessels.

9. Where the infection of plague, cholera, yellow fever, small-pox, epidemic influenza, or other infectious disease exists or is suspected to exist in any person, animal, or thing on board of any vessel, and

where the Port Health Officer, acting in accordance with the general or special instructions of the Principal Medical Officer, considers that the public health cannot otherwise be adequately safeguarded, he may notify the Master of such vessel of the intention of placing such vessel in quarantine or of requiring him to remove such vessel in quarantine to another port or to the sanitary anchorage at Zanzibar, for the purpose of dealing with such infection, provided that no officer other than the Port Health Officer, Mombasa, shall require the removal of a vessel from any port to any other port or to the sanitary anchorage at Zanzibar except with the previous approval of the Principal Medical Officer. Unless the Master declines to submit to quarantine or refuses to remove such vessel as aforesaid and elects to leave the port as provided in Section 66 of the Ordinance, the Port Health Officer shall then place such vessel in quarantine and in conjunction with the Port Captain shall fix the place of mooring of such vessel. The Master of every vessel in quarantine shall cause the quarantine flag, namely, that known as flag L, being a large flag of yellow and black, borne quarterly, to be flown between sunrise and sunset, at the foremast head of such vessel when it is possible to do so, otherwise in the most conspicuous position available and clear of any other flags, and to be shown between sunset and sunrise at the peak of such vessel or other conspicuous place where it can best be seen, and at a height of not less than 20 feet above the hull of such vessel, a night signal consisting of three lights which shall be arranged at a distance of not less than six feet apart in the form of a equilateral triangle of which the light at the apex of the triangle shall be white and the other lights at the ends of the base shall be red

Prohibition of communication between unauthorised persons and vessels in Quarantine.

10. Except in case of danger no Master of a vessel in quarantine shall, or shall allow any person on board to, leave such vessel or send any article or thing ashore or to any other vessel or any boat, or communicate with the shore or with any other vessel or any boat, and no person from the shore or from any other vessel or boat shall communicate or attempt to communicate with such vessel otherwise than by signal. Nothing in this Regulation shall prevent the Port Health or other duly authorised officer from coming alongside or boarding such vessel.

Quarantine of prohibited Immigrants.

11. (a) Whenever the Port Health Officer lands in quarantine any person who has not been granted authority to enter the Colony and Protectorate after examination by an Immigration Officer under any law relating to the restriction of immigration in force for the time being, he shall immediately inform such Immigration Officer of the name of such person, the name of the vessel by and the port at which he arrived and the place of detention.

(b) The Port Health Officer shall give such Immigration Officer and the Master and Agents of such vessel due notice in advance of the release of such person from quarantine, and upon being so released, such person shall revert to the custody of the Master and Agents of such vessel and shall be subject to the order of such Immigration Officer.

(c) All expenses incurred in connection with the detention and maintenance (including expenses of escort and identification) of such person until permitted to enter the Colony and Protectorate, and with his repatriation in the event of his being declared a prohibited immigrant, shall be payable by the Master or Owner of such vessel, and noth-

ing in these Regulations contained shall be construed as relieving them of any liability imposed on them under any law for the restriction of immigration in force for the time being. Such expenses shall be recoverable as a civil debt recoverable summarily.

Quarantine restrictions.

12. The boundaries of every place of isolation on shore which may be established under these Regulations shall be demarcated by a fence or otherwise. Any person leaving or attempting to leave such place without due authority shall be liable to the penalties provided for a contravention of these Regulations. Any person escaping or attempting to escape from any vessel in quarantine or from any place of isolation may be arrested and taken back thereto by any guard or any member of the police, who may use any force necessary for so doing.

Orders of Quarantine. Medical Officer.

13. Any Port Health Officer or Medical Officer-incharge of any vessel in quarantine or of any place of isolation on shore may give such orders or instructions as he may deem necessary for safeguarding the health of the persons so isolated or the public health. Any person failing or refusing to carry out or comply with any lawful order or instruction so given shall be liable to the penalties provided for a contravention of these Regulations.

Masters to carry out orders of Port Health Officer.

14. The Master of any vessel in quarantine or having on such vessel any person suffering, or suspected to be suffering, from any infectious disease shall carry out the orders of the Port Health Officer as regards the isolation of such persons, disinfection, or otherwise.

Quarantined vessels to be dealt with and released with all despatch.

15. Outbreaks of or the infection of any infectious disease on board vessels in quarantine shall be dealt with; infected persons, and persons who have been specially exposed to infection and who may be incubating a disease, shall be, where possible, removed to and isolated on shore, and the infection eradicated with all possible despatch. No vessel shall be detained in quarantine after the removal therefrom of all persons infected or suspected to be infected, and the eradication of infection on board by disinfection, deverminization or other special measure.

Cholera infected vessels; special precaution.

- 16. In the case of any vessel having or suspected of having the infection of cholera on board, the Port Health Officer may, by written notice, require the Master of such vessel to—
  - (a) Pump out all bilge water, drinking water, and water ballast from such vessel at such place as he, in consultation with the Port Captain, shall fix
  - (b) Cleanse and disinfect, to the satisfaction of the Port Health Officer, all water tanks and receptacles for water on such vessel;
  - (c) Provide such vessel with a fresh supply of pure water;
  - (d) Take any other practicable measure, which may be specified in such notice for preventing the spread of or eradicating the infection, or for preventing the pollution of the staters of a port with human excreta or any infectious matter:

Prevention of Migration of Rodents.

- 17. The Port Health Officer may, by written notice, require the Master of any vessel in any port or harbour of the Colony and Protectorate—
  - (a) To close and render impassable to rats and mice all openings or holes in the side of such vessel which is contiguous to any wharf, lighter, or other vessel:
  - (b) To affix an effective rat shield or screen and parcelling to be freshly tarred each day, not less than three feet or more than five feet from the side of such vessel, to every rope or hawser connecting the vessel to any wharf, mooring appurtenance, lighter, or other vessel;
  - (c) Between the hours of sunset and sunrise, either to remove every landing stage or gangway between such vessel and the wharf, lighter, or other vessel, or, except when any such appliance is actually in use, to station a watchman at its inboard and to prevent migration of rodents;
  - (d) To take any other practicable measures specified in such notice to prevent the migration of rodents to or from such vessel or for the destruction of rodents on board of the vessel.

Should the Master of such vessel fail or refuse to carry out or comply with, to the satisfaction of the Port Health Officer, any requirement lawfully made under this Regulation, he shall be liable to the penalties provided for a contravention of these Regulations, and the Port Health Officer may, by written notice issued after consultation with the Port Captain, order that such vessel be forthwith removed from the vicinity of any wharf, lighter, or other vessel and moored in the stream or in such other position as may be specified in such notice.

The Principal Medical Officer may, by notice in the Gazette, apply all or any of the requirements of this Regulation to all vessels, or any specified class or description of vessel, at any port of the Colony and Protectorate.

Disinfection of vessels in certain cases.

18. In the case of any vessel having or suspected of having the infection of plague on board, the Port Health Officer may cause such vessel to be disinfected or deverminized by the Clayton (sulphur gas) for any other process appropriate for the purpose.

Disinfection of dirty or verminous persons, clothing or articles.

- 19. The Port Health Officer may-
- (a) Medically examine any person before or after landing from any vessel; and any person who refuses to submit to medical examination when so required by the Port Health Officer shall be liable to the penalties provided for a contravention of these Regulations.
- (b) Inspect and examine the clothing, bedding or other effects of any such person;
- (c) Detain and cause to be cleansed or disinfected or deverminized any dirty or verminous person, or any dirty or verminous clothing or bedding or other article or thing. If any such article or thing is of such a nature that it cannot be cleansed or disinfected or deverminized to his satisfaction he may, with the previous concurrence of the Principal Medical Officer, or if the reputed value of the article does not exceed ten pounds (£10) without such concurrence, order or cause it to be destroyed.

Disinfection of used clothing, etc.

- 20. (1) Every consignment (exclusive of the personal effects of travellers) of bedding, blankets, body linen, or other articles of clothing which have been in use, or any rags, or flock made of rags, or any used sacks, carpets, or canvas, or any similar article which has been in use, and which is landed at any port of the Colony and Protectorate shall be declared as such to the customs at the port, and a certified statement submitted showing the place of origin and precise composition of the consignment.
- (2) Every such consignment or any portion thereof, intended for sule or disposal in the Colony and Protectorate shall be accompanied by a sufficient certificate furnished by a recognised public authority at the port of shipment or place of origin of the package, to the effect that the articles mentioned therein are clean and have been sufficiently disinfeeted to the satisfaction of such authority, and stating in detail the method of disinfection and the apparatus used, together with a certificate or other satisfactory evidence that since the issue of the certificate of disinfection the package has not been opened nor its contents in any way added to or tampered with. Every such consignment, whether accompanied by the above-mentioned certificates or not, shall be detained by the Customs pending its inspection or examination by the Port Health Officer or by any person authorised by him to carry out such inspection or examination.

For the purpose of carrying out such inspection or examination, the Port Health Officer or person authorised by him may open any such consignment or require the opening of such consignment by the consignee or owner thereof.

For the purpose of this Regulation "efficient disinfection" means disinfection by steam under pressure in a suitable apparatus, or other process which can be relied upon to destroy any infection or any vermin. Fumigation with hydrocyanic acid gas shall not be accepted unless some reliable germicidal process has also been carried out.

- (3) Failing the production of satisfactory certificates as mentioned in clause (2) hereof, or if, despite the production of such certificates, the articles are found to be dirty or uncleansed, the whole of such consignment shall be disinfected at the port of entry by, or to the satisfaction of, the Port Health Officer, and at the sole expense, risk, and delay of the consignee.
- (4) Where a consignment or any part thereof is of such a nature that it cannot, in the opinion of the Port Health Officer, be satisfactorily disinfected, the Port Health Officer may destroy or order the destruction of the whole or any part of such consignment, provided that the Port Health Officer shall not destroy or order the destruction of any part of a consignment where the goods to be destroyed are of greater value than £10 without the previous sanction in writing of the Principal Medical Officer and provided further that where the destruction of goods of a greater value than £10 may be required, such destruction shall not be carried out if the owner or consignee shall undertake to re-export and shall so re-export the said goods within a period of four weeks of the date of the order to destroy.
- (5) Consignments intended for places outside the Colony and Protectorate if unaccompanied by the certificates mentioned in clause (2) hereof, may be landed under such guarantees as the Commissioner of Customs may from time to time require that such consignments will be conveyed to the assigned destination outside the Colony and Protectorate, and that no bale, case, or package will be opened or any of the articles unpacked, disturbed or dealt with or disposed of in the Colony and Protectorate. Provided that if the Government of any East African Territory requests the Government of the Colony and Protectorate.

torate to apply the provisions of this Regulation to all such articles consigned to places within its territory, the same requirements shall be enforced in respect of all such articles as if the articles had been consigned to a place within the Colony and Protectorate.

- (6) The recognised authority for granting the certificate of disinfection mentioned in clause (2) hereof shall be—
  - (a) The Port Health or Sanitary Authority of any British port at which the consignment has been shipped; or
  - (b) The Local Health or Sanitary Authority for any area in the British Islands or British Colonies at which the goods have been packed; or
  - (c) The Port Health or Sanitary Authority, or the Municipality or other Local Health Authority at any foreign port, or at any place abroad at which the goods have been packed, provided that the certificate thereof has been verified and countersigned by a British Consul.
- (7) All charges for any disinfection carried out by the Medical Department under these Regulations shall be paid by the owner or consignee or his agent who shall also be responsible for any transport, unpacking, repacking or rebaling which may be required with regard to the articles to be disinfected, inspected or examined.

Disinfection and destruction of articles.

21. The Port Health Officer may-

(a) Cause any article or thing on board of or landed from any vessel and contaminated, or suspected to be contaminated, with the infection of any infectious disease, to be disinfected. Such disinfection shall be carried out with all possible despatch and so as to avoid as far as possible any injury to the articles or things disinfected;

Prohibit the landing from any vessel of any article or thing contaminated, or suspected to be contaminated with the infection of any infectious disease until the same has been disinfected to his satisfaction, provided that any article or thing may be landed for the purpose of disinfection with the permission in writing of the Port Health Officer and subject to such conditions and restrictions as may be specified thereby. Where owing to its nature or other circumstances any such article or thing cannot, in the opinion of the Port Health Officer, be satisfactorily disinfected, such officer may, with the previous concurrence of the Principal Medical Officer, or, if the reputed value of such article or thing does not exceed ten pounds (£10), without such concurrence, altogether prohibit its landing, or cause it to be destroyed by or at the cost of the Master of such vessel. Mail matter (not including parcels conveyed by post) contained in clean and intact bags or packages shall not be liable to disinfection.

Port Health Officer to give certificate of disinfection on request.

22. When any measures have been taken by the Port Health Officer for the removal or eradication of infection from any vessel, the Port Health Officer, when so requested by the Master or Owner or Agent of such vessel, shall furnish him with a certificate stating the measures taken and the reasons therefor, or shall enter those particulars on the Bill of Health to be furnished to the Master of such vessel before leaving port.

Destruction of unsound food or drink.

23. The Port Health Officer or other person duly authorised by the Port Health Officer in writing, may

inspect and examine, detain, seize, or remove for the purpose of examination any article of food or drink on board of any vessel or within any port or harbour area, and if the Port Health Officer be of opinion that the same is diseased or unsound or unwholesome, or infected or contaminated, or otherwise unfit for human consumption, he may order it to be treated or disposed of so as not to endanger health, or he may, with the previous concurrence of the Principal Medical Officer or, if the reputed value of such article does not exceed ten pounds (£10), without such concurrence, order or cause it to be destroyed. Any expenses incurred in connection with such treatment or disposal or destruction shall be payable by the owner of such article or his agent. Such expenses shall be recoverable as a civil debt recoverable summarily.

Masters of vessels required to maintain cleanliness and to prevent nuisances being committed.

No Master of a vessel shall cause or permit any manure, excreta, or refuse of any kind to be thrown overboard from such vessel in any harbour so as to constitute a nuisance in the opinion of either the Port Health Officer or the Port Captain, but shall cause all such things to be removed to a place set apart for disposed of as the the purpose, or otherwise Port Health Officer may Carcases of dead animals, offal, and other offensive things shall be kept separate, and shall be separately disposed of. Where any cattle ship or other vessel is in a filthy condition, or has a large quantity of manure or other offensive matter on such vessel, the Port Health Officer, after consultation with the Port Captain, may require the Master to remove such vessel to a specified distance beyond such harbour area and outer anchorage and there cleanse such vessel.

Nuisances on board vessels.

25. No Master of a vessel shall cause or permit any nuisance or danger to health to exist on such vessel. Should any such nuisance or danger to health arise, the Port Health Officer may require the Master to remedy it forthwith and to take such measures as he may specify for preventing its recurrence. Failure or refusal to carry out properly such requirement shall be a contravention of thes Regulations, and in addition the Master may be required to remove such vessel from harbour until such nuisance or danger to health shall have been remedied.

Nuisances in Harbours, Roadsteads, or Port Areas.

23. Where any nuisance is caused by any article or any carcase within any harbour, roadstead, or port area, the Port Health Officer may require the owner thereof or his agent or consignee or any other person responsible forthwith to remove the nuisance. If such person fails to do so, or cannot be found, the Port Health Officer, after consultation with the Commissioner of Customs, or Port Captain, may order or cause the nuisance to be removed, and, if necessary for that purpose, may cause such article or carcass to be destroyed. Any expenses incurred in so doing shall be payable by the owner of such article or carcass or his agent or such other person responsible. Such expenses shall be recoverable as a civil debt recoverable summarily.

Prohibition of nuisances.

27. No person shall commit a nuisance or foul any public latrine or urinal within any port or harbour area.

Vaccination of person exposed to Small-pox infection.

- 28. The Port Health Officer may require the vaccination of any person on board of any vessel who, in his opinion, may have been recently exposed to the infection of small-pox and who does not produce evidence to his satisfaction of successful vaccination against small-pox during the five years immediately preceding, provided that any such person may—
  - (a) Be vaccinated, free of charge, by the Port Health Officer with calf vaccine lymph; or

(b) At his own expense, employ any medical practitioner to perform such vaccination; or

(c) Be exempted from such vaccination if considered by the Port Health Officer not to be in a ft state of health to undergo vaccination.

Any person who fails to comply with any instruction or requirement lawfully issued or made under this Regulations shall be liable to the penalties provided for a contravention of these Regulations, and, in addition, the Port Health Officer may prohibit the landing of such person.

Prohibition of embarkation of injected persons or articles.

99. The Port Health Officer may-

- (a) Medically examine any person before or inter boarding any vessel, and may prohibit the embarkation or order the removal ashore of any person suffering or suspected to be suffering from any infectious disease, or any dirty or verminous person. Any person who refuses to submit to uedical examination when so required by the Port Health Officer shall be liable to the penalties provided for a contravention of these Regulations;
- (b) Inspect, detain, or cause to be disinfected or deverminized, or prohibit the embarkation of any article or thing which is or is suspected to be contaminated with the infection of any infectious disease, or which is dirty or verminous. If such article or thing is of such a nature that it cannot be disinfected to his satisfaction he may, after obtaining the concurrence of the Principal Medical Officer, cause it to be destroyed.

Rids of Health.

30. The Port Health Officer shall on payment of a fee of fifteen shillings and on receipt of the application form shown in Schedule C duly filled in furnish in respect of any vessel leaving his port a bill of health in the form shown in Schedule D hereto. The Port Health Officer shall enter therein such particulars as to the existence or non-existence of infectious disease, at or in the vicinity of such port, as the Prneipal Medical Officer may from time to time instruct. Where plague, Asiatic cholera, yellow fever, typhus fever, small-pox, or other formidable epidemic disease exists at or in the vicinity of such port, particulars thereof and of the precautions and measures taken to prevent the spread of or eradicate the infection shall be so entered.

Recovery of expenses.

- 31. (1) All expenses incurred by the Government of the Colony and Protectorate—
  - (a) In dealing with any person who is on a vessel or has recently been landed therefrom and who is suffering, or suspected to be suffering, from any infectious disease or from scurvy, beri-beri, dysentery, or other disease which the Governor may have notified in the Gazette; or
  - (b) In connection with the detention in quarantine of any vessel infected with, or the isolation, accommodation, care and treatment of any person suffering from or who has been exposed to the infection of any infectious disease; or

(c) In eradicating the infection of any infectious disease in any vessel, or in any article or thing on board of any vessel, or in any article or thing which although landed therefrom, was infected before it was landed:

shall be payable by the Master, Owner or Agent of such vessel and shall be recoverable as a civil debt recoverable summarily.

(2) Before carrying out any service mentioned in clause (1) hereof, the Port Health Officer may require the Master, Owner or Agent of such vessel to furnish satisfactory security or guarantee in respect of payment therefor, or, if the service be one in respect of which there is a tariff charge, may require payment of such charge in advance.

Penalties.

- 32. (1) Any person who contravenes or fails to comply with any provision of these Regulations or any instruction or requirement lawfully issued or made thereunder, or who obstructs or hinders any Port Health Officer or other duly authorised officer in the execuion of his duties thereunder, or who fails or refuses to give any information which he is lawfully required by any such officer to give, or who gives to any such officer false or misleading information, knowing it to be false or misleading, shall be liable, save as provided in clause (2) hereof, to a fine not exceeding fifty pounds (£50) or to imprisonment of either description without the option of a fine for a period not exceeding three months, or to both such fine and imprisonment.
- (2) If the Master of a vessel contravenes or fails to comply with any provision of these Regulations relating to pratique or quarantine, or make any false statement or false answer to any question in any declaration of health, knowing the same to be false, he shall be liable to a fine not exceeding two hundred pounds (£200) or to imprisonment of either description without the option of a fine for a period not exceeding twelve months, or to both such fine and imprisonment.
