IT is notified for public information that the restrictions on the importation of citrus trees from Southern Rhodesia, and the Cape and Natal Provinces, Union of South Africa, are now cancelled.

It should, however, be clearly understood that no importation of citrus or other trees can be permitted unless accompanied by a permit issued by the Director of Agriculture.
