RULES OF COURT.

RULES of Court made under the provisions of the Kenya Order-in-Council, 1921, article 9 with the approval of the Governor.

Short title.

1. These Rules may be cited as the Rules of Court (Maintenance Orders Enforcement Rules), No. 2 of 1923.

Copies of Orders to whom to be sent.

2. The copy of an order made by a Court outside the Colony of Kenya and received by the Governor under Section 3 of the Maintenance Orders Enforcement Ordinance, 1921, as amended by the Maintenance Orders Enforcement (Amendment) Ordinance, 1922 (hereafter referred to as the Ordinance) shall

(i) If the order was made by a Court of superior jurisdiction be sent to the Registrar of the Supreme Court who shall enter the order in a register to be kept for that purpose at Nairobi and the copy so received shall be filed in the Registry of the Supreme Court at Nairobi.

(ii) If the order was not made by a Court of superior jurisdiction be sent to a magistrate holding a Subordinate Court of the First Class having jurisdiction within the area in which the defendant is alleged to be living.

Copies of Provisional Orders to whom to be sent.

3. The copy of a provisional order made by a Court outside the Kenya Colony and received by the Governor under Section 6 of the Ordinance shall be sent to a magistrate holding a Subordinate Court of the First Class in the manner provided by the foregoing rule with the accompanying documents and a requisition for the issue of a summons.

Registration by a Magistrate.

4. The magistrate to whom any order is sent in accordance with the above rules shall enter it in his Civil Register on the date on which he receives it in the same manner as though the proceedings had been had and the order had been made at his Court provided that each such entry shall be headed as follows:—

“In the matter of the Maintenance Orders Enforcement Ordinance, 1921.”

Notice of Confirmation of Order or otherwise.

5. When an order provisionally made outside the Colony of Kenya has been confirmed with or without modification under Section 6 of the Ordinance by a magistrate holding a Subordinate Court of the First Class or the Court has decided not to confirm it the magistrate shall send notice thereof to the Court from which it has issued and also to the Governor.

*Confirmation of
Provisional Order:
Direction for
payments.*

6. When an order has been registered under Section 3 of the Ordinance or a provisional order has been confirmed under Section 6 of the Ordinance the Court shall unless satisfied that it is undesirable to do so direct that all payments due thereunder shall be made to such person as it may specify for the purpose.

Payments.

7. The person through whom the payments are directed to be made shall collect the monies due under the order and may take proceedings in his own name for enforcing payment and shall send the monies when so collected to the Crown Agents for the Colonies for transmission to the person to whom they are due.

The person through whom payments are directed to be made may retain out of such monies as come into his hands the amount of all disbursements necessarily made and a further sum not exceeding 1% in respect of his charges.

*Variation or
rescission of Order.*

8. An application for the variation or rescission of a confirmed order shall be made with notice to the person through whom payments are directed to be made: and the applicant shall cause a copy of any order varying or rescinding a confirmed order to be served upon that person. The fees and costs payable upon the lodging of an application under Section 6 (6) of the Ordinance shall be the fees and costs payable in respect of interlocutory applications in the Supreme Court.

Appeals.

9. An appeal against an order in confirmation lodged under Section 6 (7) of the Ordinance shall be presented to the Supreme Court and shall be heard in like manner as a civil appeal from a Sub-ordinate Court under the Courts Ordinance, 1907. Where a person through whom payments are directed to be made has been nominated, the appellant shall cause notice of the appeal and of any order made by the Supreme Court in the course of the hearing of the appeal to be served upon such person. The fee payable upon the filing of the appeal shall be Shs. 20.

*Inspection and
copies of Registers.*

10. (i) The register to be kept under Rule 2 and the entries to be made in the register of a Sub-ordinate Court of the First Class under Rule 4 shall be open to inspection on the payment of a fee of Shs. 2/50.

(ii) Copies of any orders registered in accordance with these rules shall be supplied upon payment of the usual copying fees.
