# A Bill

#### Intituled

# An Ordinance to Amend the Legislative Council Ordinance, 1919.

1. This Ordinance may be cited as "The Legislative Council Short title. (Amendment) Ordinance, 1923," and shall be read as one with the Legislative Council Ordinance, 1919 (hereinafter referred to as "the Principal Ordinance"), and all amendments thereof.

2. Section 3 of the Principal Ordinance is hereby repealed Repeal and and the following section is substituted therefor:

of Section 3

- "3. Seventeen members shall be elected in accordance with Principal the provisions of this Ordinance to represent the following ordinance. electoral areas in the Council, namely:
- (1) One member for each of the electoral areas described 10 in Schedule I, Part A;
  - (2) Five members to represent the interests of the Indian community for the electoral area described in Schedule I, Part B;
- (3) One member to represent the interests of the Arab 15 community, for the electoral area described in Schedule I, Part B.
  - 3. Section 6 of the Principal Ordinance is hereby repealed Repeal and and the following section is substituted therefor:

re-enactment of Section 6

- "6. For each electoral area a separate register of the Principal persons entitled to vote in such area for the election of a Ordinance, member or members, as the case may be, shall be prepared, published and revised in the manner prescribed by the Rules contained in Schedule II".
- 4. Sub-section (1) of Section 9 of the Principal Ordinance Repeal and 25 is hereby repealed and the following sub-section substituted re-enactment therefor:

"(1) (a) is not a British subject of European origin or descent;

of sub-section (1) of Section 9 of the Principal Ordinance, and extension

- (b) is not a British subject of Indian origin or descent; or of the said 30 is not an Indian under the suzerainty or protection of His Majesty;
  - (c) is not a male Arab able to write Arabic or Swahili in Arabic characters."
- 5. Between Section 11 and Section 12 of the Principal Qualifications 35Ordinance there shall be inserted the following section:

"11A. Any person, not otherwise disqualified under the provisions of this Ordinance, shall be entitled:—

- (a) if a British subject of European origin or descent, to to have his name entered in the register of voters for one of the electoral areas described in Schedule I, Part A;
- (b) if a British subject of Indian origin or descent, or an Indian under the suzerainty or protection of His Majesty, to have his name entered in the register of voters for the electoral area described in Schedule I, Part B.
- (c) if a male Arab, to have his name entered in the register of voters for the electoral area described in Schedule I, Part B."

Amendment of Section 16 of the Principal Ordinance.

- 6. Section 16 of the Principal Ordinance is hereby amended by the addition thereto of the following paragraph:—
  - "Each voter may give one vote and no more for each of any number of persons not exceeding the number to be elected."

- 7. Schedule I of the Principal Ordinance is hereby amended as follows:—.
  - (a) Below the word and figure "Schedule I" there shall be added the word and letter "Part A."
  - (b) After the said schedule there shall be added the follow- 20 ing part:—

THE KENYA AND UGANDA (CURRENCY)
ORDER, 1921.

PROCLAMATION.

Subsidiary Coins as Legal Tender.

IN EXERCISE of the powers conferred upon the Governor by the Kenya and Uganda (Currency) Order, 1921, I, Robert Thorne Coryndon, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor of the Colony and Protectorate of Kenya, with the approval of the Treasury and a Secretary of State, do hereby proclaim and declare that on and from the 1st day of June, 1922, the subsidiary coins specified in the Schedule hereto and issued under the provisions of the Kenya and Uganda (Currency) Order, 1921,

shall be legal tender for payments made in the Co'ony and Protectorate of Kenya in accordance with the provisions of the said Order; one cent being equivalent to one-hundredth of a shilling.
