THE EAST AFRICA TOWNSHIPS ORDINANCE, 1903.

TOWNSHIP OF NAROK.

RULES.

IN EXERCISE of the powers conferred on him by the East Africa Townships Ordinance, 1903, the Governor's Deputy-in-Council has been pleased to make the following Rules for the Township of Narok:—

ASIATIC AND AFRICAN EATING HOUSES.

1. These Rules shall be applicable to the Township of Narok and may be cited as "The Narok Township (Eating House) Rules, 1924," and shall be read with the Rules of 26th January, 1916, applicable to the Township of Narok.

2. For the purposes of these Rules, the following expressions shall have the several meanings assigned to them unless repugnant to the context:—

(a) "Eating House" shall mean any premises or places where any article of food or drink is sold, or offered for sale, to Asiatics or Africans, and where accommodation is provided for the consumption of such food or drink.

(b) "License" shall mean a licence to keep an eating house for Asiatics or Africans granted under these Rules.

(c) "Licensee" shall mean the person to whom a licence, granted under these Rules, has been issued.

(d) "Licensed Premises" shall mean the eating house in respect of which a licence, granted under these Rules, is then current.

(e) "Medical Officer" shall mean the person acting for the time being as the Medical Officer and shall include any person duly authorised in writing by the Medical Officer to act on his behalf.

3. From and after the 1st day of July, 1924, no premises shall be used as an eating house in Narok Township unless such premises shall have been licensed as an eating house under these Rules and no person shall carry on the business of an Asiatic or African eating house unless he shall be in lawful possession of a current licence issued under these Rules.

4. Application for a licence or for the renewal of a licence for any premises as an eating house shall be made to the District Commissioner.

5. Every licence issued shall be for such period as the District Commissioner may determine provided that no licence shall be granted for a longer period than one year and every licence shall expire on December 31st of the year in which it was granted.

6. The licence shall contain:—

- (a) The name of the licensee.
- (b) The situation of the licensed premises.
- (c) The number of the rooms therein.
- (d) The maximum number of persons allowed on the licensed premises at any one time.
- (e) The date on which the licence expires.

7. There shall be paid a fee of Shs. 60 per annum for every such licence and for every renewal thereof provided that if the application for a licence be made after the 30th day of June of any year, half the above fee shall be paid.

8. The occupier of an unlicensed eating house shall be guilty of an offence under these Rules, and be liable to the penalties prescribed in Sections 26 and 27 of these Rules.

9. If at any time during the currency of the licence the Medical Officer or District Commissioner is not satisfied with the methods of preparing, storing or cooking food or drink, or with the general sanitation or cleanliness of the premises, the Medical Officer or District Commissioner shall serve a notice in writing upon the occupier, calling upon such occupier to make such alterations as the Medical Officer or District Commissioner shall deem necessary, and may specify the work to be executed, within a time stated in the notice.

10. All premises must be kept clean and in good repair.

11. Every licence issued under these Rules shall expire on the 31st day of December of the year in which such licence was issued.

12. A licensee shall not be transferable from the holder thereof to any other person, or from the premises in respect of which it was issued to any other premises without the consent of the District Commissioner and in the case of a transfer from one premises to another without the approval of the Medical Officer or District Commissioner.

13. The licensee shall not permit any female other than those of Asiatic or African origin to be at any time upon the licensed premises or in the house of which the licensed premises form part.

14. The licensed premises shall be at all times open to inspection by the District Commissioner and Police, and the licence shall be at all times exhibited in a conspicuous place upon the licensed premises.

15. The licensee shall not store or keep or cause or allow to be stored or kept any articles of food or drink in or upon any portion of licensed premises, except in the store room or rooms provided for the purpose under these Rules.

16. No part of the licensed premises shall be used as a living-room, bed-room or sleeping-room.

17. Any food or drink deposited upon any licensed premises which is in the opinion of the Medical Officer or District Commissioner unfit for human consumption, may be seized by the District Commissioner and shall be dealt with in such manner as he may deem fit.

18. Any person upon whose premises any unsound food has been found and dealt with as prescribed in the foregoing Rule, shall be liable to the penalties provided in Rule 26 of these Rules.

19. The licensee shall himself conduct the business of an Asiatic or African eating house on the licensed premises and shall not carry on or permit to be carried on any other business whatsoever on the licensed premises.

20. The licensee shall not permit any Asiatic or African not in his employ to loiter or remain on the licensed premises except when obtaining food or refreshment.

21. No eating house licensed under these Rules shall be open for business between the hours of 9 p.m. and 4-30 a.m.

22. The licensee shall not allow a larger number of persons than that set out in his licence to be upon the licensed premises at any one time.

23. (1) The licensee shall affix and maintain over the outside of the main entrance to the licensed premises a board or plate not less than two feet square and bearing the words "Licensed Asiatic or African Eating House," as the case may be, and the name of the licensee, in legible letters not less than three inches in length.

(2) The licensee shall fix and maintain within the licensed premises in a conspicuous position to the satisfaction of the District Commissioner a tariff of charges, and such tariff shall be legibly written or printed in English, Swahili and Hindustani and no payment in excess of such tariff shall be demanded or received from any customer by the licensee or any other person on his behalf.

24. The licensee shall be responsible for the due observance of these Rules, and any breach thereof by any servant of the licensee shall be deemed to be a breach thereof by the licensee of the premises in respect of which such breach is committed.

25. Any offence against the provisions of these Rules shall be a cognisable offence within the meaning of the Criminal Procedure Ordinance, 1913.

26. Any person who shall be guilty of any breach or non-observance of any of these Rules shall on conviction be liable to a fine not exceeding Shs. 400 or to imprisonment of either description for a term which may extend to two months, or to both, and to the forfeiture of any licence under these Rules.

27. Any person who shall fail to comply with the requisitions of any notice served under these Rules within the time specified in such notice, shall be guilty of an offence and shall be liable to a fine not exceeding Shs. 30 per day for every day in which he shall be in default.
