## A Bill

## Intituled

**An Ordinance to Amend The Traders Licensing  
Ordinance, 1919.**

1. This Ordinance may be cited as "The Traders Short title  
Licensing (Amendment) Ordinance, 1925," and shall be read  
as one with The Traders Licensing Ordinance, 1919, herein-  
after referred to as "the Principal Ordinance."

5      2. Section 7 of the Principal Ordinance is repealed and Amendment  
of Section 7 of  
the Principal  
Ordinance  
replaced as follows :—

7. (1) Subject to the provisions of Schedule I, a  
trading licence shall entitle the holder to trade at one  
store only to be specified in such licence.

10      Provided that where any firm, company or individual  
has more than one place of business in any one township,  
one licence only shall be payable in respect of the business  
or businesses carried on in such township by such firm,  
company or individual.

15      (2) Where any one firm, company or individual is  
engaged in more than one kind of trade or business subject  
to the provisions of this Ordinance in any one township,  
such firm, company or individual shall be liable to pay  
one licence only, viz., the highest applicable to any one  
20      of the trades or businesses engaged in.

3. Section 20 (e) of the Principal Ordinance is repealed Amendment  
of Section 20

and replaced as follows :—

Any person selling fresh fish, fruit, milk, vegetables,  
eggs, fowls and victuals of like description or firewood.

4. Schedule I of the Principal Ordinance is repealed and replaced as follows :—

# SCHEDULE I.

" A."

APPLICABLE TO BUSINESSES AND TRADES WHERE STOCK IS  
CARRIED FOR SALE.

For a trading licence for each store with liberty to store  
in and deliver out of Public and other go-downs and ware-  
houses :—

(a) Where the value of goods  
on hand at the stock-taking for  
the year preceding the taking out  
of the licence did not exceed  
Shgs. 500 ... .. Shgs. 10 per annum.

(b) Where the value of goods  
on hand at the stock-taking for  
the year preceding the taking out  
of the licence exceeded Shgs. 500  
but did not exceed Shgs. 3,000 ... Shgs. 30 per annum.

(c) Where the value of goods  
on hand at the stock-taking for  
the year preceding the taking  
out of the licence exceeded  
Shgs. 3,000 but did not exceed  
Shgs. 10,000 ... .. Shgs. 75 per annum.

(d) Where the value of goods  
on hand at the stock-taking for  
the year preceding the taking  
out of the licence exceeded  
Shgs. 10,000 but did not exceed  
Shgs. 50,000 ... .. Shgs. 150 per annum.

(e) Where the value of goods  
on hand at the stock-taking for  
the year preceding the taking  
out of the licence exceeded  
Shgs. 50,000 but did not exceed  
Shgs. 100,000 ... .. Shgs. 300 per annum.

(f) Where the value of goods  
on hand at the stock-taking for  
the year preceding the taking  
out of the licence exceeded  
Shgs. 100,000 ... .. Shgs. 400 per annum.

If it is considered that the charging of the fee for any  
licence taken out under (a) will prove a serious check to  
desirable trade the whole or part of such fee may be remitted  
by the Licensing Officer in any case.

Every such case shall be reported to the Governor or such officer as he may appoint.

In taking out a licence under (a) or (b) or (c) or (d) or (e) or (f) hereof the owner or manager of each store shall make a sworn declaration before the Licensing Officer that the value of goods on hand in each store at the stock-taking for the year preceding that for which the licence is taken out is within the limits therein specified.

Where a trading licence is applied for by a person who has no available record of the value of goods on hand during the year preceding such application, or by a person who has not carried on business during the year preceding such application, he shall furnish an estimate of the maximum value of goods which he anticipates will be on hand at any one time during the period in respect of which the licence is applied for and shall pay for such period the licence fee indicated in the scale given above in accordance thereto, and if the actual value of his goods during such period has exceeded the said estimates at any one time he shall pay any balance which may be found due and unless and until such sum is paid he shall not be granted a further licence under this Ordinance.

All other businesses and trades of whatever nature except as otherwise provided ... Shgs. 200 per annum.

" C. "

(1) Commercial Travellers (other than persons employed as travellers by persons or firms already paying a licence under the Ordinance).

In respect of each year or part of a year spent in the Colony ... Shgs. 500 per annum.

(2) Hawkers ... Shgs. 10 per month.

(3) Importers Licence payable by any firm or individual importing goods from overseas for sale in the Colony and not having a place of business ordinarily used and licensed for the sale of such goods ... Shgs. 500 per annum.

BANKS.

Each Bank other than a Bank whose sole business is that of a Savings Bank having registered offices in the Colony and Protectorate irrespective of the number of its offices or branches ... Shgs. 2,000 per annum.

### Intituled

### An Ordinance to Amend the Fish Protection (Amendment) Ordinance, 1923.

Short title.

1. This Ordinance may be cited as "The Fish Protection (Amendment) Ordinance, 1924," and shall be read as one with the Fish Protection (Amendment) Ordinance, 1923 (hereinafter referred to as "the Principal Ordinance").

2. (1) Section 2 of the Principal Ordinance is hereby re-numbered 2 (1). 5

(2) Section 2 of the Principal Ordinance is hereby amended by the deletion therefrom of the words "any species of fish" and the substitution therefor of the word "trout."

(3) Section 2 of the Principal Ordinance is hereby further amended by the addition thereto of the following sub-section:— 10

"(2) If the Governor shall consider at any time that any amount previously paid under the provisions of Sub-section (1) hereof has not been properly applied by the Kenya Angling Association for the purposes therein specified it shall be lawful for him to direct the Treasurer to deduct such amount from any future payments or to withhold any future payments till such time as the aforesaid association shall satisfy the Governor that such payments will be properly applied." 15
