THE ARMS AND AMMUNITION AMENDMENT
BILL, 1926.

STATEMENT OF OBJECTS AND REASONS.

This Bill is to effect two amendments to the Principal Ordinance desired by the Secretary of State.

A Bill

Intituted

An Ordinance to Amend the Arms and
Ammunition Ordinance, 1925.

1. This Ordinance may be cited as "the Arms and Ammunition (Amendment) Ordinance, 1926," and shall be read as one with the Arms and Ammunition Ordinance, 1925, hereinafter referred to as "the Principal Ordinance." Short title.

2. Section 22 of the Principal Ordinance is repealed and the following substituted therefor:— Amendment of Section 22 of the Principal Ordinance.

"22. No arms shall be repaired except at Government arsenals or at arsenals or establishments licensed by the Governor for that purpose. Before such a licence is granted guarantees shall be given for the observance of the rules of the Convention in such form as the Governor shall direct:

"Provided that nothing in this section shall be deemed to prohibit a person repairing arms belonging to himself with or without assistance."

3. Section 31 of the Principal Ordinance is hereby repealed. Repeal of Section 31 of the Principal Ordinance.

PROCLAMATION NO. 7.

THE GAME ORDINANCE, 1921.

PROCLAMATION.

IN EXERCISE of the powers conferred upon him by Section 7 of the Game Ordinance, 1921, and all other powers thereunto enabling him, His Excellency the Governor in Council has declared :—

1. That he has altered the First Schedule of the said Ordinance by adding thereto the following :

“ 14. Thomas' Cob (*Adenota cob thomasi*) in the following area, that is to say, in the Administrative District of Trans-Nzoia.”

2. That he has altered the Third Schedule of the said Ordinance as altered by Proclamation No. 137 of 1923 by adding immediately after the words “ Thomas' Cob (*Adenota cob thomasi*) ” where it appears in the Third Schedule, the words “ except in the Administrative District of Trans-Nzoia, where Thomas' Cob may not be hunted, killed or captured.”

THE PUBLIC TRUSTEE'S ORDINANCE, 1925.

RULES.

IN EXERCISE of the powers conferred by Section 26 of the Public Trustee's Ordinance, 1925, His Excellency the Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as “ the Public Trustee's Rules (No. 2), 1925,” and shall be read as one with the Public Trustee's Rules, 1925, hereinafter referred to as “ the Principal Rules.”

2. Rules 10 and 18 of the Principal Rules are amended by the deletion of the words “ Rule 5 ” therein and the substitution therefor of “ Rule 11.”

3. Rule 11 (b) of the Principal Rules is amended by the deletion of the words “ real property within the Colony ” and the substitution therefor of the words “ immovable property within the Colony.”

4. Rule 23 (d) of the Principal Rules is repealed and the following substituted therefor :—

“ 23. (d) To dispose of by public auction all movable and, if necessary, immovable property belonging to such estates and in the latter case to grant a conveyance thereof, provided always that a certificate signed by such agent that the property conveyed forms part of the estate of the deceased vested in him by virtue of the Public Trustee's Ordinance, 1925, shall be registered under the Registration of Titles Ordinance, 1919, Sections 51 and 52, in lieu of the grant of probate or letters of administration, as the case may be.”

CONTRACTS FOR WORKS DURING 1926.

THE list of contractors who wish to be invited to tender for works during 1926 is now being prepared. When such works are proposed, contracts will, when possible, be arranged for:—

1. Erection of new buildings.
2. Painting and major works in connection with the maintenance of existing buildings.
3. Construction of new roads and bridges and certain classes of road improvement.
4. Maintenance of existing roads.

Lists of contractors for the above classes of work are being revised in the following divisions and subdivisions of this Department:—

Mombasa (including the Coast area).

Nairobi (including Machakos and Kyambu Districts).

Naivasha (including Nakuru, Ravine and Rumuruti Districts).

Kisumu (including Lumbwa, Kericho, and North and South Kavirondo Districts).

Nyeri (including Fort Hall, West, East and North Kenya areas).

Eldoret (including Trans-Nzoia).

Persons desirous of being invited to tender from time to time for the classes of work alluded to, whether their names are at present on the list of contractors or not, are requested to send their names as soon as possible after the appearance of this notice to the Executive Engineer at the P.W.D. Office in the particular division or subdivision in which they are prepared to operate, stating at the same time which of the above classes of work they wish to undertake and the limits of the area within which they are willing to enter into contracts. If a contractor wishes to tender for work in more than one of the above divisions, he must submit separate applications to the Executive Engineer in charge of each division.

Invitations to tender will be sent to contractors registered for the class of work concerned, and notices will be displayed at the offices of Resident or District Commissioners and Executive Engineers. No further public notice of works contemplated, except possibly unusually large building works, will be given in the Press until January, 1927.

It is probable that there will be an extensive programme of new building work this year, and it is necessary that the list of contractors should be as complete as possible.

Applicants whose names are not already on the list of contractors must supply the Executive Engineer with a statement in support of their ability to undertake the class of work for which they apply.
