## THE CROP PRODUCTION AND LIVESTOCK ORDINANCE, 1926.

#### STATEMENT OF OBJECTS AND REASONS.

This Bill confers powers upon Government actively to improve the standards of production in the Colony, and to forbid the growth of crops or plants which are known to be deleterious or in other ways undesirable, also to preserve permanent food crops from destruction.

Through it cultural methods calculated to increase production could be laid down and in order to prevent immature produce in bad condition being exposed for sale the time of marketing any particular kind of produce may be specified.

The stocking of land beyond its carrying capacity with resultant poverty and deaths of stock may be prevented, and the number, etc., of livestock which may be kept on a given area can be defined. Generally also provision is made for determining the manner in which livestock improvement should be carried out.

The enactment amounts to an enabling Ordinance rendered effective only through rules made by the Governor in Council, and it is designedly for the benefit of and application to native agriculture.

## A Bill

#### Intituled

## An Ordinance to make Provision for the Control and Improvement of Crop Production and Livestock, and the Marketing thereof.

1. This Ordinance may be cited as " the Crop Production Short title. and Livestock Ordinance, 1926."

2. The Governor may by order apply the whole or any Application of part of this Ordinance to the whole or part or parts of the Ordinance. 5 Colony.

3. In this Ordinance, unless the context otherwise Definition. requires :---

" Crop " shall include all trees grown either for timber, fuel, food production, or any other purpose.

" Livestock " includes cattle, sheep, goats and donkeys 10 and any other animal which the Governor may by order declare to be included in the definition for the purpose of this and the set of the Ordinance.

" Agricultural produce " means any article produced or derived from farming operations and includes meat and all mouth means other products derived from livestock.

Rules.

4. The Governor in Council may from time to time make rules which shall be applicable to such area or areas as may be named therein for the following purposes :---

(a) Declaring the kind of crop or agricultural produce which shall come under the operation of this Ordinance.

(b) Improving the cultural conditions of any crop, also the methods of its production, and the prevention of its destruction.

(c) Improving the quality of any agricultural produce.

(d) Specifying any particular kind of crop, tree, or 10 plant or variety thereof, as the kind or kinds which may or may not be grown, or which may or may not be destroyed.

(e) The destruction of any diseased crop or agricultural produce with or without compensation to owner or 15 owners thereof.

(f) Assisting and, if necessary, controlling transportation, preparation for market and marketing of agricultural produce for purposes of sale.

(g) The inspection of any crop or agricultural produce. 20

(h) For defining or limiting the number, ages and sexes of the livestock to be carried on any area.

(i) For promoting the improvement of the quality of the livestock in any area.

(i) For the disposal of surplus and undesirable live- 25 stock.

(k) For fixing and collecting fees and charges in connection with the operations of this Ordinance.

Penalty.

5. Any person who commits a breach of any rule made under this Ordinance shall be guilty of an offence and upon 30 conviction shall be liable to imprisonment for a term not exceeding six months, or to a fine not exceeding five hundred shillings, or to both; and shall also be liable to confiscation of any crop or livestock in respect of which the breach was committed.

## A Bill

#### Intituled

## An Ordinance to Amend the Municipal Corporations Ordinance, 1922, and to make Provision for the Election of Councillors.

Short title.

1. This Ordinance may be cited as "the Municipal Corporations (Amendment) Ordinance, 1926," and shall be read as one with the Municipal Corporations Ordinance, 1922 (hereinafter referred to as "the Principal Ordinance").

Interpretation.

2. "Elected" means elected in accordance with this Ordinance and any rules made hereunder.

5

3. Notwithstanding anything in the Principal Ordinance Declaring municipalities contained the Governor in Council may from time to time to be elective. by proclamation published in the Gazette declare that any or all of the members of a council shall be elected or that any 5 group or groups or class or classes of such members may be elected and thereafter such members shall cease to be

appointed by the Governor but shall be elected by the electorate or electorates of such municipality duly qualified in accordance with such rules as the Governor in Council may from time to 10 time make.

4. The Governor in Council may make rules providing Rales governing for the qualification of voters or groups or classes of voters in a municipality, the preparation of a register or registers of voters, the nomination of candidates for election, the appointment of 15 a returning officer and the conduct of elections and any other matters connected with election of municipal councillors, and the period during which such councillors shall hold office.

5. In the event of a vacancy occurring among the elected members of a municipal council owing to the death, resignation 20 or disqualification of any member, such vacancy shall be filled by election and the member so elected shall hold office for the remainder of the period for which the member who has died. resigned or been disqualified was elected.

6. No person shall be qualified to be elected a member Disqualification 25 of the municipal council of any elective municipality if such for election. person :--

#### (a) Is not a British subject;

(b) Has not ordinarily resided within the area of such municipality or within five miles of the boundary thereof for at least one period of one year previous to the holding of the election within a period of three years immediately preceding the election; '

(c) Is a servant of any municipal corporation or committee:

(d) Has been convicted of a criminal offence and has been sentenced to a term of imprisonment for a term of six months or over and has not received a pardon: Provided that the Governor in Council may by order in any particular case remove such disqualification;

(e) Has received relief from any public funds whatsoever within twelve months of his nomination as a candidate for election;

(j) Is an undischarged bankrupt;

(g) Cannot read, write, or speak the English language unless by reason of physical infirmity.

7. The proviso to Section 7 (1) of the Principal Ordinance Repeal of is hereby repealed.

#### NOTICE.

#### Sale of Grants in respect of Kibwezi Plots.

NOTICE is hereby given that grants in respect of the twenty-six plots at Kibwezi specified in the Schedule hereto will be sold by auction at Kibwezi Station Waiting Room on Friday, February 26th, 1926, commencing at 10 a.m.

Plans of the sites may be seen at the Public Map Office, attached to the Land Department, Nairobi, and at the office of the Station Master at Kibwezi, or may be had on application to the Land Department on payment of Sh. 3, post free.

The right to withdraw any plots from the auction is reserved to the Commissioner of Lands.

#### GENERAL CONDITIONS.

1. Each plot shall be auctioned separately.

2. The highest bidder shall be the purchaser, and, if any dispute arise as to any bidding, the plot shall be put up again at the last undisputed bid.

3. The amount of the advance of each bid shall be regulated by the auctioneer and no bidding shall be retracted.

4. Each purchaser shall pay to the auctioneer immediately on the fall of the hammer a deposit of 25% of his purchase money. In default of such payment the plot may be immediately re-offered for sale and any subsequent bid by the person who has made default may be ignored or refused.

5. The balance of the purchase money together with the rent due to the 31st day of December, 1926, the survey fees and the fees payable for the preparation and registration of the grant and the stamp duty payable in respect of the grant shall be paid to the Commissioner of Lands at the Land Office, Nairobi, within seven days from the date of the sale, and upon such payments being duly made the purchaser shall, subject to the provisions of the Crown Lands Ordinance, 1915, and if the conditions of sale have been complied with be entitled to a grant of the plot, which grant shall be presented to him duly executed as soon as conveniently may be.

Provided that the balance of the purchase money shall not be payable within the time stated or thereafter unless and until the Commissioner of Lands can present to the purchaser the grant of the plot duly executed.

6. The grants shall be for 99 years and shall commence from the 1st day of March, 1926, and the rent shall be payable from that date.

7. Subject to the proviso contained therein if the balance of the purchase money together with the rent, fees and duty mentioned in Condition No. 5 is not paid to the Commissioner of Lands, at the Land Office, Nairobi, within seven days from the date of the sale, the Commissioner of Lands may order the deposit made by the purchaser to be forfeited and the purchaser shall have no further claim to a lease of the plot. 8. No building shall be erected on any plot unless plans, drawings, elevations and specifications thereof shall have been previously submitted to and approved by the Commissioner of Lands or such other person as he may appoint.

9. The grantee shall further submit a block plan of the plot with the position of the building clearly defined and showing a system of drainage, which shall satisfy the Director of Medical and Sanitary Services, for properly dealing with the surface water on the plot and before any building may be occupied the grantee shall satisfy the Director of Medical and Sanitary Services that such system of drainage has been properly constructed.

10. Each grantee shall suitably connect his premises with any town drainage system when, in the opinion of the Director of Medical and Sanitary Services, such drainage scheme is so far completed as to enable the grantee reasonably so to connect.

11. The Government or such person as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains and service pipes, telegraph or telephone wires, and electric mains of all descriptions whether overhead or underground, and the grantees shall not erect any building in such a way as to cover or interfere with any existing routes, main or service pipes or the telegraph or telephone wires and electric mains aforementioned.

12. Every purchaser shall bear the cost of deeds Shs. 90, stamp duty, registration Shs 20 and survey fees Shs. 70, and all other expenses, if any, connected with the purchase of the plot.

#### SPECIAL CONDITIONS OF GRANT.

1. Each purchaser shall erect on his plot within two years of the commencement of his grant a building constructed of stone, brick or concrete, asbestos, wood or wood and iron.

2. Each plot may be used for the combined purpose of residence and business provided however that should a plot be used for the said combined purpose not more than one-half of the area may be built upon. Should the plot be used for business purposes only then two-thirds may be built upon.

3. The grantee shall not any time during the term of the grant assign or sublet any portion of a plot.

4. At no time during the term of the grant shall any plot or any other portion thereof or any building erected on the plot be used for the purpose of carrying on any of the following trades:—

Blood-boiler, bone-boiler, fellmonger, soapboiler, tallow-melter, tripe-boiler, blood-drier, leather-dresser, tanner, fat-melter or extractor, glue-maker, size-scraper, gut-scraper, knacker, slaughterer of animals, storage of hides, bacon euring, artificial manure-making, oil cloth and linoleum-making, india-rubber-making, varnishmaking and oil-boiling. paper-making, manufacture of alkali, trades associated with the generation of irrespirable gases, manufacture of horse-hair, wool-sorting. trades associated with the use of poisonous metals or any other trade or business which may be declared to be dangerous or offensive by notice in the Official Gazette.


