## A Bill

### Intituled

### An Ordinance to Amend the Town Planning Ordinance, 1919.

1. This Ordinance may be cited as " the Town Planning (Amendment) Ordinance, 1926," and shall be read as one with the Town Planning Ordinance, 1919, hereinafter referred to as " the Principal Ordinance." Short title.

5 2. Section 17 (e) of the Principal Ordinance is hereby deleted and the following substituted therefor :— Amendment of Section 17 (e) of the Principal Ordinance.

10 " (e) the area of any such new plot or holding shall as far as possible bear the same relation to the area of the original plot as the difference between the area referred to in (b) and the area referred to in (a) bears to the area referred to in (b)."

3. This Ordinance shall be deemed to have come into operation with the commencement of the Principal Ordinance. Date of commencement.

## THE TOWN PLANNING ORDINANCE, 1919.

## ORDER.

IN EXERCISE of the powers conferred by the Town Planning Ordinance, 1919, Section 3 (1) the Governor in Council is pleased to appoint the persons whose names appear in Schedule I hereto to be the Authority for the purposes of the Town Planning Ordinance, 1919, for the area comprised in the circle of 10 miles radius from Nairobi House.

The said Authority may be referred to as the Nairobi Area Town Planning Authority.

Further, the Governor in Council is pleased to order the Nairobi Area Town Planning Authority to prepare a Town Planning Scheme in respect of those portions of Nairobi Township and Upper Parklands Estate contained within the boundaries described in Schedules II and III hereto and more particularly delineated and described on a plan deposited in the Land Department and available for inspection.

In order to avoid unduly retarding the development of any internal portion of the areas enclosed within the boundaries aforesaid any owner or lessee of land situated within the said boundaries desiring to sell, build upon or otherwise develop his property may submit his proposals to the Chairman of the Town Planning Authority who, if the proposal will not interfere with the Town Planning Scheme, will give a certificate to that effect.

## NOTICE.

WHEREAS by Section 8 of the Public Travel and Access Roads Ordinance, 1920, as amended by the Public Travel and Access Roads (Amendment) Ordinance, 1924, it is enacted that whenever it is made to appear to the Governor that requirements exist for the establishment, alteration or cancellation of a line of public travel or the conversion of a road of access into a line of public travel, the Governor may, by order published in the Gazette, dedicate a line of public travel which shall be clearly described in such order, and from such date of publication such line of public travel shall be absolutely dedicated to the public as a public road within the meaning of any law now or hereafter in force, and such public road shall be of such width as the Governor shall direct.

Nos. 395, 396/11, 397, 398, 399, 400, 401, 402, 403, 404, 4,333, 4,136, 1,340/1, 1,340/2, 1,154, 3,930, 4,124, 408/1, 408/2, 412/2, 412/1, 414, 415/1/1, 415/1/3, 416/1, 416/2, 417/2, 417/1, 418, 419, 420/1/2, 420/1/1, 420/2, 421/2/1, 4,568 A, 4,568 B, and 423, to a point where it joins the Naivasha-Gilgil Road on the last-mentioned farm.

Now, therefore, in exercise of the powers vested in me by the said section, I hereby order that the right-of-way and road reserve hereinbefore described as shewn approximately by black double-dotted lines on the plan marked P.W.D. No. 3,479, filed at the Head Office of the Public Works Department, Nairobi, be cancelled and I hereby further order that the line of public travel hereinbefore described and as shewn approximately by firm black line on the said plan be dedicated as a line of public travel for the purposes of the said Ordinance, and I also direct that such public road shall be 120 feet in width.

2. Admissions of children take place at meetings of the Committee of Education, Christ's Hospital, held in January and September each year. One vacancy for Kenya presentation is available now and a further presentation will be available in three years' time, and thereafter as vacancies occur so that there can always be two children on Kenya presentation in residence.

3. It must be understood that Christ's Hospital is a Church of England school and that, whilst there is no objection to the grant of a nomination to a child on the ground that he or she is not of the Church of England, the child would be required to attend prayers and religious services in the School chapel and the Hospital authorities cannot make arrangements or grant facilities for a boy or girl to attend prayers and religious services in the School chapel during term time.

4. Children are only eligible for presentation between the properly certified ages of 9 and 11 years. Boys will at first enter a preparatory department of the School at West Horsham and be drafted subsequently to the Boys' School there. Girls are sent to the Girls' School at Hertford. It is expected that children who thus enter the Schools will remain at them for about seven years.

5. All children admitted in this way will be subject to the provisions of the scheme. No child can be admitted to the Foundation of the Hospital whose parents or guardians are not in the opinion of the Council of Almoners in need of assistance towards the education and maintenance of their children, and children will receive education,

maintenance, and clothing at the cost of the Foundation. If, in the opinion of the Council, the guardians are not able to contribute substantially towards the education and maintenance of the child, these will be given free. If the guardians are so able they will have to pay not less than £10 nor more than £40 a year in aid of the General Fund of the Foundation.

6. Before children are admitted they must be satisfactorily certified to be of good character and sufficient bodily health. If, after admission, they are found to be disqualified, they will immediately be returned to their parents or guardians.

7. Each child must pass an educational examination in the following subjects:—

(1) *Reading*: To read with facility and intelligence from some standard author, reading book or History of England.

(2) *Writing*: To write legibly and correctly from dictation, with pen and ink on paper, an easy passage of ordinary English.

(3) *Arithmetic*: To work accurately sums in the four simple and compound rules of arithmetic. In the case of younger children, a thorough grounding in the principles of elementary notation and numeration, with a sound knowledge of the four simple rules, will be accepted as a sufficient test.

(4) *Geography*: To have a knowledge of elementary geographical terms and of the main features of the map of England.

(5) *English Grammar*: To be able to distinguish the different parts of speech.

The examination is not restricted to any particular books. No examination papers are published.

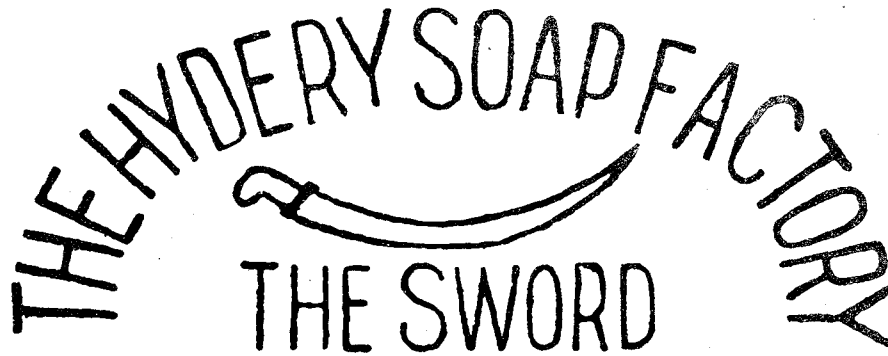

## NOTICE.

SALE OF GRANTS IN RESPECT OF BUSINESS,  
RESIDENTIAL AND HOTEL PLOTS, NANYUKI.

NOTICE is hereby given that grants in respect of the business, residential and hotel plots at Nanyuki specified in the Schedule hereto, will be sold by auction at Nanyuki, on Thursday, the 8th April, 1926, commencing at 10.30 a.m.

Plans of the sites may be seen at the Public Map Office, attached to the Land Department, Nairobi, and at the office of the Resident Commissioner at Nyeri, or may be had on application to the Land Department on payment of Shs. 4. post free.

The right to withdraw any plot from the auction is reserved to the Commissioner of Lands.

## GENERAL CONDITIONS OF SALE.

1. Each plot will be auctioned separately.
2. The highest bidder will be the purchaser, and, if any dispute arises as to any bid, the plot will be put up again at the last undisputed bid.
3. The amount of the advance of each bid will be regulated by the auctioneer and no bidding shall be retracted.
4. Each purchaser shall pay to the auctioneer immediately on the fall of the hammer a deposit of 25 per cent. of his purchase money. In default of such payment the plot may be immediately re-offered for sale and any subsequent bid by the person who has made default may be ignored or refused.
5. The balance of the purchase money together with the rent due to the 31st December, 1926, the survey fees and the fees payable for the preparation and registration of the grant and the stamp duty payable in respect of the grant shall be paid to the Commissioner of Lands, at the Land Department, Nairobi, within seven days from the date of the sale, and upon such payments being duly made the purchaser shall, subject to the provisions of the Crown Lands Ordinance, 1915, and if the conditions of sale have been complied with be entitled to a grant of the plot, which grant shall be presented to him duly executed as soon as conveniently may be.

Provided that the balance of the purchase money shall not be payable within the time stated or thereafter unless and until the Commissioner of Lands can present to the purchaser the grant of the plot duly executed.

6. The grants will be for 99 years and will commence from the 1st day of May, 1926, and the rent shall be payable from that date.

7. Subject to the proviso contained therein if the balance of the purchase money together with the rent, fees and duty mentioned in Condition No. 5 is not paid to the Commissioner of Lands, at the Land Department, Nairobi, within seven days from the date of sale, the Commissioner of Lands may order the deposit made by the purchaser to be forfeited and the purchaser will have no further claim to a lease of the plot.

8. No building shall be erected on any plot unless plans, drawings, elevations and specifications thereof shall have been previously submitted to and approved by the Commissioner of Lands or such other person as he may appoint.

9. The grantee shall further submit a block plan of the plot with the position of the building clearly defined and shewing a system of drainage, which shall satisfy the Director of Medical and Sanitary Services, for properly dealing with the surface water on the plot and before any building may be

occupied the grantee shall satisfy the said Director of Medical and Sanitary Services that such system of drainage has been properly constructed.

10. Each grantee shall suitably connect his premises with any town drainage system when, in the opinion of the Director of Medical and Sanitary Services, such drainage scheme is so far completed as to enable the grantee reasonably so to connect.

11. The Government or such person as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains and service pipes, telegraph or telephone wires, and electric mains of all descriptions whether overhead or underground, and the grantees shall not erect any building in such a way as to cover or interfere with any existing routes, main or service pipes or the telegraph or telephone wires and electric mains aforementioned.

12. Each purchaser shall bear the cost of deeds Shs. 90, stamp duty, registration Shs. 20, survey fees and all other expenses, if any, connected with the purchase of the plot.

## SPECIAL CONDITIONS FOR BUSINESS SITES.

1. Each purchaser shall erect on his plot within two years of the commencement of his grant a building constructed of stone, brick or concrete.

2. The plots referred to as business sites may be used for the combined purpose of business and residence, provided that should a plot be used for the said combined purpose not more than one-half of the area shall be built upon and that should the plot be used for business purposes only then two-thirds of the area may be built upon.

3. At no time during the term of the grant shall any plot or any portion thereof or any building erected on the plot be used for the purpose of carrying on any of the following trades:—

Blood-boiler, bone-boiler, fellmonger, soap-boiler, tallow-melter, tripe-boiler, blood-drier, leather-dresser, tanner, fat-melter or extractor, glue-maker, size-scraper, gut-scraper, knacker, slaughterer of animals, storage of hides, bacon curing, artificial manure-making, oilcloth and linoleum-making, indiarubber-making, varnish-making, and oil-boiling, paper-making, manufacture of alkali, trades associated with the generation of irrespirable gasses, manufacture of horse-hair, wool-sorting, trades associated with the use of poisonous metals, or any other trade or business which may be declared to be dangerous or offensive by notice in the Official Gazette.

4. Subdivision of Plot No. 2, Section IX or the subletting of a portion thereof will not be permitted.

## SPECIAL CONDITIONS FOR RESIDENTIAL PLOTS.

1. Each purchaser shall within two years of the commencement of the grant completely enclose his plot with a fence of suitable design and in conformity with the Township Regulations.

2. Each purchaser shall erect on his plot within two years of the commencement of his grant a dwelling-house of approved design to be built of stone, brick, or concrete, in respect of the Class "A" Residential Plots, and of stone, brick, concrete, asbestos, wood or wood and iron in respect of the Class "B" Residential Plots.

3. At no time during the term of the grant shall more than one dwelling-house with the necessary offices and out-buildings be erected on any plot.

4. All outbuildings, offices, etc., shall be properly screened from view to the satisfaction of the Commissioner of Lands or such other person as he may appoint and shall be kept so screened during the term of the grant.



5. No building shall at any time during the term of the grant be used for any other purpose than a private dwelling-house.

6. The grantee shall not at any time during the term of the grant erect any building or buildings so as to cover more than one-half of the area of the plot, and shall not erect any buildings nearer than 10 feet from the boundary of the plot.

7. At no time shall the plot be subdivided, and the grantee shall not assign any portion of a plot without consent.

#### SPECIAL CONDITIONS FOR THE HOTEL PLOT.

1. The plot shall be used for the purposes of an hotel and for no other purpose whatsoever.

2. Within two years of the date of the grant the grantee shall erect on the plot suitable buildings of an approved design to be constructed of stone, brick or concrete.

3. Within two years of the date of the grant the grantee shall completely enclose the plot with a fence of suitable design and in conformity with Township Rules.

4. All offices and outbuildings, etc., shall be properly screened from view to the satisfaction of the Commissioner of Lands or such other person as he may appoint and shall be kept so screened during the term of the grant.

5. No subdivision of the plot will at any time be allowed.

6. At least one-third of the plot shall remain unbuilt upon.
