## A Bill to Amend the Interpretation and General Clauses Ordinance.

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows :—

1. This Ordinance may be cited as " the Interpretation and General Clauses (Amendment) Ordinance, 1926," and shall be read as one with the Interpretation and General Clauses Ordinance (Chapter 1 of the Revised Edition), hereinafter referred to as " the Principal Ordinance."

Short title.

2. (1) The following shall be inserted as paragraph (24a) of section 2 of the Principal Ordinance :—

Amendment of section 2 of the Principal Ordinance.

10 " (24a) ' Native Reserve ' shall include any area declared to be a Native Reserve under the provisions of the Crown Lands Ordinance."

Cap. 140.

(2) Paragraph (36) of section 2 of the Principal Ordinance is hereby repealed, and in lieu thereof shall be read the following :—

15 " (36) ' Statutory declaration ' shall mean a declaration made by virtue of the Statutory Declarations Ordinance, 1926."

3. Where any Ordinance or part of an Ordinance is repealed, all proclamations, rules, by-laws, orders and notices issued under or made in virtue thereof shall remain in force so far as they are not inconsistent with the repealing Ordinance and, unless the contrary intention appears, until they shall have been revoked or have been repealed by proclamations, rules, by-laws, orders or notices, as the case may be, issued or made under the provisions of the said repealing Ordinance.

Effect of repeal of Ordinance on rules, etc., made under it.

### OBJECTS AND REASONS.

It is proposed by this Bill to amend the Interpretation and General Clauses Ordinance as follows :—

Clause 2 (1) of the Bill includes in the list of general definitions a definition of the term " Native Reserve." This term is used in various enactments, but no general definition at present exists.

Clause 2 (2) substitutes a new general definition of the term " Statutory Declaration." This amendment becomes necessary in view of the introduction of a local Statutory Declarations Ordinance.

Clause 3 is intended to render it unnecessary, when an Ordinance is repealed and replaced by a substantially similar Ordinance, to re-issue proclamations, rules, by-laws, orders and notices which may have been made under the former Ordinance. The proposed clause preserves the effect of all such proclamations, rules, etc., so far as they are not inconsistent with the new Ordinance, until they are specifically revoked or replaced.

### A Bill Relating to Statutory Declarations.

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows :—

- Short title.** 1. This Ordinance may be cited as "the Statutory Declarations Ordinance, 1926."
- Power to take declarations.** 2. It shall be lawful for any Magistrate, Justice of the Peace, or Commissioner for Oaths to take the declaration of any person voluntarily making and subscribing the same before him in the Form in the Schedule to this Ordinance. 5
- Fees payable on declarations.** 3. Whenever any declaration shall be made and subscribed by any person under and in pursuance of the provisions of this Ordinance, such fees or fee as would have been due and payable on the taking or making any legal oath, solemn affirmation, or affidavit shall be in like manner due and payable upon making and subscribing such declaration. 10
- Mode of describing declaration.** 4. A declaration made under this Ordinance may be referred to in any Ordinance or other legal document as a Statutory Declaration. 15
- Penalty.** 5. If any person knowingly and wilfully makes any statement which is false in a material particular in a Statutory Declaration he shall be liable on conviction to imprisonment of either description for a term not exceeding two years or to a fine not exceeding one hundred pounds, or to both such imprisonment and fine. 20

#### SCHEDULE.

(Section 2.) I, A.B., do solemnly and sincerely declare as follows :—

[Here state the matters declared.]

I make this declaration conscientiously believing the same to be true and according to the Statutory Declarations Ordinance, 1926.

#### OBJECTS AND REASONS.

A number of local Ordinances contain reference to Statutory Declarations, and the term is defined in the Interpretation and General Clauses Ordinance (Chapter 1) to mean—

" a declaration made by virtue of the provisions of the Imperial Act known as ' the Statutory Declarations Act, 1835.' "

Some doubt has been expressed, however, as to whether the Statutory Declarations Act applies in the Colony, and it is therefore considered desirable to enact local legislation to provide for the making and subscribing of Statutory Declarations.

Provision will be made by another Bill for the amendment of the general definition of " Statutory Declaration " above referred to.

  4. Each purchaser shall pay to the auctioneer immediately on the fall of the hammer a deposit of 25 per cent. of his purchase money. In default of such payment the plot may be immediately re-offered for sale and any subsequent bid by the person who has made default may be ignored or refused.

The grantee shall further submit a block plan of the plot with the position of the building clearly defined and shewing a system of drainage, which shall satisfy the Director of Medical and Sanitary Services, for properly dealing with the surface water on the plot and before any building may be occupied the grantee shall satisfy the said Director of Medical and Sanitary Services that such system of drainage has been properly constructed.

10. Each grantee shall suitably connect his premises with any town drainage system when, in the opinion of the Director of Medical and Sanitary Services, such drainage scheme is so far completed as to enable the grantee reasonably so to connect.

11. The Government or such person as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains, and service pipes, telegraph or telephone wires, and electric mains of all descriptions whether overhead or underground, and the grantees shall not erect any building in such a way as to cover or interfere with any existing routes, main or service pipes or the telegraph or telephone wires and electric mains aforementioned.

12. Each purchaser shall bear the costs of deeds, Shs. 90; stamp duty, registration Shs. 20, survey fees and all other expenses, if any, connected with the purchase of the plot.

## SPECIAL CONDITIONS FOR BUSINESS SITES.

1. Each purchaser shall erect on his plot within two years of the commencement of his grant a building constructed of stone, brick, concrete, asbestos, wood, or wood and iron.

2. The plots referred to as business sites may be used for the combined purpose of business and residence, provided that should a plot be used for the said combined purpose not more than one-half of the area shall be built upon and that should the plot be used for business purposes only then two-thirds of the area may be built upon.

3. At no time during the term of the grant shall any plot or any portion thereof or any building erected on the plot be used for the purpose of carrying on any of the following trades:—

Blood-boiler, bone-boiler, fellmonger, soap-boiler, tallow-melter, tripe-boiler, blood-drier, leather-dresser, tanner, fat-melter or extractor, glue-maker, size-scraper, gut-scraper, knacker, slaughterer of animals, storage of hides, bacon-curing, artificial manure making, oilcloth and linoleum making, indiarubber-making, varnish-making, and oil-boiling, paper-making, manufacture of alkali, trades associated with the generation of irrespirable gases, manufacture of horse-hair, wool-sorting, trades associated with the use of poisonous metals, or any other trade or business which may be declared to be dangerous or offensive by notice in the Official Gazette.

## SPECIAL CONDITIONS FOR RESIDENTIAL PLOTS.

1. Each purchaser shall within two years of the commencement of the grant completely enclose his plot with a fence of suitable design and in conformity with the Township Regulations.

2. Each purchaser shall erect on his plot within two years of the commencement of his grant a dwelling-house of approved design to be built of stone, brick, or concrete.

3. At no time during the term of the grant shall more than one dwelling-house with the necessary offices and outbuildings be erected on any plot.

The plot shall be used for purposes of a garage, or for the combined purpose of a garage and residence, and for no other purpose whatsoever, provided that should the plot be used for the said combined purpose not more than one-half of the area shall be built upon and that should the plot be used for garage purposes only then two-thirds of the area may be built upon.

2. The grantee shall erect on his plot within two years of the commencement of his grant a building constructed of stone, brick or concrete.

3. Subdivision of the plot or the subletting of a portion thereof will not be permitted.
