THE NATIVE FOODSTUFFS ORDINANCE.

PROCLAMATION.

EDWARD DENHAM.

I S.

BY His Excellency Sir Edward Brandis Denham, Knight Commander of the Most Excellent Order of the British Empire, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commander-in-Chief of the Colony and Protectorate of Kenya, in Executive Council.

WHEREAS by section 3 of the Native Foodstuffs Ordinance, (Chapter 135 of the Revised Edition), it is provided that where it has been made to appear to the Governor in Council that any district or area is suffering from, or threatened with a shortage of native foodstuffs, he may issue a proclamation (a) prohibiting the purchase or barter of such foodstuffs generally or of any class or classes of the same, for the purpose of re-sale in or export from the district or area in such proclamation specified, unless the written permission of the Resident Commissioner or District Commissioner, as the case may be, be first obtained; (b) prohibiting the export of such foodstuffs generally or of any class or classes of the same from any district or area; (c) prohibiting the use of such foodstuffs or of any class or classes of the same for the manufacture of liquor in any district or area; (d) prohibiting the concealment or destruction of such foodstuffs or any class or classes of the same in any district or area;

AND WHEREAS it has been made to appear to me that the District of South Kavirondo is suffering from or threatened with a shortage of native foodstuffs:

NOW, THEREFORE, by virtue of the powers in me vested as aforesaid and having taken the advice of my Executive Council, I do hereby prohibit—

- (a) the purchase or barter of maize, beans, chiroko, wimbi, sweet potatoes, kunde and mtama for the purpose of re-sale in or export from the South Kavirondo District unless the written permission of the District Commissioner of the said district be first obtained;

- (b) the export of any such native foodstuffs from the said area;
- (c) the use of any such native foodstuffs for the manufacture of liquor in the said area; or
- (d) the concealment or destruction of any such native foodstuffs in the said area.

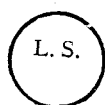

## GOVERNMENT NOTICE No 442.

## THE TOWNSHIPS ORDINANCE.

## RULES.

IN EXERCISE of the powers conferred upon him by Section 3 of the Townships Ordinance (Chapter 82 of the Revised Edition), His Excellency the Acting Governor in Council has been pleased to make the following rules :—

1. These Rules may be cited as “ the Nyeri Township Rules, 1927,” and shall apply to the Township of Nyeri.

2. In these rules, unless the context otherwise requires :—

The expression “ night ” means the interval between nine o'clock in the evening and six o'clock of the next succeeding day ;

The expression “ native ” shall include a native of the Comoro Island, and a native of Madagascar.

3. Every native who—

- (a) not being a servant housed therein by his or her employer or the husband, wife or children of such servant, shall be found or remain, by day or by night, in or upon any house, tent, warehouse, coach-house, garage, stable, outhouse, yard, garden, or other premises without the consent of the owner or occupier of such house, tent, warehouse, coach-house, garage, stable, outhouse, yard, garden, or other premises or without other lawful excuse (the proof whereof shall be on such native) ;
- (b) without valid excuse, the proof whereof shall be on such native, shall be found lying, wandering or loitering on any highway, yard or other place during the night, or shall be found wandering abroad and/or lodging in any barn or outhouse or in any deserted or unoccupied building or in the open air or under a tent or in any cart or wagon ;
- (c) shall be found by night having in his possession without lawful excuse (the proof whereof shall be on such native) any dangerous or offensive weapon, fire-arm, or instrument or any key, picklock, crow-bar, jemmy, jack, bit or other implement of house-breaking or having his or her face disguised ;
- (d) shall remain within the Township of Nyeri for a longer period than forty-eight hours without employment (the proof whereof shall be on such native) ; provided that the provisions of this sub-rule shall not apply to any native who is in possession of a valid permit to reside in the Township of Nyeri issued by the District Commissioner, and provided that the said District Commissioner may issue to any native showing good and sufficient cause a permit in the form of the Schedule hereto, and such permit, should constitute the authority of such native to reside within the Township of Nyeri for the period stated on such permit,

and every person wilfully aiding or wilfully assisting any such native aforesaid shall be guilty of an offence and on conviction for such offence shall be liable to a fine not exceeding four hundred shillings or to imprisonment of either description for a term not exceeding two months, or to both such fine and imprisonment. In addition to such punishment aforesaid, the Court may order such native to return to his reserve or proper place of residence and if such native disobeys such order he shall be liable to a further term of imprisonment of either description not exceeding two months.

4. Any police officer may take into custody without warrant any person found or reasonably suspected of committing or attempting to commit or wilfully aiding or wilfully assisting any native to commit any offence against these rules.

5. When there is reasonable cause for so doing any European police officer of or above the rank of Assistant Inspector or any police officer authorised in writing by him may enter any house, tent, warehouse, coach-house, garage, stable, outhouse, yard, garden or other premises at any time to ensure that the provisions of these rules are being complied with.

NOTICE.

NGONG ROAD TO DAGORETTI FOREST ROAD.

WHEREAS by Section 8, Chapter 113, Laws of Kenya, as amended by Public Travel and Access Roads (Amendment) Ordinance, 1924, it is enacted that whenever it is made to appear to the Governor that requirements exist for the establishment, alteration or cancellation of a line of public travel, or the conversion of a road of access into a line of public travel, the Governor may, by order published in the Gazette, dedicate a line of public travel which shall be clearly described in such order, and from such date of publication such line of public travel shall be absolutely dedicated to the public as a public road within the meaning of the law now or hereafter in force, and such public road shall be of such width as the Governor shall direct.

AND WHEREAS it has been made to appear to me that requirements exist for the establishment of the line of public travel described in the Schedule hereto.

NOW, THEREFORE, in exercise of the powers vested in me by the said section, I hereby order that the said line of public travel be dedicated as a public road for the purposes of the said Ordinance and I also direct that such public road shall be 120 feet wide.

## GENERAL NOTICE No. 738.

## TENDERS.

TENDERS are invited under the following conditions for the purchase of the lease of plots in the southern residential area of the Island of Mombasa for the purpose of erecting houses thereon.

1. Survey of the plots to be undertaken by a licensed surveyor to be engaged by the successful tenderer and to act under the direction of the District Surveyor, Mombasa.

2. The leases of the plots shall be for a term of 99 years commencing from a date to be determined after the completion of survey. Rental shall be payable from this date.

3. The rental of each plot shall be at the rate of £48 per acre per year. The Stand Premium of each plot shall be at the rate of £200 per acre.

4. A house with suitable out buildings shall be erected on each plot within two years of the date of the lease of a total value of not less than £1,300. Successful tenderers must be prepared to prove to the satisfaction of the Commissioner of Lands that this sum at least has been spent on buildings on each plot.

5. No building shall be erected on a plot unless plans, drawings, elevations and specifications thereof shall have been previously submitted to and approved by the Land Officer or such other person as he may appoint.

6. Purchasers shall further submit a block plan of their plot with the position of the buildings clearly defined and showing a system of drainage, which shall satisfy the Medical Officer of Health, for properly dealing with the surface water on the plot, and before any building may be occupied, the purchasers shall satisfy the Medical Officer of Health that such system of drainage has been properly constructed.

7. Purchasers shall suitably connect their premises with any town drainage system when in the opinion of the Medical Officer of Health, such drainage scheme is so far completed as to enable the purchasers reasonably so to connect.

8. No subdivision of any plot will be allowed at any time.

9. Purchasers shall, within one year of the commencement of the lease, completely enclose the plot with a fence of suitable design and in conformity with the township regulations.

10. All outbuildings, offices, etc., shall be properly screened from view to the satisfaction of the Land Officer or such other person as he may appoint, and shall be kept so screened during the term of the lease.

11. No building may approach within a less distance than 10 feet of the boundary of the plot, and at least one-half of the plot must remain unbuilt upon.

12. The Director of Public Works or such person as may be appointed for the purpose shall have the right to enter upon the plot and lay and have access to water mains and service pipes, telegraph or telephone wires and electric mains of all descriptions whether overhead or underground, and the purchasers shall not erect any building in such a way as to cover or interfere with any existing routes, main, or service pipes or the telegraph or telephone wires and electric mains aforesaid.

13. Purchasers must be prepared to conform to all the Mombasa Building Rules, to the terms of the Mombasa Town Planning Scheme and to all other rules and regulations in force in Mombasa Township.

14. The lease will contain the restrictive covenants as regards both ownership and occupation which already obtain in this residential area.

15. A tender may be for the amount of the Stand Premium or for a larger amount. A tender for less than the Stand Premium will not be accepted. The highest or any tender will not necessarily be accepted.

16. Failure to comply with any of these conditions will involve forfeiture of both land and buildings.

17. Plans of the area may be seen at the Land Office, Mombasa or Nairobi, or may be obtained on application at a cost of Shs. 3, post free.

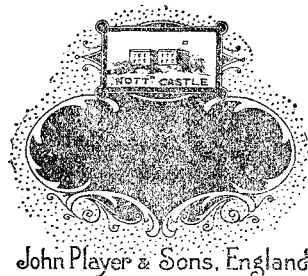
