

BY His Excellency Sir Edward Brandis Denham, Knight Commander of the Most Excellent Order of the British Empire, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commander-in-Chief of the Colony and Protectorate of Kenya.

IN EXERCISE of the powers conferred upon me by section 3 of the Forest Ordinance, (Chapter 149 of the Revised Edition), I hereby declare the area described in the Schedule hereto to be a Forest Area within the meaning of the aforementioned Ordinance.

## SCHEDULE.

### BOUNDARIES OF THE MOUNT KENYA FOREST RESERVE.

The boundaries of this Forest Reserve are delineated and coloured green on Land Surveys Boundary Plan No. 39 deposited at the office of the Land Surveys Department, Nairobi, a copy whereof is on record at the office of the Forest Department, Nairobi.

The general description of these boundaries is as follows :—

Commencing at the south-eastern corner of L.O. No. 4634 on the eastern Marania (or Lukululu) River ;

thence bounded by that river up-stream to its intersection with the Kazita Marania track ;

thence by the centre line of that track (which also forms the south-western boundary of the Meru Forest Reserve) in a generally south-easterly direction to a point about 1,000 feet north of the junction of the Muni and Kazita (Kathita) Rivers, where it intersects a cut and beacons line;

thence in a generally southerly direction by that cut line to its intersection (about half a mile south of its intersection with the Iraru River) with the old P.W.D. Road;

thence south-easterly by the south-western edge of that old road to its intersection with the Mutonga River;

thence by that river up-stream for about one mile and a half to its intersection with a cut and beacons line;

thence by that cut line in a generally south-easterly and southerly direction to a point about two-thirds of a mile beyond its intersection with the Ruguti River;

thence still following a cut line south-westerly, westerly and southerly to the Kii River;

thence by a very irregular cut line which follows closely the forest edge in a generally westerly direction to the Sagana River;

thence by that river up-stream to its intersection with the eastern boundary of L.O. No. 2266;

thence by the eastern boundary of that portion to its north-east corner;

thence by the south-eastern, north-eastern and north-western boundaries of L.O. No. 2263 and the northern boundaries of L.O. Nos. 3449 and 2262 to the intersection of the latter with the Nairobi River;

thence by that river up-stream to its intersection with the south-western boundary of L.O. No. 1784;

thence by the south-western and south-eastern boundaries of that portion;

thence by the south-eastern boundaries of L.O. Nos. 1783, 1782 and 1781;

thence by the generally northern boundary of the last portion;

thence by the south-eastern boundary of L.O. No. 3800 and the north-eastern boundary of L.O. No. 4353 to its intersection with the Naramoru River;

thence by that river down-stream to its intersection with the eastern boundary of L.O. No. 1230;

thence by that boundary to its intersection with the Buguret River;

thence by that river down-stream to its intersection with the southern boundary of L.O. No. 2832 (outspan);

thence by the southern and eastern boundaries of that outspan;

thence north-easterly by part of the south-eastern boundary of L.O. No. 1232 and the south-eastern boundary of L.O. No. 1231 to the intersection of the latter with the Nanyuki River;

thence by that river up-stream, forming part of the south-western boundary of Nanyuki Township to its intersection with the eastern boundary thereof;

thence by that eastern boundary to its intersection with the Liki (or Lekki) River;

thence by that river down-stream to its intersection with the generally southern boundary of L.O. No. 5103;

thence by the generally southern and south-eastern boundaries of that portion and the southern boundaries of L.O. Nos. 2882 and 2886;

thence by the south-western boundary of L.O. No. 2888, and the southern boundaries of L.O. Nos. 2895, 2894, 2893, 2816, 2817, 2820 and 4634 to the point of commencement.

The area within the foregoing boundaries comprising L.O. Nos. 3379, 2260, 3377, 3378, 3447/R, 2281, 3442, 3443, 3444, 4402 and 5115, as delineated on Sheets 16 and 17 of the aforesaid deposited plan, are not part of the Forest Reserve, and are excluded therefrom.

## GILGIL TOWNSHIP.

*Description of Boundaries.*

Commencing at the southernmost corner of L.O. No. 5624;

thence northerly, south-easterly, southerly and westerly by lines bearing  $352^{\circ} 45' 07''$  for 2,775 feet,  $127^{\circ} 45' 07''$  for 1,541.5 feet,  $172^{\circ} 45' 07''$  for 1,805 feet, and  $262^{\circ} 45' 07''$  for 1,090 feet to a point bearing  $172^{\circ} 45' 07''$  for 120 feet from the point of commencement;

thence southerly to a beacon by a line bearing  $172^{\circ} 45' 07''$  for 635 feet and onwards to its intersection with the generally southern 100 feet Railway Reserve boundary;

thence south-easterly by that boundary down-line to its intersection with the eastern boundary of L.O. No. 423;

thence north-westerly by part of the latter boundary to the north-east corner of L.O. No. 423;

And I do further declare that the description of the trading centre published in the Gazette at page 68, Government Notice No. 33, dated 25th day of January, 1918, No. 1 of the Schedule, is hereby rescinded.

thence south-easterly by part of the northerly boundary of L.O. No. 152 to the north-easterly corner of that portion;

thence south-westerly by the south-eastern boundaries of L.O. Nos. 152, 2950/4, 2950/5/2/3, 2950/1, 3564, 169/R 2 to the Mutiguti River;

thence by that river up-stream to the westerly corner of L.O. No. 170/1/2;

thence by a straight line north-westerly to the south-western corner of L.O. No. 4713 on the 100' eastern zone of the Kenya and Uganda Railway;

thence northerly by that 100' zone to a point due east of the most easterly point of L.O. No. 174 (in the 100' zone of the Kenya and Uganda Railway);
