THE MOTOR TRAFFIC ORDINANCE.

NOTICE.

(SPEED LIMITS, MOTOR OMNIBUS AND MOTOR LORRY).

IN EXERCISE of the powers conferred upon him by section 15 (1) of the Motor Ordinance (Chapter 68 of the Revised Edition), His Excellency the Governor in Council is pleased to notify that—

- 1. The speed at which a motor omnibus or motor lorry may be driven on any public thoroughfare shall not exceed twenty miles an hour provided that—
  - (a) if the tare weight of the motor omnibus or motor lorry exceeds thirty hundredweight, the speed shall not exceed fifteen miles an hour.
  - (b) if the motor omnibus or motor lorry draws a trailer, the speed shall not exceed twelve miles an hour.
- 2. For the purpose of this notice the expressions "motor omnibus," "motor lorry" and "trailer" shall have the same meanings as have been assigned to them by the Motor Traffic (Omnibus and Lorry) Rules, 1927.
- 3. This notice shall have effect as from the 1st day of January, 1928.

## THE MOTOR TRAFFIC ORDINANCE.

ORDER.

(Motor Omnibuses and Motor Lorries).

IN EXERCISE of the powers conferred upon him by section 18 of the Motor Traffic Ordinance (Chapter 68 of the Revised Edition), His Excellency the Governor in Council has been pleased to order that:—

- 1. (a) No motor omnibus may carry passengers for hire unless such motor omnibuses shall have been approved and licensed for that purpose by a licensing officer.
  - (b) It shall be lawful for a licensing officer to fix the maximum number of passengers, exclusive of the driver and assistant driver, if any, which any omnibus may carry. For the purpose of this order the weight of each person to be carried shall be taken as one hundred and twenty-six pounds.
  - (c) No baggage or parcels shall be placed on a motor omnibus in such a position as to impede the free ingress and egress of passengers.
  - (d) It shall be unlawful for any person to travel on the footboard or mudguard or elsewhere on the outside of a motor omnibus.
  - (e) The driver's seat of every motor omnibus shall be partitioned off and entirely separate from that portion of the omnibus intended for the carriage of passengers. No person other than the driver, the assistant driver, if any, shall occupy the driver's seat. The driver's seat shall permit of an uninterrupted view to the front and sides of the omnibus and a window or aperture of adequate dimensions shall be so placed at the back of the driver's cabin as to permit a view to the rear of the omnibus with the aid of a mirror or reflector.
  - (f) The driver's seat of every motor lorry shall be partitioned off and entirely separate from that portion of the lorry intended for the carriage of goods or materials. No person other than the driver, and assistant driver, if any, shall occupy the driver's seat. The driver's seat shall permit of an unobstructed view to the front and sides of the lorry and a window or aperture of adequate dimensions shall be so placed at the back of the driver's cabin so as to permit of a view to the rear of the lorry with the aid of a mirror or reflector.

- (g) The width of a motor lorry, motor omnibus or trailer whether laden or unladen shall not exceed seven feet, such width to be measured between its extreme projecting points. The length of any motor lorry or motor omnibus or trailer whether laden or unladen shall not exceed twenty-four feet
- (h) No motor lorry, motor omnibus or trailer shall be so loaded as to cause any load or article to project more than six feet behind the vehicle. Exemption from this condition may be granted by a District Commissioner, Assistant District Commissioner, a Justice of the Peace, or a Police Officer, any of whom may issue a permit which must be carried by the driver or person in charge of the motor lorry or motor omnibus.
- 2. For the purposes of this order the expressions of "motor omnibus," "motor lorry" and "trailer" shall have the same meanings as have been assigned to them by the Motor Traffic (Omnibus and Lorry) Rules, 1927, (Government Notice No. 602 of 16th December, 1927).

This order shall have effect as from the 1st day of January, 1928.

## THE MOTOR TRAFFIC ORDINANCE.

## Rules.

IN EXERCISE of the powers conferred upon him by section 22 of the Motor Traffic Ordinance (Chapter 68 of the Revised Edition), His Excellency the Governor in Council has been pleased to make the following rules:—

- 1. These Rules may be cited as "the Motor Traffic (Omnibus and Lorry) Rules, 1927."
  - 2. For the purpose of these Rules the expression:—
  - "Motor omnibus" includes every motor omnibus, charabane, or other motor vehicle licensed to convey more than six passengers for hire or reward and whether at separate fares or otherwise but does not include a taxicab;
  - "Motor lorry" includes any motor van or other motor vehicle designed or used for the transport of goods or materials or for hauling or intended for the haulage of any goods or materials or of any trailer;
  - "Taxi-cab" includes any motor vehicle licensed under the provisions of any Municipal By-laws or Township Rules for the purpose of carrying not more than six passengers for hire or reward;
  - "Trailer" includes any vehicle drawn by a motor lorry or omnibus, provided that a trailer shall be suitably constructed and sprung to the satisfaction of the licensing officer.

## Motor Omnibuses.

- 3. The owner of a motor omnibus shall cause to be painted or otherwise plainly marked on some conspicuous part of the right or off side and also in some conspicuous part of the inside of such omnibus in letters and figures not less than two inches in height and of such shape and colour as to be clearly legible—
  - (a) the name and address of the owner.
  - (b) the number of passengers which the omnibus is licensed to carry, in the form "Licensed to carry ......passengers."
  - (c) the highest speed at which the omnibus is permitted to travel.

He shall cause the paint or marking to be from time to time repaired or renewed, as often as may be necessary, to keep the said letters and figures clearly legible and clearly distinguishable.

- 4. Every motor omnibus shall have affixed thereto a mirror or reflector in such a position that the driver may with the aid of such mirror or reflector see any other vehicle which may be overtaking or following close behind such omnibus.
- 5. It shall be the duty of every owner and driver of a motor omnibus at all times to keep such motor omnibus in good mechanical repair.
- 6. The licensing officer may prescribe a time and place at which any motor omnibus shall be presented for inspection in accordance with the provisions of section 6 (3) of the Motor Traffic Ordinance.

## MOTOR LORRIES.

- 7. The Licensing Officer may prescribe the maximum weight to which any motor lorry may be loaded and such maximum weight shall be endorsed on the licence by the licensing officer. Provided that no motor lorry shall be loaded in excess of the weight specified by the manufacturer thereof.
- 8. No motor lorry shall ply for hire for the carriage of passengers.
- 9. The owner of a motor lorry shall cause to be painted or otherwise plainly marked on some conspicuous part of the right or off side of such motor lorry in letters and figures not less than two inches in height and of such shape and colour as to be clearly legible—
  - (a) the registered weight of the motor lorry unladen;
  - (b) the maximum weight which the motor lorry is licensed to carry;

- (c) the name and address of the owner;
- (d) the highest speed at which the motor lorry may be driven without a trailer.
- 10. Every motor lorry shall have affixed thereto a mirror or reflector in such a position that the driver may, with the aid of such mirror or reflector, see any other vehicle which may be overtaking or following close behind such motor lorry.
- 11. It shall be the duty of every owner and driver of a motor lorry or trailer at all times to keep such motor lorry in good mechanical repair.
- 12. The licensing officer may prescribe a time and place at which any motor lorry shall be presented for inspection in accordance with the provisions of section 6 (3) of the Motor Traffic Ordinance.
- 13. These Rules shall come into force on the 1st day of January, 1928.

EVERY weight, measure and weighing instrument must be verified and stamped by the inspector with a stamp of verification under the Weights and Measures Ordinance, 1912, and a certificate of justness issued with respect to all weighing and measuring apparatus used for trade purposes.

- 2. The Weights and Measures Office situate opposite the Police Headquarters, Government Road, Nairobi, will be open to the public as from January 3rd, 1928. All traders may submit their weights and weighing instruments for examination and stamping between the hours of 8-30 a.m. and 4 p.m. (Saturdays excepted).
- 3. Every set of articles must be accompanied by a completed requisition form (obtainable on application) and the stamping fees paid before the articles are returnable. A trader may submit his apparatus in separate portions on different dates to avoid dislocation of business should he so prefer.
- 4. All weights and measures must be clean and free from dirt, grease and rust.
- 5. Instruments which are immovable, or having an actual dead weight exceeding 250 lbs. will be examined upon trader's premises on application on payment of the usual fees.


