KENYA COLONY AND PROTECTORATE
(BOUNDARIES) ORDER IN COUNCIL, 1921:

PROCLAMATION.

L.S.

By His Excellency Sir Edward William Macleay Grigg, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Companion of the Distinguished Service Order, upon whom His Majesty has conferred the decoration of the Military Cross, Lieutenant Colonel in His Majesty's Army (retired), Governor and Commander in Chief of the Colony and Protectorate of Kenya:

IN EXERCISE of the powers conferred upon me by Article 3 (1) of the Kenya Colony and Protectorate (Boundaries) Order in Council, 1921, I, with the approval of the Secretary of State, do hereby declare that the district hitherto known as "Malindi District" shall be known as "Kilifi District" and Proclamation No. 54 of the 25th day of February, 1924, as amended by Proclamation No. 25 of the 27th day of February, 1925, is amended accordingly.

thence in a south-easterly direction following the western boundary of Farm L.O. No. 1980 to the north-western corner of Farm L.O. No. 4741;

thence in a north-easterly direction following the northern boundary of Farm L.O. No. 4741 to the northern corner of that portion;

thence in a south-easterly direction following the north-eastern boundaries of Farms L.O. Nos. 4741 and 4744 to the eastern corner of the latter portion;

thence in a north-easterly direction following the northern boundary of Farm L.O. No. 2017 to the north-western corner of that portion;

thence in a south-easterly direction following the north-eastern boundaries of Farms L.O. Nos. 2017 and 2007 to the eastern corner of the latter portion;

thence in a southerly direction following the western boundaries of Farms L.O. Nos. 2009, 3526, 3527 and 3528 to the north-eastern corner of Farm L.O. No. 2008;

thence in a south-westerly direction following the northern boundary of Farm L.O. No. 2008 to the north-western corner of that portion;

thence in a southerly direction following the western boundaries of Farms L.O. Nos. 2008 and 3524 to the south-western corner of the latter portion;

thence in a south-westerly direction following the southern boundary of Farm L.O. No. 4720 to the south-western corner of that portion;

thence in a northerly direction following the western boundary of Farm L.O. No. 4720 to the north-eastern corner of Farm L.O. No. 4754;

thence in a south-westerly direction to the north-western corner of that portion;

thence in a south-westerly direction in a straight line to the top of the Kakuzi Hills;

thence in a south-easterly direction following the top of the Kakuzi Hills to a point on Farm L.O. No. 1544 where the Kakuzi Hills end;

thence in an easterly direction in a straight line through a portion of Farms L.O. Nos. 1544 and 4607 to the south-western corner of Farm L.O. No. 2307;

thence in a south-easterly direction following the northern boundaries of Farms L.O. Nos. 4607, 2287, 3581, 2289/R, 4934 and 3582 to the north-eastern corner of Farm L.O. No. 3582;

thence in a south-westerly direction following the eastern boundary of Farm L.O. No. 3582 to the Thika River;

thence in an easterly and northerly direction following the Thika River down-stream to its junction with the Tana or Kiloluma River;

thence in a westerly direction following the Tana or Kiloluma River up-stream to its junction with the Thaba River;

thence in a westerly direction following the Thaba River up-stream to its junction with the Thara River;

thence in a southerly direction following the Thara River up-stream to where the western boundary of Farm L.O. No. 324 intersects the Thara River, the point of commencement.

(2) An area on either side of the Thika River including all points within a distance of 400 yards of any point on that river commencing at the intersection of the north-western boundary of Farm L.O. No. 4607 and the said river and ending at the intersection of the south-eastern boundary of Farm L.O. No. 3582 and the said river.

And further I do hereby declare that the following Proclamation and portion of a proclamation are revoked:—

Proclamation No. 125, dated the 28th day of November, 1923.

That portion of Proclamation No. 86, dated the 2nd day of November, 1927, declaring Farms L.O. Nos. 4715 and 5224, Messrs. Ward Bros., Manyatta, Subukia, Nakuru District, to be infected areas (Trypanosomiasis).

SPEED LIMITS—NAIROBI MUNICIPALITY.

IN EXERCISE of the powers conferred upon him by section 15 (1) of the Motor Traffic Ordinance (Chapter 68 of the Revised Edition), His Excellency the Governor in Council has been pleased to prescribe the following speed limits for motor cars and motor cycles driven within the boundaries of the Nairobi Municipality :—

1. (a) Within the limits of the area defined in paragraph (1) of the Schedule hereto or upon any road forming part of the boundary of such area or upon any approach to any such road within a distance of 200 yards therefrom ; and
- (b) Upon such portions of roads as are specified in paragraphs (2), (3) and (4) of the said Schedule or upon any approach to any such portion within a distance of 200 yards therefrom ... 15 miles per hour
2. Upon any public road elsewhere within the boundaries of the Nairobi Municipality ... 25 miles per hour

This Notice shall have effect as from the second day of April, 1928.

THE CUSTOMS TARIFF ORDINANCE, 1927.

Notice is hereby given that as from the 1st May, 1928, the provisions of the Customs Management Ordinance, 1926, the Customs Tariff Ordinance (Chapter 50 of the Revised Edition), and the Customs Tariff Ordinance, 1927, will be strictly applied to goods imported into or exported from the Colony and Protectorate of Kenya across the Kenya-Italian East African frontier.

In order to facilitate the proper control of this traffic His Excellency the Governor has been pleased to appoint Wajir a Port of Entry for purposes of Customs, with effect from 1st May, 1928, and arrangements for the establishment of a Customs office and godown at Wajir are being made accordingly.

On and from that date, all goods imported into the Colony and Protectorate of Kenya *via* the Kenya-Italian East African frontier must be produced for Customs entry and examination and the proper duties chargeable thereon under the Customs Tariff Ordinances must be paid before delivery can be allowed. Goods intended for export must be similarly produced and entered prior to transportation to Italian East Africa.
