A Bill to Supply a Further Sum of Money for the Service of the Year Ended 31st December, 1927.

BE IT ENACTED by the Governor of the Colony of Kenya with the advice and consent of the Legislative Council thereof :—

1. This Ordinance may be cited as "The Supplementary Appropriation Ordinance, 1928." Short title.

2. The Public Revenue for the period 1st January to 31st December, 1927, and other funds of the Colony and Protectorate of Kenya are hereby charged towards the service of the period 1st January to 31st December, 1927, with a further sum of ninety-two thousand eight hundred and thirty-three pounds, seventeen shillings and nine cents, in addition to the sums provided by the Appropriation Ordinance No. 32 of 1926. Public Revenue charged.

3. The money granted by this Ordinance shall be applied to the purpose and services expressed in the schedule annexed hereto. Application of money granted.

4. The Treasurer of the Colony and Protectorate of Kenya is hereby given authority for having paid out of the Revenue and other funds of the Colony and Protectorate of Kenya, for the several services specified in the schedule, the said sum of ninety-two thousand eight hundred and thirty-three pounds, seventeen shillings and nine cents, which have come in course of payment during the period 1st January to 31st December, 1927.
