PROCLAMATION.

IN EXERCISE of the powers thereunto enabling me, I hereby declare the Area defined in the Schedule hereto to be free from East Coast Fever, and I hereby further declare that the said area shall be known as a "Clean Area" for the purposes of Rules under the Diseases of Animals Ordinance.

## SCHEDULE.

### NORTHERN CLEAN AREA.

The area bounded as follows :—

Commencing at the intersection of the Anglo-Italian boundary with the Lak Dera;

thence westerly by the Lak Dera to the Lorian Swamp and onwards following the river E. Uaso Nyiro up-stream to the point where the Meru-Archer's Post road crosses that river;

thence southerly by that road for a distance of approximately 7 miles to a post;

thence still southerly by a line of posts to a post on the Nyeri-Meru old road;

thence westerly by that road to the Eastern Marania River;

thence south-westerly by the Meru District Boundary (as defined by Proclamation No. 54 of the 25th February, 1924) to the summit of Mount Kenya;

thence south-westerly by a straight line to the most southerly corner of Farm L.O. No. 4353;

thence north-westerly by part of the south-western boundary of that portion to its intersection with the Rongai River;

thence following that river down-stream to its junction with the Amboni River;

thence following that river up-stream to its intersection with the north-eastern boundary of the Laikipia Forest Reserve;

thence westerly by that boundary to the south-western corner of Farm L.O. No. 3402;

thence south-westerly by a straight line to the most northerly corner of Farm L.O. No. 1286/1;

thence southerly by the western boundaries of the Aberdare and Kikuyu Escarpment Forest Reserves to the northern 100-foot zone of the Kenya and Uganda Railway;

thence by a straight line due south across the Kenya and Uganda Railway to the southern boundary of the southern 100-foot zone;

thence westerly by that zone to its intersection with the western boundary of Farm L.O. No. 2976/7;

thence south-westerly by part of that boundary to the most southerly corner of Farm L.O. No. 1708;

thence westerly by the southern boundary of that portion to its south-western corner;

thence westerly by straight lines to the Trigonometrical Beacon Ol Lonogot and onwards to the most easterly corner of Farm L.O. No. 2662 on the boundary of the Masai Native Reserve;

thence in a generally westerly and northerly direction by that boundary to the most northerly corner of Farm L.O. No. 1316;

thence north-easterly by a straight line to the north-western corner of Farm L.O. No. 4336;

thence easterly and northerly by the generally eastern boundary of the Nakuru Lake Forest Reserve to the low water mark on Lake Nakuru;

thence northerly, easterly and southerly by that low water mark to its intersection with the northern boundary of Farm L.O. No. 3983 extended thereto;

thence north-easterly by the northern boundaries of that portion and of Farm L.O. No. 3982 to the north-eastern corner of the latter portion and onwards by the latter boundary extended across the Kenya and Uganda Railway to its eastern 100-foot zone;

thence southerly by that zone to the north-eastern corner of Farm L.O. No. 434;

thence easterly by the northern boundary of that portion to its north-eastern corner;

thence northerly and south-easterly by the western and northern boundaries of Farm L.O. No. 4477 to the Mororoni River;

thence by that river down-stream to the north-western corner of Farm L.O. No. 440/2;

thence easterly by the northern boundary of that portion to its north-eastern corner;

thence northerly by part of the western boundary of Farm L.O. No. 3984 and the western boundaries of Farms L.O. Nos. 4682 and 465/2 to the north-western corner of the last portion;

thence north-easterly and northerly by the southern and easterly boundaries of the Nakuru Forest Reserve to the most northerly corner of Farm L.O. No. 1282/1;

thence south-westerly by a straight line to the most northerly corner of Farm L.O. No. 4725;

thence in a generally south-westerly direction by the northern and part of the western boundaries of Farm L.O. No. 4724 and the north-western boundary of Farm L.O. No. 3662 to the western corner of the latter portion;

thence by part of the north-western boundary of Farm L.O. No. 442/3 to its intersection with the south-western boundary of Farm L.O. No. 4560 extended across the road reserve;

thence north-westerly by that extended line and the south-western boundary of Farm L.O. No. 4560 to the most western corner of that portion;

thence northerly and north-easterly by the western and part of the north-western boundaries of that portion to the most easterly corner of Farm L.O. No. 4559;

thence northerly and westerly by the eastern and northern boundaries of that portion to the south-western corner of Farm L.O. No. 3660;

thence northerly by the western boundaries of that portion and of Farms L.O. Nos. 2847, 2848, 2849, 2850, 5630 and 2676/R to the north-western corner of the last portion;

thence westerly by part of the southern boundary of Farm L.O. No. 3232 to the south-western corner of that portion;

thence northerly by the western boundaries of Farms L.O. Nos. 3232, 2678, 5233 and 2679 to the north-western corner of the last portion;

thence westerly by the southern boundary of Farm L.O. No. 3630 to the south-western corner of that portion;

thence in a generally northerly direction by the eastern boundaries of the Kamasia and Njempa Native Reserves, as defined in Government Notice No. 394 of the 11th October, 1926, to the height shown on Topographical Sheet No. North A 137/S, as 4141;

thence in a generally westerly direction by the generally southern boundary of the Suk Native Reserve, as defined in Government Notice No. 171 of the 18th May, 1920, to the Kerio or Ndo River;

thence southerly and westerly by the boundary of the Marakwet Native Reserve, as defined in the aforesaid Government Notice, to the junction of the Chebyemit and Moyben Rivers;

thence by the south-western boundary of the Marakwet Native Reserve, as defined in Government Notice No. 394 of the 13th October, 1926, to its north-western corner at the most northern corner of Farm L.O. No. 2156;

thence north-westerly by the southern boundary of the Suk Native Reserve, as defined in the said Government Notice No. 394, to its south-western corner on the Kenya-Uganda Boundary;

thence northerly by that boundary to its intersection with the Anglo-Egyptian Sudan Frontier;

thence easterly by that Frontier and the Abyssinian Frontier to the Anglo-Italian Boundary;

thence southerly by the Anglo-Italian Boundary to its intersection with the Lak Dera, the point of commencement.

## GOVERNMENT NOTICE No. 284.

## THE ROADS PROTECTION ORDINANCE.

## ORDER.

## SOUTH LUMBWA DISTRICT.

IN EXERCISE of the powers vested in him by section 3 of the Roads Protection Ordinance, 1924, His Excellency the Governor has, with the concurrence of the Local Authority within the meaning of the said section, been pleased to order that the road branching from the main Litein-Monieri Road, 4 miles from Litein and running to Chemagel Police Station, and from this point across the Kipsonoi River to its junction with the Monieri-Manga Road, and also the deviation from below the Chemagel Police Station across the Kipsonoi River on to Farm No. L.O. 4779, shall be closed to all kinds of wheeled traffic except the following :—

- (a) Pedal cycles;
- (b) Motor cycles with or without sidecar attachments;
- (c) Light buckboards or carts used for carrying passengers only;
- (d) Motor vehicles not exceeding 3 tons gross weight when loaded, excluding those with metal tyres.

## GOVERNMENT NOTICE No. 285.

## THE DISEASES OF ANIMALS ORDINANCE.

## RULES.

IN EXERCISE of the powers conferred upon him by section 7 of the Diseases of Animals Ordinance (Chapter 157 of the Revised Edition), His Excellency the Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as " the Diseases of Animals Rules, 1928," and shall be read as one with the Diseases of Animals Rules, 1918.

2. In these Rules, unless the context otherwise requires, the term " Clean Area " means an area declared by Proclamation under section 4 of the Diseases of Animals Ordinance to be a Clean Area.

3. It shall be unlawful for any person to move or attempt to move or cause or permit to be moved any cattle into any Clean Area unless such cattle are the property of the owner or occupier or lessee of any land within such Clean Area : Provided that the provisions of this Rule shall not apply to—

- (a) any cattle being moved for slaughter; or
- (b) any cattle moved by virtue of a permit from the Veterinary Officer of the district concerned, or such other person as may be specifically authorised in writing in that behalf by the Chief Veterinary Officer; or

- (c) any transport cattle which are immune to East Coast Fever and branded with the Government Registered Brands K.T., L.T., and T., or other Government registered brand indicating immunity to East Coast Fever, and such cattle may be moved to and from into and within such Clean Area.

For the purposes of these Rules any cattle found straying or strayed shall be deemed to have been moved by the owner and by the person actually in charge of such cattle.

4. It shall be unlawful for any person to keep or permit to be kept any cattle in any Township within a Clean Area without a permit in that behalf issued to him by the Veterinary Officer of the District concerned or by such other person as may be specifically authorised in writing by the Chief Veterinary Officer to issue such permits.

GOVERNMENT NOTICE NO 286.

THE DISEASES OF ANIMALS ORDINANCE.

RULES.

IN EXERCISE of the powers conferred upon him by section 7 of the Diseases of Animals Ordinance (Chapter 157 of the Revised Edition), His Excellency the Governor in Council has been pleased to make the following Rules :—

1. These Rules may be cited as “ the Diseases of Animals District and Farm Inoculations Rules, 1928,” and shall be read as one with the Diseases of Animals Rules, 1918.

2. Whenever treatment to immunize stock against disease is undertaken on a farm or in a district or area, every person owning or having charge of stock on such farm or within such district or area shall, on being required thereto by a Veterinary Officer or Stock Inspector, present all susceptible stock on such farm for treatment, notwithstanding that such stock may be the property of other persons.

3. On an application made by the owner or person having charge of any stock the Veterinary Officer or Stock Inspector carrying out such treatment may at his discretion exempt any stock from treatment, provided that if so requested he shall furnish the owner, occupier or manager of the farm with his reasons in writing for such exemption.

4. The owner, occupier or manager of a farm shall be responsible to Government for the collection and payment of all fees in connection with treatment carried out on his farm, notwithstanding that the stock dealt with may be the property of other persons.

5. Such fees paid by the owner, manager or occupier in respect of services rendered shall be recoverable by him at law from the owner or person having charge of the stock treated.

## GOVERNMENT NOTICE NO. 287.

## THE WIRELESS TELEGRAPHY ORDINANCE.

## RULES.

IN EXERCISE of the powers conferred upon him by the Wireless Telegraphy Ordinance (Chapter 118 of the Revised Edition) as amended by the Wireless Telegraphy (Amendment) Ordinance, 1927, His Excellency the Governor in Council has been pleased to make the following Rules:—

1. These Rules may be cited as "The Wireless Telegraphy Rules, 1928," and shall come into operation on the 1st day of July, 1928.

2. The Postmaster General may issue a dealers' licence (hereinafter referred to as "a licence") permitting any person to sell, let on hire or otherwise dispose of complete broadcasting receivers or any of the following component parts of such receivers:—

- (i) Valves and valve holders,
- (ii) Loud speakers,
- (iii) Head telephone having a resistance of over 300 ohms,
- (iv) Variable telephone condensers,
- (v) Crystals or other minerals in general use as detectors or rectifiers for reception of wireless signals,
- (vi) Tuning inductance coils,
- (vii) Inter valve transformers and coupling units,

and no person shall trade by way of selling, letting on hire, or otherwise disposing of any of the foregoing apparatus unless and until such licence has been issued to him.

3. The licence shall only be issued and available in respect of a particular address or place of business which shall be stated in the licence, and shall not authorize the licensee to exercise such licence in respect of any other address or place of business without the consent of the Postmaster General being first obtained. The licence is not transferable.

4. Every licensee holding a licence under these Rules shall cause to be exhibited in a prominent and conspicuous position on his premises the following notice:—

"Licensed Wireless Dealer."

5. The fee for a licence shall be ten shillings per annum payable in advance.

6. No person shall sell, let on hire or otherwise dispose of any apparatus referred to in Rule 2 hereof to any person unless satisfied that such person holds a broadcasting receiving licence or other licence authorizing him to use such apparatus.

Provided that a licensed dealer who holds a wireless demonstration licence may supply, for test or observation, a prospective purchaser, who is not the holder of a wireless receiving licence, with a complete receiving set, but such set shall not be so used for a longer period than seven days.

7. The licensee shall keep a record of all sales, hirings and disposals of the apparatus referred to in Rule 2 hereof, and such record shall be open at all reasonable times to inspection by the Postmaster General or any officer authorized by him in that behalf.

8. Any person other than a licensee under these Rules who imports any of the apparatus referred to in Rule 2 hereof shall notify the Postmaster General in writing of such importation and furnish particulars of the apparatus imported within a period of 14 days.

GOVERNMENT NOTICE N<sup>o</sup> 288

THE DISEASES OF PLANTS PREVENTION  
ORDINANCE.

RULES.

IN EXERCISE of the powers conferred upon him by section 3 of the Diseases of Plants Prevention Ordinance (Chapter 155 of the Revised Edition), His Excellency the Governor in Council has been pleased to make the following Rules:—

1. These Rules may be cited as “the Locust Rules, 1928.”

2. In these Rules—

(a) “Ordinance” means the Diseases of Plants Ordinance;

(b) “Locusts” shall mean the insects *Schistocerca peregrina*;

(c) “Hoppers” shall mean immature locusts that are not yet able to fly.

3. Every occupier of land on which locusts deposit their eggs shall immediately give notice of the fact to the nearest Police Officer and shall state the locality on his land where such eggs have been laid and such other information as may be required.

4. No occupier of land shall be deemed to be exempt from Rule 3 above by reason of temporary absence from the farm at the time when such eggs were deposited.

5. Wherever any such notice shall have been given as aforesaid to a Police Officer such officer shall communicate same immediately to the Director of Agriculture, who may thereupon take whatever action may appear to him advisable.

6. As soon as any hoppers shall appear on any land the occupier thereof shall forthwith—

- (i) give notice of the fact to the nearest Police Officer;
- (ii) use his utmost endeavours to destroy the said hoppers by the adoption of such measures and the use of such materials as are recommended by the Director of Agriculture.

7. No person shall wilfully drive or attempt to drive or permit hoppers to be driven on to his neighbours' land.

8. In the event of any occupier failing to give the notice required in Rules 3 and 6 (i) above, or failing to destroy the hoppers in the manner prescribed under Rule 6 (ii), the Director of Agriculture or any person authorised by him may carry out the destruction and the occupier shall be liable for any expenditure thereby incurred.

9. The Director of Agriculture may appoint inspectors under these Rules, and such inspectors shall have the power to enter upon any land where locusts are believed to be or to have been for the purpose of carrying out all or any of these Rules.

10. Any person who without lawful excuse obstructs an inspector in the discharge of his duties under these Rules, or who refuses to permit an inspector to enter upon his land, or refuses to carry out the instructions of an inspector in the discharge of his duties under these Rules, or who otherwise contravenes any of the provisions of these Rules shall be guilty of an offence and shall on conviction be liable to a fine not exceeding £100 or in default of payment thereof to imprisonment of either description for a term not exceeding three months.

4. Each purchaser shall pay to the auctioneer immediately on the fall of the hammer a deposit of 25% of the purchase money. In default of such payment the plot may be immediately re-offered for sale, and any subsequent bid by the person who has made default may be ignored or refused.




