# An Ordinance to Alter the Time within the Colony and Protectorate of Kenya.

30th June, 1928.

Date of commencement.

ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

- 1. This Ordinance may be cited as "the Alteration of Short title. Time Ordinance, 1928."
- 2. At and after midnight on the 30th day of June, 1928, Alteration of time within the Colony and Protectorate shall be deemed to be and shall be three hours fast on Greenwich mean time.



# Mombasa Township Plots.

NOTICE is hereby given that grants in respect of the plots at Mombasa specified in the Schedules hereto will be sold by auction in the Jubilee Hall, Mombasa, on Saturday, the 7th July, 1928, commencing at 10 a.m.

Plans of the plots may be seen at the offices of the Survey and Registration Department, Nairobi and Mombasa, or may be had on application to the Survey Department, Mombasa, on payment of Shs. 4, post free.

The right to withdraw any plot from the auction is reserved to the Commissioner for Local Government, Lands and Settlement.

In the following general and special conditions of sale the term "Authority" means the "Responsible Authority" defined by the Mombasa Town Planning Scheme, 1926, or such other municipal authority as may be hereafter established by law.

# GENERAL CONDITIONS OF SALE.

- 1. Each plot will be auctioned separately.
- 2. The amount of the advance of each bid will be regulated by the auctioneer and no bidding shall be retracted.
- 3. The highest bidder will be the purchaser, but if any dispute arise as to any bid, the plot will be reoffered at the last undisputed bid.
- 4. Each purchaser shall pay to the auctioneer immediately on the fall of the hammer a deposit of 25% of the purchase money. In default of such payment the plot may be immediately reoffered for sale and any subsequent bid by the person who has made default may be ignored or refused.
- 5. Each purchaser shall on paying the deposit inform the auctioneer of the name or names of the person or persons on whose behalf the plot is purchased; the grant will be issued in accordance with this information.
- The balance of the purchase money, together with the rent due to the 31st December, 1928, the survey fees, the fees payable for the preparation and registration of the grant (Shs. 110), and the stamp duty payable in respect of the grant and all other expenses, if any, shall be paid to the Resident Commissioner, Mombasa, within seven days from the date of the sale, and upon such payment being duly made the purchaser shall, subject to the provisions of the Crown Lands Ordinance, 1915, and if if the conditions of sale have been complied with, be entitled to a grant of the plot, which grant shall be presented to him duly executed as soon as conveniently may be. Provided that the balance of the purchase money shall not be payable within the time stated or thereafter unless and until the Commissioner for Local Government, Lands and Settlement can present to the purchaser the grant of the plot duly executed.
- 7. Subject to the proviso contained in Condition No. 6 if the amounts therein mentioned are not paid to the Resident Commissioner, Mombasa, within seven days from the date of sale, the Commissioner for Local Government, Lands and Settlement may order the deposit made by the purchaser to be forfeited, and the purchaser shall have no further claim to a grant of the plot.

- 8. The Government or such person or authority as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains, service pipes, telegraph or telephone wires, and electric mains of all descriptions whether overhead or underground, and the grantees shall not erect any building in such a way as to cover or interfere with any existing routes, main or service pipes or the telegraph or telephone wires and electric mains aforementioned.
- 9. No building shall be erected on any plot unless plans (including block plan showing the position of the buildings), drawings, elevations and specifications thereof shall have been previously approved in writing by the Commissioner for Local Government, Lands and Settlement or such other person as he may appoint. The purchaser of the plots enumerated in Schedule II, which will be sold as one plot, shall erect within two years of the commencement of his grant a building of approved design constructed of stone, burnt brick or concrete on proper foundations for use as a Cinema Theatre; the foundations of such building shall be laid and the work of erection shall be in progress within one year of the commencement of the grant. The cost of erecting such building shall be not less than Shs. 150,000.
- 4. The grantee shall not at any time subdivide the plot or assign or sublet any portion of the plot without the consent of the Governor.
- 5. At no time during the term of the grant shall any plot enumerated in Schedules I and II or any portion thereof or any building erected on the plot be used for the purpose of carrying on any trade or business which has been declared or may be hereafter declared to be dangerous or offensive by notice in the Official Gazette.
- 6. Verandahs may be erected within a road reserve with the previous consent of the Authority and must conform to a building line decided upon by such Authority.
- 7. The grantee shall conform in all respects with the Mombasa Building Rules, all local regulations, and with the provisions of the Mombasa Town Planning Scheme, 1926.
