COLONY AND PROTECTORATE OF KENYA. THE TOWNSHIPS ORDINANCE.

Rules.

IN EXERCISE of the powers conferred upon him by section 3 of the Townships Ordinance (Chapter 82 of the Revised Edition), His Excellency the Governor in Council has been pleased to make the following Rules:—

- 1. These Rules may be cited as "the Machakos Township (Grazing Fees) Rules, 1928.
- 2. All bonâ fide transport oxen, all Government-owned stock, and stock in charge of Government shall be allowed to graze free of charge to owners in that part of the Machakos Township which is marked on Land Surveys Boundary Plan No. 18 as No. 1491/2.

Provided that this shall not exempt the owners of any impounded stock from payment of the usual pound fees.

- 3. Any holder of a plot in Machakos Township who pays rent for the same shall be granted the right to graze free of charge three cows with their calves in the above-mentioned area in addition to transport oxen. The District Commissioner may at his discretion grant grazing free of charge for such time as he may deem fit for oxen about to be slaughtered as butchers' meat.
- 4. No person shall allow any animal suffering from any disease mentioned in paragraph (4) of section 2 of the Diseases of Animals Ordinance (Chapter 157 of the Revised Edition), or mentioned in any proclamation made under the said paragraph to graze within the Township. Any person committing a breach of this Rule shall on conviction be liable to a penalty not exceeding ten pounds, or to imprisonment of either description for a term not exceeding three months, or to both such fine and imprisonment.
- 5. Except as provided by Rules 2 and 3 hereof the following fees shall be payable by the owners of stock grazing in the above-mentioned area:—

Cattle: Cts. 50 per head per month or part thereof.

Sheep or

Goats: Cts. 25

The fees payable under this Rule shall be paid in advance and the receipt shall state the name of the owner, the number of cattle and sheep or goats to which it refers, and the period for which it shall be in force.

6. Notwithstanding anything in these Rules it shall be within the discretion of the District Commissioner to decide how many head of cattle shall be allowed to be grazed by any owner within the Township and if necessary to refuse grazing at any time.

NOTICE is hereby given that grants in respect of the plots on the mainland, in the Changamwe area, specified hereto, will be sold by auction in the Jubilee Hall, Mombasa, on Monday, the 20th August, at 10 a.m.
