WHEREAS by section 2 of the Indian and Colonial Divorce Jurisdiction Act, 1926, it is enacted that His Majesty may, by Order in Council, provide for applying the provisions of section 1 of the said Act, subject to the necessary modifications, to any part of His Majesty's dominions other than a self-governing dominion (as therein defined) in like manner as they apply to India, and, in particular, such Order in Council may determine the Court by which the jurisdiction conferred by those provisions is to be exercised:

AND WHEREAS the Colony of Kenya is a part of His Majesty's dominions other than a self-governing dominion as aforesaid:

AND WHEREAS it is expedient to provide for applying the aforesaid provisions of the said Act to the Colony of Kenya:

NOW, THEREFORE, His Majesty, by virtue and in the exercise of the powers in this behalf by the Indian and Colonial Divorce Jurisdiction Act, 1926, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

- 1. This Order in Council may be cited as "the Kenya Divorce Jurisdiction Order in Council, 1928."
- 2. On and after the first day of October, 1928, the provisions of the first section of the Indian and Colonial Divorce Jurisdiction Act, 1926, shall apply to the Colony of Kenya in like manner as they apply to India.
- 3. In the application of the said provisions to the said Colony—
  - (a) the Court which is to exercise the jurisdiction thereby conferred shall be the Supreme Court of Kenya, and references in the said first section to a High Court in India shall be read as references to such Supreme Court;
  - (b) references in the said first section to India shall be read as references to Kenya; and
  - (c) the reference to the Secretary of State in Council of India in the said section shall be read as referring to the Secretary of State for the Colonies.

#### KENYA AND UGANDA RAILWAYS AND HARBOURS.

#### NOTICE.

Alterations and Amendments to Harbour Tariff Book No. 1, dated the 1st April, 1928.

THE undermentioned alterations and amendments to Harbour Tariff Book No. 1, dated the 1st April, 1928, have been approved by the High Commissioner for Transport.

Clause 16, page 15.—Delete the wording of clause 16 appearing on page 15, and substitute the following therefor:—

#### 16. CHARGES ON CARGO AND MERCHANDISE.

The tonnage of general cargo and merchandise (including cased oils passed over the quays) will be calculated as per Bill of Lading tonnage, a Bill of Lading ton being deemed to be the unit of weight measurement or value upon which any particular Bill of Lading is based.

Oils, coal and other minerals imported or exported in bulk are excluded from the terms of the following Schedules:—

#### (a) Imports:

1. Wharfage 1 per cent. ad valorem. For the purpose of assessment of wharfage dues, the value shall be deemed to be the landed value accepted by the Customs Department together with any import duties chargeable on the goods under the Customs tariff in force at the date of receipt by the Administration of the relative document as defined in clause 28 of this Tariff.

In calculating wharfage dues, no deduction will be made in respect of reductions in handling charges allowed under clause 28 of this Tariff.

2. Handling Shs. 4 per B/L ton (minimum charge Shs. 2).

In the case of cargo conveyed by lighter between Kilindini Harbour and the Old Port (and vice versa) an additional sum of Shs. 2 per Bill of Lading ton will be charged for such lighterage in the case of imports, and Sh. 1 per Bill of Lading ton in the case of exports.

Clause 21 (a), page 21.—Delete the word cased "in both clause 21 (a) and its footnote.

Clause 21 (a), page 21.—Add the word "towage" after the word "lighterage."

Clause 21 (e), page 21.—Delete the words "or part thereof" appearing in the fifth and sixth lines.

Clause 24, page 22.—Delete the words "and on Stacking Ground" appearing in the heading.

Substitute the words "per crane per hour or part thereof" for the words "per hour or part thereof" appearing in the first, second and third lines.

Add the following sub-clause:-

Use of Cranes by the Public on Stacking Grounds.

deadweight ton

During working hours (minimum charge Sh. 1) ... ... 2 00

Other than working hours (minimum charge Sh. 1/50) ... 2 50

Clause 28, page 23.—Insert the words "of ships" after the words "of notice" appearing in the fifth and sixth lines.

Insert the following after the words "Port Administration's Offices" appearing in the sixth line:—

In the case of cargo to be lightered to the Old Port, 24 hours additional will be allowed.

Clause 28, page 23.—Insert the following notes at the foot of the page:—

Note 1.—Where a consignment of less than one ton is stacked part in shed and part on a stacking ground, the minimum charge applicable to the location of the larger quantity shall apply to the whole.




