THE TRAFFIC ORDINANCE, 1928.

NOTICE.

IT IS HEREBY notified for public information that after the 30th June, 1929, no licences will be issued in respect of any two-wheeled cart drawn by oxen for use on any road within the boundaries of Nairobi Municipality, unless such cart conforms to the following specification :—

1. *Axle*.—The axle must be made from specially hardened steel. It must measure at least four feet between collars, which must be rigid and of sufficient size to ensure effective bearing for the bushes. It must be tapered evenly with a smooth surface to receive the bushes, and the tapered portion must be of an average section of at least 2 inches diameter. It must be slotted near the ends to receive steel pins for effective retention in position of bearing plates, which must be sufficiently large to ensure even rotation of the wheels.

2. *Bushes*.—Each bush must be made from specially-hardened steel drilled to fit evenly over the tapered end of the axle, and having a grease recess of at least $\frac{1}{4}$ inch depth and 2 inches length.

The thickness of the metal must be at least $\frac{1}{2}$ inch throughout the length of the bush, which must be at least $11\frac{1}{2}$ inches.

Each bush must have rigid nave fitting lugs, preferably cut or cast from the solid during construction.

3. *Naves*.—Each nave must be made of thoroughly seasoned hard wood, free from flaws, and of a diameter of at least 9 inches and a length of at least 12 inches, bored to ensure a tight driven fit to each bush. Stout iron bands must be shrunk and screwed on to each nave to prevent splitting of the timber.

4. *Tyres*.—Each tyre must be at least 4 inches wide, shrunk on to thoroughly seasoned hardwood felloes, it must be screwed to such felloes in at least six places evenly spaced round the circumference of the wheel, with screws counter-sunk and finished flush with the wearing surface of the tyre.

5. *Brake*.—An efficient and easily accessible brake must be fitted to each wheel and connected to an operating wheel or handle in such a way that each will exert an even and simultaneous braking pressure on the wheels.

CEYLON PENSION MINUTES.

IT IS HEREBY NOTIFIED, for the information of all officers of this Government who may have previously served in the Colony of Ceylon, that, in terms of the amendment of the Ceylon Pension Minutes, dated 31st August, 1928, they should inform the Colonial Secretary, Ceylon, or the Crown Agents for the Colonies, whether they elect to exercise the option of receiving on retirement a gratuity in lieu of a quarter of the pension for which they may be eligible from the funds of that Colony.

2. This option is exerciseable within the periods specified in section 2A, sub-section (2) of the Pension Minutes. A copy of this section appears below.

3. The fact that an officer has been permitted to exercise the option will not in itself confer upon him any claims to pension, annuity or retiring allowance. His claims will remain open to investigation until a pension has actually been granted.

“ 2A. (1) An officer to whom a pension or annuity is granted under these regulations may, at his option, exerciseable as hereinafter provided, be paid, in lieu of such pension, a pension at the rate of three-fourths of such pension, together with a gratuity equal to ten times the annual value of the reduction so made in the pension.

“ (2) The option referred to in sub-section (1) shall be exerciseable :—

(a) In the case of an officer who, if he had been retired on grounds of ill-health on October 1st, 1927, might have been granted a pension under these regulations not later than February 28th, 1929.

(b) In the case of any other officer, within one month after the earliest date on which, if retired on grounds of ill-health, he might be awarded a pension or annuity under these regulations, or not later than February 28th, 1929, whichever shall be the later date for exercising the option.

“ Provided always :—

(i) That an officer who has previously had the opportunity of exercising the option, but has not done so and who is still in the service of the Colony or in any other public service, may apply within one month of his subsequent marriage for permission to exercise the option, which permission may be granted at the Governor's discretion after examination of the officer by a Government Medical Board ;

- (ii) That the date of the exercise of the option shall be deemed to be the date of the receipt of his written notification addressed either to the Colonial Secretary in the Colony or to the Crown Agents for the Colonies; or in any case falling under the preceding proviso, the date on which the Governor grants permission to exercise the option; and
- (iii) That, if an officer has exercised the option, his decision shall be irrevocable so far as concerns any pension ultimately to be granted to him under these regulations."

MILNER MEMORIAL SCHOLARSHIPS.

The following Circular despatch of the 30th October, 1928, with its enclosure, from the Secretary of State for the Colonies is published for general information :—

“ Sir,

I have the honour to transmit to you a copy of a memorandum which I have received from the Headmaster of the King's School, Canterbury, setting out details of the scholarship scheme which has been arranged at the School as a memorial to the late Viscount Milner, and I should be glad if you would take steps as are necessary to bring the scholarships to public notice locally.

2. In the great majority of the oversea territories concerned it seems probable that candidates for the scholarships would be undergoing education in this country and in these cases the need of arrangements for a local examination overseas would not arise, but in order to ensure facilities being made available for any prospective candidates who may be receiving their education overseas I have agreed to suggest that arrangements may be made with the local education authority to conduct the necessary written examination and transmit the papers to Canterbury as soon as possible thereafter.

KING'S SCHOOL, CANTERBURY.

MILNER MEMORIAL SCHOLARSHIPS.

Five Milner Memorial Scholarships have recently been founded at the King's School, Canterbury, under a Trust Deed, out of funds collected by the Lord Milner Memorial Committee, to perpetuate the memory of the work done for the British Empire by the late Lord Milner. Their value is £100 a year for five years, and one Scholarship will be awarded each year. Candidates must be over 13 and under 14 years of age on 24th June. These Scholarships are open to “ boys of British parentage and European descent

- (i) whose fathers are or have been members of the permanent establishment of the Civil Services in India, the Colonies not possessing responsible Government, Protectorates, or the territories administered under mandate by His Majesty's Government in Great Britain, or in ‘ Iraq, Egypt, or the Anglo-Egyptian Sudan; or

- (ii) whose fathers not being or having been members of the permanent establishment nevertheless have been continuously employed in any such service for a period of not less than ten years; or
- (iii) whose parents or surviving parent reside in some part of the British Empire where facilities for Secondary Education are for the time being insufficient or inadequate."

In awarding these Scholarships account will be taken of—

- (a) intellectual ability as decided by a brief written examination;
- (b) character;
- (c) the financial circumstances of the parent or guardian.

The names of candidates for the Scholarships to be awarded in 1929 must reach the Headmaster, the King's School, by 1st May, 1929, at the latest, with a letter stating fully the grounds on which the candidate claims to be eligible for the Scholarship. Applications must be accompanied by a copy of the boy's birth certificate, and a full testimonial as to his character, ability at work or games, capacity for leadership, etc., from his present or more recent schoolmaster or tutor. It must also be accompanied by a statement as to the financial circumstances of the parent or guardian on a special form which may be obtained from the Headmaster. This information will be treated as strictly confidential.

Boys who are being educated in England will be expected to come to Canterbury for the written examination on 26th June. Boys who are being educated overseas will sit for the examination on the same date under regulations to be made by their local education authority, to whom copies of the paper will be sent, and who will return the answers to England for correction and comparison. Applications on behalf of candidates overseas must be accompanied by the name and address of the local education authority to whom papers are to be sent.

LABOUR ENGAGED AT THE PORT OF MOMBASA FOR THE WORKING OF IN-COMING SHIPS.

THE High Commissioner for Transport has approved of the following additional clause (38) being embodied in Harbour Tariff Book No. 1, dated 1st April, 1928, with effect as from the date hereof.

38. PORT LABOUR KEPT WAITING OWING TO NON-ARRIVAL OF SHIPS.

“ Advice as to the expected arrival time of a ship, together with particulars of the port labour required in connection therewith, must be furnished to the Port Manager by 4-0 p.m. on the previous day where the vessel is expected the following morning, and by 10-0 a.m. where the vessel is expected during the afternoon.

“ In the event of a ship not arriving until after the stated time, and port labour having to stand by awaiting the vessel's arrival, the actual cost of such labour for a period not exceeding five hours will be debited against the Steamship Company concerned.

“ This applies to both working and overtime hours.”

ANTI-LOCUST-HOPPER ORGANISATION—
SETTLED AREAS.

A tour has been made of the settled areas. Meetings with representatives of the selected Locust Committees were held at Gilgil, Nakuru, Ravine, Lumbwa and Eldoret. At Kitale the District Committee was met.

The scheme of organisation adopted throughout was the farm group method. Groups of farms from five to ten in number are made. One farmer is nominated to act as section leader. All farmers in the group agree to assist in the destruction of hoppers on any farm within the group both personally and by the loan of equipment—water tanks, oxen, debbies, and by the loan of labour. It has also been everywhere agreed that if a group is unable to destroy the hoppers within its boundaries then it may ask for and receive assistance from contiguous groups of farms. Njoro District is prepared to assist an adjoining district if required.

The grouping is to be decided by the various Locust Committees, and the farmers in the group select their leader. He is expected to compile the list of contributions which will be made by each farmer, and will call these into action when and if necessary. The section leader is expected to keep contact with a district leader—generally the President or Secretary of the Local Farmers' Association or a person nominated by the district for the purpose. This district leader is able to keep contact with the administrative officer of the district either directly or through the district locust officer.

The equipment for each district at present is under the control of the administrative officer, but when operations commence all equipment will be at the disposal of the locust officer appointed for distribution.

In view of the fact that there are in some districts a number of unalienated farms, a locust officer is to be appointed and provided with a small nucleus staff of natives for the purpose of overlooking the unalienated land and as much of the unoccupied land as may require it. Where possible unoccupied land is to be overlooked by the neighbouring farmers in the group.

Thus the organisation is very much along the same lines as obtains in the Natives Reserves where the inhabitants of a location are responsible for the work of destruction in a location and may be asked to assist in work on adjoining locations. The equity of the arrangement will be realised when it is considered that it is purely a matter of luck or ill-fortune whether locusts lay on one farm or another of a group or in one group and not in the adjoining one.

Should the resources of a district be inadequate to deal with the hoppers in the area it is intended to reinforce the effect of the district by a force of natives and the employment of more locust officers, but this only as a last resource and after the step has been strongly recommended, after examination.

Locust officers are to be recommended for the Gilgil, Naivasha, Thomson's Falls Area, the Nakuru District, Lumbwa Plateau and Trans Nzoia. Laikipia already has one.

Meetings are to be held in Thika for the Fort Hall, Ruiru, Donyo Sabuk Areas, and at Machakos for the Machakos settled areas.

LOCUST REPORT UP TO 17-1-29.

Kerio Province.—In Turkana the main infested areas are the Karpeddo-Kamuge Area, the Kalo-wenyang River, the Turkwell River from Lokwiyen to Loiapuwa, and from Lokichar to Loiapuwa. Destruction taking place in all these areas.

The swarm reported near Mount Lokapel has been destroyed. The newly hatched swarm at the source of the Khalabata River has been cleared up. A swarm at Kakurio has been destroyed.

The area round Kateruk is heavily infested with hoppers which are being destroyed. Laying is reported in the region about Lake Rudolph. Natives in Turkana are working well at destruction.

In Suk.—The area Turkwell-Gorge 50 miles southwards to Masol—one very large swarm destroyed. In the direction of Nepua Pass smaller infestations in Kateruk, Kamuneno, Chepropo and Lokwien are being dealt with, as also laying areas.

In Kamasia the main infestation is about Pakka, and in Karpeddo, to which point a road has been completed from Marrigat, much destruction has taken place, hoppers are now in the last stage, and a number are mature.

In the above areas of the Province small flying swarms of pink locusts are to be seen, their movement is generally east.

Northern Frontier Province.—The infestation around Ngombe Crater is practically destroyed. Hopper swarms along the Marsabit Road have been destroyed as also swarms in the direction of Merto. Infestation at Kipseng destroyed, at Kauro small swarms are entering the flying stage. The Kipseng area has been sprayed clear of hoppers. Considerable destruction has taken place in the region of Barsaloi.

The Lesser Locust Bird and the ordinary Locust Bird are now present and breeding in the Northern Frontier. During last week flights of these birds were observed flying north over Nakuru. The work of birds was observed in the Gilgil-Longonot area in July, and it is anticipated that very great numbers of birds will be found in the area shortly.

Four locust officers have been poisoned and have received treatment.

The infestation in the Northern Frontier Province is so widespread that only a proportion of the hoppers may be destroyed before reaching the

winged stage. South-eastern Sudan and Abyssinia are heavily infested also.

Ukamba-Kitui.—Destruction is now nearing completion in many areas despite the new hatchings, and the situation is much relieved. It has again been observed that when the swarm organisation is broken the remnants collapse due to natural agencies.

Hoppers are getting older and more active and are travelling great distances. Fire is now being employed effectively.

Kongo-Tsavo.—Extensive hatchings are reported in native shambas and in sisal lands in this area. Action is being taken and staff and equipment being augmented.

Voi.—Hoppers are being dealt with on sisal estates quite satisfactorily.

In the Voi area the situation is well in hand. Bura-Mwatate area is practically clear, but scouting is carried on in view of the second laying.

Mbololo-Kedai.—Large areas cleared of hoppers. Main work now in the Maji Mazuri area.

Serengetti Area.—Maktau and Mbunyuni areas cleared, but there is a large infestation at Sabta. Mgange, situation in hand, as also Taveta. At Masai progress is slow owing to dense bush.

Coast—Kilifi.—This area is now practically clear.

Malindi.—Successful operations continuing on north bank of river.

Tanaland.—Staff re-inforced, spraying proving very effective.

Masai Reserve.—Negative reports from scouting party.

SETTLED AREAS.

Nanyuki District.—The locust officer reports—inspections have been made of a number of areas which were visited by mature swarms in the past. To date no trace of eggs or hoppers has been found.

From the positions occupied by locusts to-day in order to invade the agricultural areas of the Colony, swarms must fly south, south-west or west, the swarms have much other choice—the remaining points of the compass. There are other factors which may lessen or increase the chances according to the direction from which they operate.

There are seventy-five locust officers appointed; seventy-three are in the field.

Subject to the proviso contained in Condition No. 6, if the amounts therein mentioned are not paid as therein laid down within seven days from the date of the sale, the Commissioner for Local Government, Lands and Settlement may order the deposit made by the purchaser to be forfeited, and the purchaser shall have no further claim to the grant of the plot.

(B) GENERAL.

1. The Government or such person or authority as may be appointed for the purpose shall have the right to enter upon any plot and lay and have access to water mains, service pipes, telegraph or telephone wires, and electric mains of all descriptions, whether overhead or underground, and the grantees shall not erect any building in such a way as to cover or interfere with any existing routes, main or service pipes, or the telegraph or telephone wires and electric mains aforementioned.

2. No building shall be erected on any plot unless plans (including block plan showing the position of the buildings), drawings, elevations and specifications thereof shall have been previously approved by the Authority and by the Commissioner for Local Government, Lands and Settlement, or such other person as he may appoint. Such plans, etc., shall be submitted in triplicate to the Senior Commissioner, Nakuru, for necessary action.

3. The term of each grant will be 99 years from the 1st day of March, 1929.

4. The grantee shall not at any time subdivide the plot, or assign, sublet or otherwise dispose of any portion of the plot without the previous consent of the Governor.

5. Any building erected shall conform to a building line decided upon by the Authority.

(C) SPECIAL CONDITIONS IN RESPECT OF BUSINESS PLOTS (SCHEDULES I AND II).

1. The plots enumerated in Schedule No. II may be used for the combined purpose of business and residence; those in Schedule No. I shall be used for business purposes only.

2. In the case of plots to be used for the combined purposes of business and residence, not more than one half of the area of any such plot shall be built over.

3. In the case of plots to be used for business purposes only, not more than ninety per cent. of the area of any such plot shall be built over:

Provided that in no case shall the area of any such business plot required to remain unbuilt on be less than 300 square feet, and that the said area shall be free from any erection thereon above the level of the ground, except latrine accommodation constructed in accordance with all laws and by-laws in force relating thereto, and in accordance with a design approved by the Local Authority.

Such open space shall be at the rear of the building, and shall extend along the entire width of the building or for a distance of not less than 30 feet, whichever shall be the lesser, and the distance across such open space from every part of the building to the rear boundary of the plot shall be not less than 10 feet.

4. Each purchaser of a plot in Schedule No. I shall erect within two years of the commencement of his grant a building of approved design constructed of stone, burnt brick, or concrete, on proper foundations.

5. Each purchaser of a plot in Schedule No. II shall erect within two years of the commencement of his grant a building of approved design constructed of stone, burnt brick, concrete, asbestos, wood or iron, on proper foundations.

6. At no time during the term of the grant shall any plot or any portion thereof or any building erected on the plot be used for the purpose of carrying on any trade or business which has been or may be declared to be dangerous or offensive by notice in the Official Gazette.

7. Verandahs may be erected within a road reserve with the previous consent of the Authority and must conform to a building line decided upon by such Authority.

(D) SPECIAL CONDITIONS IN RESPECT OF RESIDENTIAL PLOTS (SCHEDULES No. III AND No. IV).

1. Each purchaser of a plot in Schedule III shall erect within two years from the commencement of his grant a dwellinghouse of approved design to be built of stone, burnt brick, or concrete, on proper foundations.

2. Each purchaser of a plot in Schedule No. IV shall erect within two years from the commencement of his grant a dwellinghouse of approved design to be built of stone, burnt brick, concrete, asbestos, wood or iron, on proper foundations.

3. No building shall at any time during the term of the grant be used for any other purpose than a dwellinghouse.

4. At no time during the term of the grant shall more than one dwellinghouse with the necessary offices and outbuildings be erected on any plot without the consent of the Governor, and the grantee shall not without such consent subdivide the plot, or assign or sublet any portion of the plot.

5. The grantee shall not at any time during the term of the grant erect any building or buildings so as to cover more than one-half of the area of the plot.

6. All outbuildings, offices, etc., shall be properly sited and screened from view to the satisfaction of the Authority or such other person as may be appointed and shall be kept so screened during the term of the grant.
