IN EXERCISE of the powers conferred upon me by section 4 of the Local Government (District Councils) Ordinance, 1928, I do hereby declare the area described in the Schedule hereto to be a District under the jurisdiction of a District Council, to be known as the Uasin Gishu District.

## SCHEDULE.

Boundaries of the Uasin Gishu District Council Area.

Commencing at trigonometrical beacon Olessos on the Uasin Gishu Administrative District Boundary as defined by Proclamation No. 54 of 25th February, 1924;

thence bounded in a north-westerly and south-westerly direction by that Administrative District boundary to the southern corner of L.O. No. 3167;

thence by the south-western boundary of that portion to its western corner;

thence by a straight line north-westerly to the trigonometrical beacon Kakaroua;

thence by a beaconed line bearing approximately 0° 30′ for about 18,107 feet to a beacon;

thence bearing approximately 341° 30′ for about 6,168 feet to a beacon at the end of a spur;

thence bearing approximately 356° for about 5,054 feet to a beacon on the lower of the two summits of the hill Kaikomor;

thence bearing approximately 7° for about 3,800 feet to a beacon;

thence bearing approximately 292° 30′ for about 2,244 feet to a beacon;

thence bearing approximately 7° 30′ for about 5,944 feet to a beacon on the southern boundary of L. No. 4282 (5598);

thence westerly by parts of that southern boundary and of that of L.O. No. 4126 to the trigonometrical beacon Osorongai on the Uasin Gishu Administrative District Boundary;

thence by that district boundary westerly, northerly and north-easterly to the northern corner of L.O. No. 2211;

thence by the north-eastern and part of the eastern boundaries of L.O. No. 2211 to the north-west corner of L.O. No. 2210;

thence by the northern boundary of the latter portion and the eastern boundaries of the same portion and of L.O. No. 3047 and part of that of L.O. No. 2226 to the north-west corner of L.O. No. 2227;

thence by the northern boundary of the last portion to its north-east corner on the Cherangai River;

thence by that river down-stream to the north-west corner of L.O. No. 3046;

thence by the northern and eastern boundaries of that portion;

thence by the northern boundary of L.O. No. 4635 to its intersection with the eastern boundary of the Uasin Gishu Administrative District boundary on the Moyben River;

thence by that district boundary southerly and westerly and south-easterly to the cairn on the eastern shore of Sergoit Lake:

thence bearing 149° 15′ 15″ for about 12,624 feet to a beacon:

thence by a straight line south-easterly to the north-east corner of L.O. No. 4473 (1559/3) on the said district boundary;

thence in a generally southerly direction by that administrative district boundary to its intersection with the northern boundary of Ravine Administrative District;

thence in a generally easterly and southerly direction by that latter district boundary to its intersection with the western boundary of L.O. No. 503 (Lembus Forest Concession);

thence southerly by that western boundary to the southeast corner of L.O. No. 1866;

thence westerly by the southern boundaries of L.O. Nos. 1866 and 6260;

thence northerly by the south-western boundary of the latter portion to its most western corner on the Uasin Gishu Administrative District Boundary;

thence by that district boundary westerly, southerly, westerly and northerly to the point of commencement.

Such area as may from time to time be defined as Eldoret Municipality, within the above-described boundaries, is excluded from the Uasin Gishu District Council area.

## THE NATIVE FOODSTUFFS ORDINANCE.

(Chapter 135 of the Revised Edition).

PROCLAMATION.

#### J. W. BARTH.



BY His Excellency Sir Jacob William Barth.
Knight, Commander of the Most Excellent
Order of the British Empire, Acting
Governor and Commander-in-Chief of the
Colony and Protectorate of Kenya, in
Executive Council.

WHEREAS by section 3 of the Native Foodstuffs Ordinance (Chapter 135 of the Revised Edition) it is provided that where it has been made to appear to the Governor in Council that any district or area is suffering from or threatened with a shortage of native foodstuffs, he may issue a proclamation (a) prohibiting the purchase or barter of such foodstuffs generally or of any class or classes of the same, for the purpose of resale in or export from the district or area in such proclamation specified, unless the written permission of the Resident Commissioner or District Commissioner, as the case may be, be first obtained; (b) prohibiting the export of such foodstuffs generally or of any class or classes of the same from any district or area; (c) prohibiting the use of such foodstuffs or of any class or classes of the same for the manufacture of liquor in any district or area; (d) prohibiting the concealment or destruction of such foodstuffs or any class or classes of the same in any district or area:

AND WHEREAS it has been made to appear to me that the Meru, Embu, South Nyeri, Fort Hall and Kyambu Districts are threatened with a shortage of native foodstuffs:

NOW THEREFORE by virtue of the powers vested in me as aforesaid, and having taken the advice of my Executive Council, I do hereby prohibit—

- (a) the purchase or barter of maize, beans, mtama, mwele, potatoes, yams, sweet potatoes, bananas and all other fruits, roots and grain commonly used as food by natives for the purpose of resale in or export from the Meru, Embu, South Nyeri, Fort Hall and Kyambu Districts unless the written permission of the respective District Commissioners of the said districts be first obtained;
- (b) the export of any such native foodstuffs from the said districts;

- (c) the use of any such native foodstuffs for the manufacture of liquor in the said districts;
- (d) the concealment or destruction of any such native foodstuffs in the said districts.

#### THE FOREST ORDINANCE.

#### Rules.

IN EXERCISE of the powers conferred upon him by the Forest Ordinance (Chapter 149 of the Revised Edition), His Excellency the Acting Governor in Council has been pleased to make the following Rules:—

- 1. These Rules may be cited as "the Forests (Coast Native Reserves) Rules, 1929."
- Subject to any special Rule applicable to any forest area in any of the Native Reserves in the Coast Province, no person shall fell, cut, take, work or remove any trees growing in any of the Native Reserves in the Coast Province, hereinafter referred to as "the Coast Native Reserves", without having first obtained such licence in writing as is provided in Rule 3 hereof: Provided always that nothing in these Rules contained shall extend or apply to the case of any native felling, cutting or removing any tree or timber for the purpose of erecting any native hut or house for habitation in the Coast Native Reserves or making any canoe for his own use or cutting or collecting wood or forest produce for his own use as fuel or for other domestic purposes: And provided further that a District Commissioner, in regard to so much of the Coast Native Reserves as shall be situate in his district, may, anything in these Rules to the contrary notwithstanding, on being satisfied that any person or persons, firm or company is or are under a contract or contracts to supply firewood to the Kenya and Uganda Railways and Harbours, grant in the form set out in Part III of the Schedule hereto, for the purposes of such contract or contracts, and for such purposes only, a free licence in writing to any person or persons, firm or company to fell, cut, take or remove any trees growing in the Coast Native Reserves to such number or amount (if any) as he may specify in such licence without payment of the royalties prescribed by these Rules; saving always that in any such free licence as aforesaid such District Commissioner may in his absolute discretion except from the operation of the said licence such trees as he shall specify therein.
- 3. Application for any such licence as is referred to in the preceding Rule shall be made to the District Commissioner of the district in which the trees or timber in respect of which application is made are situate, and such District Commissioner shall thereupon grant a licence in writing to the applicant subject to the conditions and in the form specified in Part I of the Schedule hereto: Provided always that the decision of the District Commissioner as to the number of trees of each species respectively to be included in such licence shall be final and without appeal.
- 4. The holder of any such licence as aforesaid shall transport the trees and/or the logs or timber hewn or sawn from the trees in respect of which such licence is granted to such place as the said District Commissioner shall specify in the licence in order that the same may be measured for the purpose of calculating the amount of royalties payable; and no such trees, logs or timber, as the case may be, shall be removed from such place until the royalties prescribed by these Rules have

been paid and a permit in writing obtained from the person to whom such royalties have been paid authorising the removal of the same. Such permit in writing shall be in the form specified in Part II of the Schedule hereto.

5. (1) There shall be paid by the holder of a licence granted pursuant to Rule 3 hereof or by the applicant for a removal permit pursuant to Rule 4 hereof, as the case may be, the following royalties:—

- (2) There shall be paid for firewood despatched by rail from the Coast Native Reserves a royalty of Sh. 20 per 10-ton truck load or part thereof.
- (3) Firewood cut in the Coast Native Reserves which is not sent by rail shall be stacked for measurement in accordance with the condition of a permit issued under Rule 4 of these Rules and there shall be paid a royalty of Cts. 6 per stacked cubic foot.
- 6. Any person contravening any of the provisions of these Rules or any of the terms or conditions of any licence issued under these Rules shall be deemed to be guilty of an offence under the Forest Ordinance.
- 7. The Rules dated the 3rd day of October, 1917 (Government Notice No. 341), The Forest (Payment of Royalties) Rules, 1919, The Forest (Payment of Royalties) Amendment Rules, 1919, and The Forest (Payment of Royalties) Rules, 1927, are hereby revoked.

# DEPARTMENT OF AGRICULTURE.

LOCUST REPORT UP TO 30TH JANUARY, 1929.

# KERIO PROVINCE.

Kateruk Area.—Now clear of hoppers.

Tyaa Area.—Destruction of young hoppers proceeding, but fresh young swarms are still hatching out near to Lodwar.

Lake Area.—From Lokichar Border at Kerio Naramet to the north as far as the Kolaloi River, some eighty miles, hoppers are hatching. Two officers with native labour are working there.

The Turkana people have turned out well for work and have effected much destruction, particularly by grass burning.

Suk.—No operation report to hand.

Niemps and Northwards.—Operations ceasing. No operation report to hand. Staff being withdrawn.

# NORTHERN FRONTIER PROVINCE.

Operations almost at an end, and a portion of the staff is being withdrawn. Large swarms of pink flying locusts have come into the Barsaloi-Isiolo-Meru area from the north, and the inaccessible parts of the province. The tendency of movement is south-easterly.

Hopper destruction, on a large scale, is taking place in the Barsaloi-Barajoi District, whilst in all other working areas, the remaining hoppers are being mopped up.

# UKAMBA PROVINCE.

Kitui.—There has been a general reshuffling of staff due to a large number of locust areas having been cleaned up. All areas save Tiva and Yatta report that only small hopper swarms are now met with.

The southern area is practically clear. Reports from the eastern and southern area indicate that flying swarms continually enter from Galla country.

Konza-Tsavo.—The Masongaleni area was reported clear of hoppers by noon of 23rd January.

Mbioizau.—Reported clear of hoppers on 18th January.

Darajani-Tsavo.—All hoppers have been scouted, and all accessible have been sprayed, the area is now almost clear.

Locust Train.—Was at Masongaleni on 22nd January, went as far as Kibwezi, and on the 23rd January sprayed all hoppers further down the line towards Tsavo.

# VOI.

Near Voi small hopper swarms are being dealt with.

Bura-Mwatate.—No further hatchings, clear.

Mbololo.—Clear except for small swarms on the mountain, which are being dealt with and destroyed.

Excellent work being done by driving, beating and burning.

Taveta.—Only a few swarms remain to be destroyed.

Masau.—Isolated swarms being dealt with.

Serengeti.—Tank truck operating on the few swarms found.

Kilulunyi.—A track of 7 miles has been cut to assist in operations.

Athi River.—Reports being verified.

The situation in this district reveals that the hopper infestation is well under control, and the whole area should be cleared up very satisfactorily.

# MASAI RESERVE.

This area has been well scouted, but a portion remains to be completed. The hopper swarm near Rombo is under control. Masai natives are not enthusiastic in the work of destruction.

# COAST AREAS.

No progress report to hand.

# LAIRIPIA.

Small swarms of hoppers are reported near the Sugeroi River. Action is being taken.

# FLYING SWARMS.

Flying swarms from the east and north have demolished native crops in Meru, Chuka and Embu, some have been damaged at Fort Hall. In Machakos damage has been done to both native crops, wheat and maize fields, and fruit orchards.

In the Nanyuki-North Kenya area, wheat crops are being destroyed.

On the Coast, bananas and coconuts have been stripped, and maize and millets consumed.

Small flying swarms are moving south down the Rift Valley. Fears are entertained for the food crops in Elgeyo.

There are fears of food shortage in certain districts, and holders of harvested food crops should exercise all care to see that there is no undue waste.

In view of the enormous size of the swarms, the most strenuous efforts will need to be made to move the locusts when they settle.


