A Bill to Amend the Specific Loan Ordinance, 1927.

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows:—

1. This Ordinance may be cited as "the Specific Loan Short title. (Amendment) Ordinance, 1929," and shall be read as one with the Specific Loan Ordinance, 1927, hereinafter referred to as No. 22 of "the Principal Ordinance."

2. Section 4 of the Principal Ordinance is hereby repealed Amendment and the following section is substituted therefor:—

of section 4 of Principal Ordinance.

"4. Contribution to sinking fund as contemplated by sections 14 and 28 of the General Loan and Inscribed Cap. 46. Stock Ordinance shall commence in respect of any stock or debentures issued under this Ordinance not later than three years after the date from which the interest on such stock or debentures shall commence to run."

OBJECTS AND REASONS.

The Crown Agents for the Colonies have pointed out that the wording of section 4 of the Specific Loan Ordinance, 1927, is not in accordance with the latest model Specific Loan Ordinance, and accordingly this Government has decided to remedy the defect by replacing section 4 of the Principal Ordinance by Clause 4 of this Bill.

LOCUST REPORT TO 17TH APRIL, 1929.

CONCENTRATIONS of locusts are now found in the following areas:—

- 1. Nand.-Plateau.—This concentration moves about chiefly in the forest near Kapsabet, being dislodged by storms, and driven in various directions, but returning to the forest.
- 2. Laikipia-Plateau.—This concentration moves about between Mount Kenya and the Marmonet Escarpment, flying in a large circle. The swarms are over half mature.
- 3. Voi District.—Five swarms of rapidly maturing locusts appear to be approaching Voi from Ndi, Maktau, Tsavo. Swarms are now bunching together, and conditions may permit of flame throwing. Egg laying is not verified, but is strongly suspected—mating has been observed. Laying is reported from Bissel, in the Masai Reserve.
- 4. Tanaland.—There is a concentration in this region.
- 5. Lumbwa-Elburgon.—There is a concentration here, having a tendency to move east.
- 6. Naivasha-Kijabe.—Swarms rapidiy maturing arrived from the south, and are diffused in this area.
- 7. A swarm is moving between Kajiado and Ngong.

Two sections of flame throwers are in the field attempting a reduction in the size of the swarms. The work is meeting with some success. Flame throwing apparatus has also been sent to Voi, although we are not sanguine of good results.

Weather conditions continue to favour the locusts in that the days are hot and dry, and what rain falls is either light or patchy so that swarms are able to avoid severe drendings, and mortality is not heavy.

Tanganyika reports egg laying confirmed in several areas, and as laying swarms have travelled northwards, we may expect that the southern areas of the Colony will become breeding grounds. There is also a strong probability that laying will shortly be observed in settled areas. In view of the fact that laying is known to have taken place in uninhabited areas in Tanganyika, mature swarms may be expected to pass northwards over this Colony later in the year.

There is practically no doubt therefore that we shall suffer invasion again, which, however, will be considerably mitigated if rains become heavy and continuous. All poison depôts have been visited, and there is a sufficiently large accumulation of stores to cope with such hopper areas as are accessible to us.


