MUNICIPALITY OF MOMBASA.

THE LOCAL GOVERNMENT (MUNICIPALITIES)
ORDINANCE, 1928.

MOMBASA BY-LAWS No. 2 OF 1930.

IN EXERCISE of the powers conferred upon it by the Local Government (Municipalities) Ordinance, 1928, the Mombasa Municipal Board, with the approval of His Excellency the Governor, has made the following By-laws:—

1. These By-laws may be cited as “the Mombasa Municipality (Public Service Vehicles and Motor Lorries) By-laws, 1930.”

2. In these By-laws, unless the context otherwise requires:—

“Public service vehicle” means a vehicle propelled by means of mechanism contained within itself, carrying either passengers or goods or materials for hire or reward.

“Motor omnibus” means any public service vehicle licensed to carry more than six passengers.

“Taxicab” means any public service vehicle licensed to carry not more than six passengers, whether it is fitted with a taximeter or not.

“Tractor” means a motor vehicle designed for towing one or more trailers.

“Trailer” means a vehicle attached to or drawn by a motor vehicle whether its weight is partly supported by a motor vehicle or otherwise, but does not include a side-car attached to a motor cycle.

“Motor lorry” includes any motor vehicle designed and used for the transport of goods or materials, and any tractor, but shall not include a motor vehicle with a box body, the chassis of which was designed to carry a touring, saloon or similar body for the conveyance of passengers.

“Street” means any highway, road or sanitary lane or any land reserved for a highway, road or sanitary lane, and includes any bridge, footway, square, court, alley or passage, whether a thoroughfare or not.

“Inspector” means any person appointed to inspect vehicles under the law relating to traffic and includes any person appointed thereto by the Board under the next succeeding By-law.

PUBLIC SERVICE VEHICLES.

3. The Board shall appoint one or more inspectors whose duty it shall be to examine every public service vehicle, and no public service vehicle shall be registered under these By-laws until the inspector shall have furnished a certificate that such vehicle complies with all the requirements of the law relating to traffic, and that such vehicle is in all respects fit to be driven in the streets.

4. Every public service vehicle shall be registered annually, and no public service vehicle shall be driven in the streets unless it has been registered under these By-laws for the current year.

5. All registrations in respect of public service vehicles shall expire on the 31st day of December in each year.

6. Application for registration of a public service vehicle shall be made to the Town Clerk who shall, upon production of the certificate mentioned in By-law No. 3, and upon payment of the fee prescribed in Schedule I of these By-laws, register the vehicle accordingly.

7. The owner of a registered public service vehicle shall be provided by the Town Clerk with a metal plate bearing the registration number of the vehicle, and shall cause the same to be attached to the vehicle in such a position and manner as the Town Clerk shall direct, and every public service vehicle shall at all times have such plate so attached.

8. The owner of a registered public service vehicle shall, when applying for re-registration, return to the Town Clerk the plate previously provided therefor.

9. All motor lorries, tractors and trailers (whether or not they be public service vehicles) shall be registered subject to the provisions of By-laws Nos. 3 to 8.

10. Notwithstanding anything hereinbefore provided it shall be lawful for the Town Clerk, if he be so directed by the Board, to refuse to register any taxicab or omnibus in excess of a number to be stated in such direction, and any taxicab or omnibus which is, in his opinion, insufficiently clean or comfortable or tidy in appearance.

DRIVERS.

11. No public service vehicle shall be driven at any time by any person other than a person specially licensed thereto under these By-laws except as provided in the law relating to traffic for the driving of a motor vehicle by the holder of a general identification mark.

12. Every person driving a public service vehicle shall, in addition to the certificate of competency required by the law relating to traffic, be specially licensed in this regard, and no such licence shall be granted to any person unless he shall have first been examined, and the Superintendent of Police shall have furnished a certificate in the form prescribed in Schedule II to these By-laws. This licence shall be valid only for the year of issue, but may be renewed yearly, free of charge, under the signature of the Superintendent of Police, provided that the latter is satisfied that the driver is still qualified in accordance with the provisions of Schedule II.

13. Application for a licence to drive a public service vehicle shall be made to the Town Clerk who shall, upon production of the certificate mentioned in By-law No. 12, and upon payment of the fee prescribed in Schedule I of these By-laws, issue the appropriate licence and enter the name of the holder in a register.

14. The holder of a licence to drive a public service vehicle shall be provided with the Town Clerk with a special badge, and shall wear such badge on the outside of the right arm between the shoulder and the elbow whenever he is in charge of a public service vehicle.

15. It shall be the duty of the driver of a public service vehicle to report forthwith to the nearest police station any accident in which he is involved causing injury to any person or property.

16. It shall be the duty of the driver of a public service vehicle to return to the nearest police station any property found in such vehicle.

TAXICABS.

17. In addition to any other contrivance there may be for securing passengers' luggage on the running-board, every taxicab shall be provided by the owner with a luggage carrier at the rear of the car.

18. All luggage shall be adequately secured within or upon the luggage carrier provided, and shall not project beyond the maximum width of the taxicab, and no luggage shall be carried on the wings or bonnet.

19. No person shall ride in a taxicab except on the seats provided for that purpose.

20. No person other than the driver and a *bona fide* passenger shall occupy any seat in a taxicab, and no taxicab shall at any time carry passengers in excess of the number allowed by the licence for such taxicab.

21. Every taxicab shall exhibit in a conspicuous place within the vehicle a tariff of fares in accordance with Schedule III of these By-laws, and fares shall be charged and paid accordingly, and no fare in excess of such tariff shall be demanded. Such tariff of fares shall be exhibited on a card fitted into a container having a transparent cover so that the tariff can be plainly read through the same. The Town Clerk shall issue such card to any applicant, and shall charge therefor the fee prescribed in Schedule I of these By-laws.

22. Every taxicab shall be maintained in a clean condition.

23. No taxicab driver shall allow his vehicle to remain in a street (except when actually engaged on hire) in any place other than a taxicab rank set aside by the Board and demarcated as such.

24. Notwithstanding the provisions of By-law No. 23, it shall be lawful for an engaged taxicab whilst waiting for the passenger who has engaged it to occupy any place set aside by the Board and demarcated as a stand for private vehicles.

25. No person suffering from an infectious or contagious disease shall be in charge of or ride in a taxicab. Should any person so suffering have been permitted by inadvertence or otherwise to ride in a taxicab, it shall be the duty of the driver forthwith to take his taxicab to the Health Office for disinfection.

26. No person in charge of a taxicab shall refuse to accept any offer of engagement from any person (except from a person prohibited by By-law No. 25), unless such taxicab is actually hired for the whole or portion of the time for which such other person desires to engage it or unless such taxicab is returning to its quarters after work.

27. No driver of a taxicab shall accept an additional passenger or additional passengers en route without the permission of the other passenger or passengers already in such taxicab.

28. Any person in charge of a taxicab may be required by the hirer thereof to wait at any place to which the hirer may have proceeded in such taxicab: Provided that no taxicab shall wait in any place so as to cause obstruction to traffic.

29. No driver of a taxicab shall solicit for engagement.

30. No driver of a taxicab not standing in a taxicab rank shall accept a passenger within a radius of one hundred yards of such rank.

31. The drivers of the first two taxicabs standing in any rank shall remain in their seats ready for hire.

32. For the purpose of taking up or depositing a passenger or load, a driver of a taxicab shall not stop such taxicab except at the side of the road.

33. No driver of a taxicab shall smoke whilst driving a *bona fide* passenger in his car.

34. Every driver of a taxicab shall conduct himself with civility and propriety towards every person seeking to hire or being conveyed in such vehicle.

35. Every driver of a taxicab shall be clean in person and clothing, and shall wear a full-length dust-coat of white or khaki material with full-length sleeves.

36. Any taxicab may be hired either by time or distance, but the hirer shall inform the person in charge thereof at the time of hiring whether he intends to hire such taxicab by time or by distance. In the absence of any such arrangement, the hirer will be charged by distance.

37. Any person calling for or sending for a taxicab and thereafter failing to employ the same shall pay the fare prescribed in Schedule III from the place from which such taxicab shall have come to the place to which such taxicab shall have proceeded as a result of such calling or sending.

38. No person hiring a taxicab shall wilfully or negligently injure the same or refuse to pay the fare prescribed in Schedule III.

39. All taxicabs shall take their stand on any taxicab rank appointed for that purpose in order of their arrival, and on any person calling for a taxicab, the front taxicab shall go forward and no other, and the place vacated by any taxicab

moving off the rank shall be occupied by the taxicab immediately behind it, and all other taxicabs shall drawn up in like order.

40. At every taxicab rank a board shall be fixed showing the number of taxicabs allowed on the rank, and no driver of a taxicab shall bring or attempt to bring his car on to any rank at which there shall be already the full number of taxicabs allowed.

MOTOR OMNIBUSES AND MOTOR LORRIES.

41. It shall be the duty of every owner and driver of a motor omnibus or motor lorry at all times to keep such vehicle in good mechanical repair.

42. The inspector shall, at the time of furnishing the certificate required by No. 3 of these By-laws, fix, in the case of each motor omnibus, the number of passengers exclusive of the driver which such omnibus may carry and, in the case of each motor lorry, the weight of the load such motor lorry may carry, and such number of passengers and such weight shall be inserted in any licence issued in respect of such vehicle, and observance of the limits so imposed shall be obligatory upon the owner and the driver.

OMNIBUSES.

43. No motor omnibus shall ply in the streets for hire by passengers without a clearly printed tariff of charges approved by the Board exhibited in a conspicuous place, and all passengers shall be bound to make payment accordingly, and the owner or driver shall not demand payment in excess of such tariff.

44. No baggage or parcels shall be placed on a motor omnibus in such a position as to impede the free ingress and egress of passengers.

45. No person shall travel on the footboard or mudguard or elsewhere on the outside of a motor omnibus or lorry.

46. Nos. 22, 34 and 35 of these By-laws relating to the conduct of drivers, and No. 25 relating to the state of both drivers and passengers in taxicabs shall apply *mutatis mutandis* to drivers of and passengers in motor omnibuses.

MOTOR LORRIES.

47. No motor lorry shall engage or solicit for engagement for the carriage of passengers for hire.

48. No motor lorry shall be loaded so that the load—

(a) exceeds ten feet in height from the ground level; or

(b) projects laterally so as to exceed seven feet in total width at any point; or

(c) projects more than six feet behind, unless a special permit shall have been given to the owner or driver of such lorry authorising the carrying of a tail load of greater length.

49. Trailers shall not be hauled by tractors on any roads without the permission of the Municipal Engineer, except the following, namely :—

- (a) Kilindini Road from the Treasury to Kilindini Customs ;
- (b) Salim Road ;
- (c) Station Road from Kilindini Road to the Railway Goods Shed.

SPEED LIMITS.

50. The following speed limits shall not be exceeded :—

- (1) Within the limits of the area defined in Schedule IV to these By-laws or upon any road forming part of the boundary of such area or upon approach to any such road within a distance of 100 feet therefrom, 15 miles per hour ;
- (2) Upon any road elsewhere upon Mombasa Island, 25 miles per hour.

51. Notwithstanding anything contained in the last preceding By-law, the speed at which a motor omnibus or motor lorry may be driven on any road shall not exceed 20 miles an hour ; provided that

- (1) if the tare weight of the motor omnibus or motor lorry exceeds 30 cwt. the speed shall not exceed 12 miles per hour ;
- (2) if the motor omnibus or motor lorry draws a trailer, the speed shall not exceed 8 miles per hour.

GENERAL PROVISIONS.

52. All licences and badges issued under the law relating to traffic or under these By-laws shall be produced on demand by any police officer or any inspector appointed under these By-laws.

53. (a) Any person contravening any of these By-laws shall be guilty of an offence, and shall be liable on conviction to a fine not exceeding three hundred shillings or to imprisonment of either description for a term not exceeding one calendar month or both.

(b) Any owner or driver who permits a public service vehicle to be driven in contravention of By-law No. 11 shall be guilty of an offence, and in any prosecution under By-law No. 11 the burden of proof shall be on the accused person to show that such vehicle was so driven without his knowledge or consent.

54. Conviction under the last preceding By-law shall not render the person convicted immune from civil action by any party aggrieved.

55. The Board may in its absolute discretion, on the conviction by a magistrate of any holder of a licence issued under By-laws Nos. 11 to 16 for any offence against these By-laws or for an offence implying moral turpitude, endorse, suspend or cancel any such licence, and shall cause particulars of every

such endorsement, suspension or cancellation to be entered in the register. Any such cancellation shall operate for such period not exceeding two years as the Board may in each case determine.

56. The Mombasa Vehicle Rules, Part XVI, published in the Schedule to the Subsidiary Legislation (Operation) Rules, 1928, and Parts XVII and XVIII of the Mombasa Township Rules are hereby revoked in so far as they apply to public service vehicles and motor lorries as defined in these By-laws.

DEPARTMENT OF AGRICULTURE.

LOCUST REPORT FOR TWO WEEKS ENDING 30-4-30.

Heavy rains are still prevalent throughout the Colony, with the result that all swarms of locusts are making every effort to reach the more arid and low-lying districts before oviposition takes place.

FLYING SWARMS OR HOPPERS.

Naivasha.—One small swarm of gravid locusts is reported in the Gilgil District, whilst another larger swarm of mixed yellow and pink locusts is moving along the lower slopes of the Kinangop Plateau. It is not considered likely that any extensive laying will take place—at least none that cannot easily be controlled.

Baringo.—Two large swarms of hoppers are reported in the Njemps locations; the Locust Control Officer is proceeding to investigate the situation and effect destruction. Another band of hoppers is reported to be doing damage to the native crops in the Ewalel location. Native headmen and elders have asked for a supply of bran bait to assist them in hopper destruction; this is being arranged under supervision.

Masai.—One Locust Officer has been engaged, and posted to this reserve. In spite of adverse weather conditions, several bands of hoppers have been destroyed by the use of bran bait. An attempt to scout the Lake Natron area was non-effective as roads are impassable, the whole country being under water. The Locust Officer is now trying to reach Laitokitok, and investigate reports of hoppers in that neighbourhood.

Turkana.—The Locust Control Officer has just returned from Northern Turkana, where he carried out a reconnaissance from the Nipay Pass via Lodwar to Lokitaung. There are no hoppers at present in the district, but gravid swarms are laying in an area of about 2,000 square miles, between Lake Rudolf in the east, and the Kuch Mountains in the west. Large bands of hoppers will appear in this area about 15th May.

FOREST DEPARTMENT.

TENDERS FOR BAMBOO CUTTING RIGHTS FOR THE
MANUFACTURE OF PAPER-PULP.

TENDERS are invited for the exclusive right to cut bamboo for the manufacture of paper-pulp over an area of not less than 50,000 acres in the Kikuyu Escarpment Forest Reserve situated between the edge of the Escarpment above the Uganda Railway from Escarpment to Kijabe, and the Southern Chania River on the following main conditions:—

1. The licence shall be for a period of 20 years, but may be renewed for a further period of 20 years on terms to be agreed between the Conservator of Forests and the licensee.
2. The basis of tender shall be a royalty payment per ton of air-dry unbleached pulp, and no tender of less than two shillings per ton will be accepted, provided that for the first 5 years of the licence no royalty on pulp will be charged.
3. An annual licence fee of £100 in respect of the area shall be paid for the first 5 years, the first payment to be made on the issue of the licence; and thereafter for such succeeding year in advance on the corresponding date, and thereafter a licence fee of £500 to be paid as aforesaid in respect of the sixth and seventh years; £1,000 to be paid as aforesaid in respect of the eighth and ninth years, and £2,000 to be paid as aforesaid for each succeeding year, provided that the licensee shall be entitled to set off against the licence fee paid in any one year the royalties payable for the same year, but in no case shall a less sum than the licence fee be paid to the Conservator of Forests.
4. The licensee shall within the area of the licence or within the adjacent Forest Reserve as may be arranged with the Conservator of Forests, erect and complete a factory and subsidiary buildings for the manufacture of paper-pulp within two years from the date of the licence, and such factory shall thereafter be worked for not less than 120 days in each year in the manufacture of paper-pulp. From and after the expiration of five years from the date of the licence the licensee shall produce an annual out-turn from the said factory of at least 10,000 tons of paper-pulp, and from and after the expiration of ten years from the same date an annual out-turn of at least 20,000 tons of paper-pulp.
5. The Conservator of Forests will reserve for the use of the licensee, areas of forest and plantations as conveniently accessible to the site of the factory as possible, sufficient to supply such reasonable quantity of wood fuel as may be required for the factory. Royalty will be payable on all fuel at the rate of two shillings per 100 stacked cubic feet for rough forest fuel, and four shillings per 100 stacked cubic feet for plantation fuel during the currency of the licence: in the event of the licence being renewed for a further period the royalty on fuel will be based on the market rates current at the time of such renewal.
6. The bamboo forest comprising the licence area will be divided by the Conservator of Forests into compartments arranged in cutting series and the licensee shall completely cut out a compartment before entering the next compartment of the same cutting series.

The order in which the said compartments shall be worked will be laid down by the Conservator of

Forests in consultation with the licensee in a plan of operations so that the whole area may be worked over systematically. The plan of operations will be based on a 15 years' rotation period unless the Conservator of Forests decides after further experience that a reduction of this period is justified. The licensee shall not be at liberty to deviate from the plan of operations so laid down without the previous sanction of the Conservator of Forests.

At the end of each year the licensee shall supply to the Conservator of Forests maps showing the area cut over during the year.

7. The licensee shall keep full and true accounts showing the quantity of bamboos brought into the factory, the quantity of paper-pulp manufactured and in process of manufacture and exported, and shall on the fifteenth day of each month send to the Conservator of Forests in such a form as he may prescribe a true analysis thereof for the month immediately preceeding.

The royalty appearing by such statement to be due in respect of the paper-pulp manufactured shall be due and payable on or before the last day of the next succeeding month.

All books of account shall be open to inspection by Government officers who shall be allowed every facility for checking the same.

8. If the licensee shall fail to commence and effect substantial operations in the terms of the licence within a period of 18 months from the date thereof, the licence shall become void.

9. The licence will contain the usual clauses reserving all minerals, prohibiting the use of the land for any purposes other than those of the licence, prohibiting transfer or subletting without prior consent of Government, providing for the due observance of the terms of the Forest Ordinance and all other laws of the Colony, and for cancellation in the event of bankruptcy of the licensee or in the event of breaches of the conditions of the licence if such breaches are not remedied promptly after due notice, protecting water courses from damage or undue interference, etc.

Tenders must be forwarded to the Conservator of Forests, P.O. Box No. 337, Nairobi, Kenya Colony, on or before the 1st January, 1931, and should be marked on the outside of the envelope "Tender for Bamboo." They should be accompanied by evidence of financial resources, adequate for the carrying out of the terms of the licence.

NOTES.

The bamboo forest occupies a comparatively level area between 8,000 and 9,000 feet altitude, the nearest point being about 3 miles from the

Railway down the Escarpment, but 8 miles from the most accessible Railway Station (Uplands), and the farthest point of the area is about 12 miles further. The climate is cold and well suited to Europeans. Uplands Station is 32 miles from Nairobi, and 361 miles from Mombasa.

It is estimated that there is an average of not less than 40 tons of air-dry bamboo per acre, and that the area will give a continuous annual yield of not less than 40,000 tons of dry unbleached pulp.

There is no large river, but numerous small streams intersect the area.

Supplies of limestone in the Colony are rather scattered, the nearest being about 35 miles by rail. The quality varies considerably.

The Railway freight on bamboo pulp to Kilindini Pier in 10-ton lots and over, pressed to 25 lb. or over per cubic foot, loading by sender, is £1-2-9 per ton.

As the result of trials, the Imperial Institute, London, reported that the Kenya bamboo yielded a pulp of good felting properties, which could be readily bleached, and yielded a white paper of good quality. Specimens of the pulp and paper can be seen at the Imperial Institute, S. Kensington, or at the Forest Office, Nairobi.

No tender will be considered unless the prospective tenderer or his representative has investigated the proposition on the spot together with such matters as factory site, transport, water, lime and fuel supply, etc.


