NOTICE.

IT is notified for general information that Government is prepared to receive applications from companies, syndicates or individuals in the terms of Sir Albert Kitson's Report for exclusive prospecting licences in respect of the unallocated divisions of the areas in the Nyanza Province numbered 3 and 4 in that Report.

In accordance with section 17 of the Mining Ordinance, 1933, applications must be in the prescribed form and applicants must give evidence of sufficient capital to ensure proper prospecting and must furnish details of the methods which they propose to pursue if their application is granted. Licences will be granted for one year but may be renewed at the discretion of the Governor for further terms of one year up to a maximum of five years on submission of a programme of further development.

The fees prescribed by the Mining in Proclaimed Areas Ordinance, 1933, will be payable in respect of each licence granted in these areas.

A key plan showing these divisions and the description of their boundaries may be obtained from the Government Printer, Nairobi, and enlarged and coloured copies of this plan may be inspected at the office of the Commissioner of Mines, Nairobi, and also at the offices of the Warden of Mines, Kisumu, Kakamega and Kisii.

Applications in respect of one or more or of all these divisions or portions thereof will be considered and should be in the hands of the Commissioner of Mines on or before 21st May, 1934.

The divisions as yet unallocated are the following: Nos. 1-10, 13-20, 23, 35, 38, 42-44, 46-50, 52.

The attention of applicants is drawn to the fact that five divisions Nos. 53-57 are shown in the plan of the Lake within the Colony's boundary. LOCUST REPORT, 15TH MARCH, 1934.

KENYA.

The Red Locust.

Coast Province.—There is very little change in the general situation and still no hopper emergence to report. So far as is known the Kwale District is comparatively free of any large swarms, those previously present in this district appear to have disintegrated. There are now only diffuse isolated aggregations present, notably in the neighbourhood of Kwale township. The large swarms previously reported as being situated a few miles south-west of Witu on the 26th February, have now returned southwards to Kaw on the Tana River.

Masai-Machakos area.—Specimens brought in from Black Reef on the Narok Road show that these swarms have mated and are now approaching the laying stage, although no reports of actual laying have been received. A feature in this area is the presence of enormous quantities of birds which are consuming the locusts. Large numbers of dead locusts have been observed along the railway from Simba to Kiu, and as there is no sign of any state of disease in the corpses it can be assumed that the deaths are due to the unsuitable climatic conditions.

Sotik-Kisii.—A small swarm of mature locusts entered Nyakatch from Kisii on the 10th March, but was driven off. It was last observed flying in a north-easterly direction towards the Lumbwa District, and it is reported that this swarm is ready to lay. Otherwise no change has to be recorded in this area.

Migratory Locust.

No development of any importance has taken place. A swarm of young flyers is reported as having entered Kabras, coming from the east, on the 11th March. As this swarm appears to be circling, mating may shortly be anticipated.

General.—The general absence of any marked alteration in the development of the present infestation, and the marked absence of any hopper emergence, now considerably overdue, is undoubtedly to be described to the unfavourable climatic conditions now prevailing. The heat, com-

bined with the lack of rain, is probably entirely responsible for retarding hatchings, and it is not to be anticipated that any radical change in the general position will be recorded before the advent of the rains, when it is to be expected that hopper emergences will take place over considerable areas.

UGANDA.

No report has been received from Uganda, but this will be issued for general information as soon as received.

If the erection of the building in accordance with the approved plans and specifications be not completed by the prescribed date, the said Commissioner, may on good and reasonable cause being shown, grant such extension as he may deem sufficient, subject to such conditions as he may prescribe. 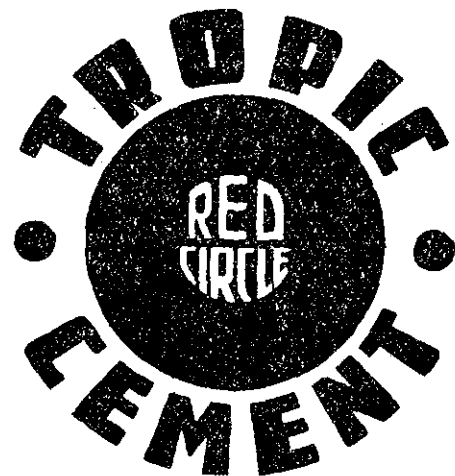
