The Red Locust.

Coast Province.—A marked change for the better can be recorded as regards the coastal infestation. Practically all those areas which have been the scene of operations for the past eight weeks are now under control, though there are still many scattered bands of hoppers and flyers in the district. It is reported that considerable hopper bands are infesting the hinterland some miles inland, but it is not anticipated that any very extensive flying swarms will materialize.

Nyanza Province.—Reports of numerous swarms have been received, generally heading in a northerly or north-easterly direction. A fairly large swarm moved from Jamji on the 10th instant flying towards Lumbwa and Fort Ternan but this swarm returned to the Kericho district the following day. On the 11th news was received of two large swarms proceeding from the Lolgorien district towards Kisii. Owing to the fact that the swarms appear to prefer the high trees for roosting at night, spray-

ing operations are rendered difficult and very little effective work can be done. No serious damage has as yet been reported.
