The survey fees (Sh. 105 per plot), the fees payable for the preparation and registration of the grant (Sh. 120), and the stamp duty payable in respect of the grant, and all other expenses, if any, shall be paid to the Surveyor General, Box 89, Nairobi.

All these amounts shall be paid within seven days of a demand being made therefor.

Upon such payments being duly made, the purchaser shall, subject to the provisions of the Crown Lands Ordinance (Chapter 140, Revised Edition), and to the Conditions of Sale having been complied with, be entitled to a grant of the plot, which grant shall be presented to him duly executed as soon as conveniently may be.

5. KENYA.

The Red Locust.

Coast Province.—Hoppers are still active in the Malindi district and at Mafasini. In most of the other affected areas young flyers now largely predominate. Little really effective work can be done against these without the retention of a large staff of European and native labour, but it is considered that the cost of such a force, at this stage of the operations, is unjustifiable. One of the largest areas covered by young and scattered flying swarms is in the vicinity of Mazeras where escapes will certainly occur but it is hoped that by means of intensive poison spraying, which has been found highly effective during the evenings and early mornings, the escapes will not assume serious proportions.

Nyanza Province.—Very few fresh swarms have been reported this week, and it would appear that the invasion from the south is abating. From specimens received from Kericho it is evident that the swarms are heavily diseased and it is reported that extensive natural mortality is occurring. A small amount of damage has been done to native crops, though nothing serious is reported and while several swarms are stated to have settled in the neighbourhood of the tea plantations it is satisfactory to learn that the plants have not been attacked.
