A Bill to Amend the Asiatic Widows' and Orphans' Pension Ordinance, 1927.

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows :—

1. This Ordinance may be cited as the Asiatic Widows' and Orphans' Pension (Amendment) Ordinance, 1935, and shall be read as one with the Asiatic Widows' and Orphans' Pension Ordinance, 1927, hereinafter referred to as the Principal Ordinance, and shall be deemed to have come into operation on the 30th day of April, 1932.

Short title.

No. 20 of 1927.

2. The Principal Ordinance is hereby amended by the insertion immediately after section 7 thereof, of the following section :—

Amendment of the Principal Ordinance.

“7A. Any Asiatic officer who exercises the option specified in Regulation 13 of the Regulations in the Schedule to the Non-European Officers' Pensions Ordinance, 1932, shall for the purpose of paying contributions to the Fund under the preceding section be deemed to be in receipt of the pension which he would have received had he not exercised such option.”

Rate of contribution to Fund of certain pensioned officers.
No. 53 of 1932.

OBJECTS AND REASONS.

Regulation 13 of the Non-European Officers' Pensions Ordinance, 1932, allows to any pensionable officer who was in the Service on the 30th April, 1932, the option of being paid a reduced pension and a gratuity in lieu of the full pension. Section 7 of the Asiatic Widows' and Orphans' Pension Ordinance, 1927, provides that contributions shall be at the rate of 4 per cent of the contributor's annual salary or pension and it has been the invariable practice, in the case of contributors

who have retired, to base the contributions on the amounts of their unreduced pensions, even though they may have commuted these under the Regulation referred to above. This is considered to be the equitable course, there being no reason why an officer who has commuted his pension should be in a better position for the purpose of contributions to the Fund than one who has not. It has been ascertained, however, that this practice is not legally covered and the object of this Bill is to make the necessary legal provision.

No expenditure of public moneys will be involved if the provisions of this Bill become law.

MUNICIPAL BOARD OF MOMBASA

In re THE LOCAL GOVERNMENT (RATING) ORDINANCE, 1928

AS AMENDED BY THE LOCAL GOVERNMENT (RATING) (AMENDMENT) ORDINANCE XVI OF 1932.

PURSUANT to the provisions of section 18 of the Local Government (Rating) Ordinance, 1928, I give notice to all persons interested that the Municipal Board of Mombasa has imposed the following rates in respect of the year 1935:—

(1) An original rate of one-half of one per centum, and

(2) an additional rate of three-fourteenths of one per centum upon the unimproved value of land as appearing in the Valuation Roll, making in all five-sevenths of one per centum, and further

(3) a rate of thirteen-fiftieths of one per centum upon the value of improvements as appearing in the Valuation Roll.

Provided that the Board may find it necessary to declare a further rate later in the year.

The above rates shall become due and payable at the Municipal Offices on the 23rd day of May, 1935.

The Board will allow discount at the rate of 2½ per cent on all rates paid on or before the due date: where payment is made by cheque dated the 23rd May, 1935, or earlier, and the cheque is received not later than the 24th May, 1935, the full discount will be allowed.

Under section 19 (3) of the Ordinance the Board is empowered to charge and collect interest on arrear assessment rates at a rate not exceeding one per centum per month. Such interest will be payable from the 1st June, 1935. Assessment rates are a debt to the Municipal Board and although every effort will be made to deliver to those liable demand notes stating the amount due, the failure so to deliver will not be held to absolve the debtor from any disability or penalty attaching to non-payment.

LOCUST REPORT, 11TH APRIL, 1935.

THE RED LOCUST.

KENYA.

Hoppers have emerged in small scattered patches in the Mombasa and Digo Districts of the Coast Province, but as the local population has been able to destroy these by beating, expenditure of funds by Government has not been necessary, nor is this anticipated.

As far as can be ascertained further flying swarms have not entered Kenya from Tanganyika and the outlook remains favourable.

TANGANYIKA.

There is but little change in the situation in this Territory. A campaign for destruction of hoppers continues in accessible areas, but destruction

by burning of grass and bush has been retarded by rain. Hoppers continue to emerge in large numbers in various parts, including the Northern and Tanga Provinces.

In the Moshi area the situation has improved, good work having been carried out by the Labour Officer, assisted by the Native Authorities. Damage caused to crops has not been serious and conditions have been suitable for planting.

And further provided that, if the purchaser so elects, the balance of purchase money may be paid in three equal annual instalments, subject to interest at the rate of 6 per centum per annum on the outstanding balance, the first of such instalments to be paid, together with the interest that shall have accrued due, on the 1st June, 1936, and thereafter instalments and interest to be paid on the 1st June, in each year.

If the erection of the buildings in accordance with the approved plans and specifications be not completed by the prescribed date, the said Commissioner may, on good and reasonable cause being shown, grant such extension as he may deem sufficient, subject to such conditions as he may prescribe.

Provided that if the grantee shall receive no intimation from the Commissioner within one month of the date on which the plans have been approved by the Nairobi Municipal Council, he may proceed with the erection of the building in accordance with the plans submitted, and the Commissioner shall not have the power to cause to be made any alteration or variation in the plan or the date.

12. Subject to the proviso contained in clause 11 hereof, no building shall be erected on the plot unless plans (including a block plan showing the position of the buildings), drawings, elevations and specifications thereof shall have been previously approved by the Commissioner of Lands or such other person as he may appoint. Such plans, etc., shall be submitted in triplicate to the Town Clerk, Nairobi, for necessary action.
