SUPPLEMENT

KENYA PROCLAMATIONS, RULES AND REGULATIONS
(No. 36)

Section 8 of the Principal Ordinance which it is proposed to amend :—

Order not enforceable if parties reside together.

8. No order made under this Ordinance shall be enforceable and no liability shall accrue under any such order whilst the married woman with respect to whom such order was made resides with her husband, and any such order shall cease to have effect if for a period of three months after it is made the married woman continues to reside with her husband.

Section 12 of the Principal Ordinance which it is proposed to replace :—

Custody and maintenance of children.

12. When a woman, who might have applied for an order or orders under this Ordinance, is dead or has committed an act of adultery, and the Attorney General is satisfied that she would, if alive or if she had not committed an act of adultery, have had reasonable grounds for applying for an order or orders under this Ordinance, he may apply to the Court for an order or orders giving directions as to the legal custody of and the reasonable maintenance by the husband of such woman of her children whom he is legally liable to maintain, and the Court may, on such application, make such order or orders giving such directions as to the matters mentioned above as it may, in its discretion, think fit.

A Bill to Amend the Subordinate Courts (Separation and Maintenance) Ordinance, 1928.

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows :—

1. This Ordinance may be cited as the Subordinate Courts (Separation and Maintenance) (Amendment) Ordinance, 1935, and shall be read as one with the Subordinate Courts (Separation and Maintenance) Ordinance, 1928, hereinafter referred to as the Principal Ordinance.

Short title.

No. 34 of 1928.

2. Section 8 of the Principal Ordinance is hereby amended by the deletion of the words "No order made under this Ordinance" from the first line thereof and by the substitution therefor of the words—

Amendment of section 8 of the Principal Ordinance.

"Save in the case of an order made under section 12 of this Ordinance upon the application of the Attorney General, no order made under this Ordinance".

3. Section 12 of the Principal Ordinance is hereby repealed and the following section is substituted therefor :—

Repeal and replacement of section 12 of the Principal Ordinance.

12. (1) In any case where a woman is dead, or has committed an act of adultery or is absent from the Colony, the Attorney General may make application to the court in respect of her children if he is satisfied that such woman would have had reasonable grounds for applying to the court for an order under this Ordinance if she had been alive, or had not committed an act of adultery or if she had been present in the Colony, as the case may be.

Application by the Attorney General as to children.

Any such order or orders shall, when made, be enforceable in the same way as any other order or orders is enforceable under this Ordinance.

Section 14 of the Principal Ordinance which it is proposed to amend :—

Residence.

14. A Court shall entertain proceedings under this Ordinance only in cases where one of the parties has at the time of the issue of the summons his or her usual place of residence in the Colony.

(2) The Attorney General on any such application, may ask for an order giving directions as to the legal custody of the children of such woman, and as to the payment by the husband of such woman of reasonable maintenance in respect of any such children whom such husband is legally liable to maintain.

(3) On any such application by the Attorney General the court may make such order or orders giving such directions as it may in its discretion think fit. Any such order or orders shall be enforceable in like manner as any other order or orders made under this Ordinance.

(4) The court may, in accordance with the provisions of section 6 (1) of this Ordinance, at any time alter, vary or discharge any order made under this section. An application for such alteration, variation or discharge may be made by the Attorney General, or by the woman in respect of whose children the order has been made, or by the husband of such woman if he has been ordered to make payments in respect of such children, but prior to the making of any such application by such woman or her husband, notice thereof shall in every case be served on the Attorney General."

4. Section 14 of the Principal Ordinance is hereby amended by the deletion of the words "A Court shall entertain proceedings" from the first line thereof and by the substitution therefor of the words—

Amendment of section 14 of the Principal Ordinance.

"Save in the case of an application made under section 12 of this Ordinance by the Attorney General, a Court shall entertain proceedings".

OBJECTS AND REASONS.

This amending Bill enables the Attorney General, in certain circumstances, to apply to the court with regard to the custody and maintenance of deserted children.

No expenditure of public moneys will be involved if the provisions of this Bill become law.

Sub-section (4) of section 2 of the Principal Ordinance which it is proposed to amend :—

2. In this Ordinance, unless there is anything repugnant in the subject or context :—

(4) "Decree" means the formal expression of an adjudication which, so far as regards the Court expressing it, conclusively determines the rights of the parties with regard to all or any of the matters in controversy in the suit and may be either preliminary or final. It shall be deemed to include the rejection of a plaint or writ and the determination of any question within section 34 or section 93, but shall not include—

(a) any adjudication from which an appeal lies as an appeal from an order, or ;

(b) any order of dismissal for default.

Explanation.—A decree is preliminary when further proceedings have to be taken before the suit can be completely disposed of. It is final when such adjudication completely disposes of the suit. It may be partly preliminary and partly final.

**A Bill to Amend the Civil Procedure Ordinance,
1924.**

BE IT ENACTED by the Governor of the Colony of Kenya, with the advice and consent of the Legislative Council thereof, as follows :—

1. This Ordinance may be cited as the Civil Procedure (Amendment No. 2) Ordinance, 1935, and shall be read as one with the Civil Procedure Ordinance, 1924, hereinafter referred to as the Principal Ordinance.

Short title.
No. 3 of 1924.

2. Sub-section (4) of section 2 of the Principal Ordinance is hereby amended by adding immediately after paragraph (b) thereof the following proviso :—

Amendment of section 2 (4) of the Principal Ordinance.

“Provided that for the purposes of appeal the word ‘decree’ shall include judgment and a judgment shall be appealable notwithstanding the fact that a formal decree in pursuance of such judgment may not have been drawn up or may not be capable of being drawn up.”

Sub-section (2) of section 65 of the Principal Ordinance which it is proposed to replace :—

(2) Notwithstanding anything contained in the Indian Limitation Act, 1877, as applied to the Colony, every appeal from a Subordinate Court to the Supreme Court shall be filed within thirty days from the date of the decree or order appealed against."

3. Sub-section (2) of section 65 of the Principal Ordinance is hereby repealed and the following sub-section is substituted therefor :—

“(2) Every appeal from a subordinate court to the Supreme Court shall be filed within the period of thirty days from the date of the decree or order appealed against :

Provided however that such time as the Registrar shall certify as having been requisite for preparation of and delivery to the appellant of a copy of the decree shall be excluded from the said period ; and provided also that an appeal may be admitted out of time when the appellant satisfies the Court that he had good and sufficient cause for not preferring the appeal within such period.”

Repeal and replacement of section 65 (2) of the Principal Ordinance.

OBJECTS AND REASONS.

Clause 2.—Under the law as it stands at present a person wishing to appeal from a decision must await until a formal decree has been drawn up, the law here being different from the practice in England where he may appeal on being supplied with the judgment. All that is necessary for an appeal is the decision obtained in the action and that is contained in the judgment. The formal decree which is necessary for purposes of executing the judgment is of no assistance to a Court of Appeal save where the appeal is from the formal decree itself and is based on a contention that it is not in conformity with the judgment, and to insist on its production by an appellant is a hardship entailing delay, further expense, and serving no purpose.

Clause 3.—This clause provides (a) that in computing the period of limitation the time requisite for obtaining the necessary papers shall be excluded, and (b) that the appellant may be allowed to appeal out of time on his showing cause, thus conforming to the procedure regulating appeals from the Supreme Court to the Court of Appeal for Eastern Africa.

No expenditure of public moneys will be involved if the provisions of this Bill become law.
