THE RFD LOCUST

KENYA

No further reports regarding the swarms of locusts at Athi River and Kamiti, referred to in the last Locust Report, dated 14th August, 1936, have been received. These were undoubtedly isolated swarms and have probably been destroyed by birds.

No reports of any other swarms in the Colony and Protectorate have been received during the past month.

There appears to have been no further invasion by red locusts across our southern border. Elsewhere in the Territory one swarm has been reported as far north-west as Singida.

Lack of further reports from districts suggests that such swarms as we have are more or less settled in uninhabited bush country, as has been the custom of the red locust at this time in previous years.

UGANDA

KAMPALA, 30TH SEPTEMBER, 1936

Locust Report for August, 1936

NOMADACRIS

There was a further northward movement of swarms from Ankole District which resulted in an increased activity of the locusts in Toro and Mubende Districts. Bunyoro was reported clear from locusts, as also was Masaka District apart from a single small swarm stated to have been exterminated by the local population. In Mubende District attempts were made to destroy settled swarms, in one case 100 bags of locusts being collected and eaten by the people.

Reports received from other districts have all been negative.

Damage was caused to cotton, banana, coffee and sweet potato in several areas of Mubende and some slight damage to crops was recorded in Toro.
